## 21<sup>ST</sup> CENTURY SCHOOLS CAPITAL PROGRAMME – YSGOL GYNRADD GYMRAEG ABERDAR

REPORT OF THE DIRECTOR OF FINANCE AND DIGITAL SERVICES IN DISCUSSION WITH THE LEADER OF THE COUNCIL, CLLR A MORGAN

#### 1. PURPOSE OF THE REPORT

1.1 The purpose of the report is to provide an update regarding financing of the proposals to increase the capacity of Ysgol Gynradd Gymraeg Aberdar (YGG Aberdar) to meet the demand for Welsh medium school places

#### 2. **RECOMMENDATIONS**

It is recommended that Cabinet:

- 2.1 Note the updated position on the outcome of the submission of a financial business case to Welsh Government;
- 2.2 Review and agree the updated total costs and funding package;
- 2.3 Review, and if acceptable propose that the attached Prudential Borrowing report at Appendix A is presented to Council on 25<sup>th</sup> November 2020.

#### 3. REASONS FOR RECOMMENDATIONS

3.1 To complete the funding package for YGG Aberdar enabling works to commence.

#### 4. BACKGROUND

4.1 Members will recall that at the meeting of the Cabinet on 20<sup>th</sup> September 2018 approval was given to develop and submit a 21<sup>st</sup> Century Schools Programme financial business case to the Welsh Government to increase the capacity of Ysgol Gynradd Gymraeg Aberdar to meet the demand for Welsh medium school places.

- 4.2 The proposal has been through all the relevant business case stages in Welsh Government and an award of funding was received on 4<sup>th</sup> November 2020.
- 4.3 The total estimated cost presented to Cabinet in September 2018 was £3.3M to provide an additional 60 primary school places. Since September 2018 the total cost has increased to £4.5M as the project now also incorporates a new childcare facility as per Delegated Decision report on 29<sup>th</sup> May 2018 and report to Cabinet on 9<sup>th</sup> April 2019.
- 4.4 The funding package has also changed. In September 2018 the WG 21<sup>st</sup> Century Schools Band B grant intervention rate was 50%, which therefore required the Council to fund 50% of the cost. The WG intervention rate has now increased to 65% and the Council's funding requirement has decreased to 35%. The following table illustrates the changes in costs and funding:

7.1 The impact of the change in total cost and change in WG 21<sup>st</sup> Century Schools Band B grant intervention rate has reduced the Council's borrowing requirement from £1.650M to £1.291M. Details of the borrowing calculation and funding of the annual revenue cost are included in the appended report.

#### 1.0 PURPOSE OF REPORT

- 1.1 The purpose of this report is to seek Council approval:
  - For a capital investment of £4.500M for an extension at Ysgol Gynradd Gymraeg Aberdar incorporating 4 classrooms and establishing a new Meithrin;
  - To finance the project through the Welsh Government's (WG) 21<sup>st</sup> Century Schools Band B grant; Welsh Government's Childcare Grant and to fund the Council's contribution from Council borrowing using its powers under the Prudential Code.

#### 2.0 RECOMMENDATIONS

It is recommended that Members:

- 2.1 Agree to the inclusion in the capital programme of a new extension at Ysgol Gynradd Gymraeg Aberdar at a total cost of £4.500M.
- 2.2 Agree that the net capital cost to the Council of £1.291M is funded through borrowing, using the Council's powers under the Prudential Code, with the annual revenue cost of £0.052M being met from savings from previous school reorganisations.

#### 3.0 BACKGROUND

3.1 Members will recall that at the meeting of the Cabinet on 20<sup>th</sup> September 2018

- approval was given to develop and submit a 21<sup>st</sup> Century Schools Programme financial business case to the Welsh Government to increase the capacity of Ysgol Gynradd Gymraeg Aberdar to meet the demand for Welsh medium school places.
- 3.2 An update was reported to Cabinet on 17<sup>th</sup> November 2020 outlining that the proposal has been through all the relevant business case stages in Welsh Government and an award of funding was received on 4<sup>th</sup> November 2020.
- 3.3 Cabinet reviewed the updated costs and funding package and agreed that this report is presented to Council to approve the borrowing for the Council's contribution.

#### 4.0 FINANCIAL DETAILS

- **4.1** The proposal to build an extension at Ysgol Gynradd Gymraeg Aberdar will cost an estimated £4.500M in capital investment.
- 4.2 The Council has successfully secured WG Childcare grant of £0.810M, with 21<sup>st</sup> Century Schools Band B grant to fund 65% of the remaining eligible capital expenditure.
- 4.3 The total grant award is £2.399M and the Council's borrowing requirement is £1.291M. The annual revenue cost to repay this borrowing is £0.052M per year for 40 years. This can be funded from revenue savings accrued from previous 21<sup>st</sup> Century Schools schemes and other school reorganisations that have already been implemented.

#### 5.0 EQUALITY AND DIVERSITY IMPLICATIONS

5.1 The equality and diversity implications have been considered and reported as part of the proposals to improve the Education provision and there are no implications as a result of the recommendations in this report.

#### 6.0 **CONSULTATION**

6.1 A formal school organisation consultation on the proposals to extend YGG Aberdar was not required, as the increase in capacity is below the threshold at which a statutory consultation is necessary. There are no consultation requirements as a result of the recommendations in this report.

#### 7.0 FINANCIAL IMPLICATION(S)

7.1 The financial implications are set out in the report; in summary this is to invest £4.500M of capital expenditure to build a new extension at Ysgol Gynradd Gymraeg Aberdar. This will be funded by WG 21<sup>st</sup> Century Schools Band B grant of £2.399M, WG Childcare Grant £0.810M and £1.291M of borrowing to fund the Council's contribution. The repayment of this borrowing will cost £0.052M annually for 40 years, which will be funded from revenue savings already accrued.

#### 8.0 LEGAL IMPLICATIONS OR LEGISLATION CONSIDERED

- 8.1 The legal implications have been considered and reported as part of the proposals to improve the Education provision.
- 8.2 The Council has the necessary powers to borrow money to fund expenditure under the Prudential Code.

## 9.0 <u>LINKS TO CORPORATE AND NATIONAL PRIORITIES AND THE WELL-BEING</u> OF FUTURE GENERATIONS ACT

- 9.1 The Council's Corporate Plan commits to "Continue to invest in improving school buildings, to ensure the County Borough's pupils have the learning environment fit for the 21st Century."
