SUBJECT: Progress Update on the delivery of Regeneration in Pontypridd Town Centre

## 1. DECISION MADE:

#### Agreed -

To note progress made since September 2017 in the development and delivery of projects and investment opportunities within Pontypridd Town Centre.

To note progress made in the development of the Pontypridd Town Centre Placemaking Plan which builds upon the 2017 – 2022 Regeneration Framework. The draft placemaking plan has been developed with Welsh Government and Transport for Wales and provides a bold vision for Pontypridd that is based on a shared ambition for the town and its role within the Capital City Region.

To consider a further report in the new year which seeking approval of the placemaking plan for consultation and public engagement alongside further updates on progress of the Muni Arts Centre redevelopment, the former Bingo Hall site and the former M&S store and associated buildings.

## 2. REASON FOR THE DECISION BEING MADE:

Town centres throughout the UK have faced significant challenges to their economic viability over the past decade and this has intensified further due to the COVID-19 pandemic. Pontypridd town centre is no different, but here, further pressure has been placed on the town and its businesses by the destructive flood events in the winter of 2020.

Despite the challenges faced, Pontypridd town centre has proven to be incredibly resilient, and the report sets out the significant progress that has been made in the delivery of major regeneration projects and initiatives within the town.

The regeneration projects and initiatives detailed in the report will collectively boost the local economy and provide job opportunities for local people.
