SUBJECT: Review of Learning Support Class Provision For Pupils with Significant Additional Learning Needs

#### 1. DECISION MADE:

## Agreed -

- Noted the proposal for the creation of a Welsh medium LSC provision to support pupils with significant additional learning needs within the context of the School Organisation Code (2018) and the 21st Century School Modernisation Programme.
- Formally approved to recommence consultation on the following proposal: To create a new Key Stage 3/4 LSC provision for pupils with significant Additional Learning Needs (ALN) at Ysgol Garth Olwg.

#### 2. REASON FOR THE DECISION BEING MADE:

To progress the proposal in accordance with the process outlined in the School Organisation Code (011/2018) so that an improved continuum of Welsh medium Additional Learning Needs (ALN) provision can be achieved in RCT.
