**SUBJECT: Sustainable Communities for Learning Programme -Proposal To  
Amalgamate Cefn And Craig Yr Hesg Primary Schools To Create A New Community  
Primary School**

1. To note the one objection received in response to the publication of the statutory notice to progress this proposal;

**2. REASON FOR THE DECISION BEING MADE:**

The need to advise Members of the outcome of the recent publication of a Statutory Notice in respect of the proposal to:

1. Amalgamate the currently federated Cefn and Craig yr Hesg primary schools. The amalgamation will be achieved by closing the two existing primary schools and
2. opening a new, bigger community primary school to replace them.
