**SUBJECT: Cynon Valley Waste Disposal Company Limited and Amgen Rhondda Limited - Annual General Meeting**

**1. DECISION MADE:**

**Agreed –**

Following the consideration of the report of the Director of Legal Services containing exempt information as defined in Paragraph 14 of Part 4 of Schedule 12A of the Local Government Act, 1972 (as amended), namely information relating to the financial or business affairs of any particular person (including the authority holding the information) it was **AGREED:**

6. That the Director of Legal Services and/or his nominee be authorised to exercise the Council's vote at the Annual General Meetings of the Companies in accordance with recommendations 2(ii) to 2(iv) above; and
7. That the Council be represented at the Companies' Annual General Meetings by a Cabinet Member.

The need to afford Members the opportunity of inspecting the financial statements of Cynon Valley Waste Disposal Company Limited and Amgen Rhondda Limited (the 'Companies') which are to be presented to the Companies' Annual General Meetings to be held 'virtually' in November 2022; and to enable Members to instruct officers who attend on behalf of the Council as sole shareholders of the Companies to vote in accordance with Members' instructions.
