1. <u>PURPOSE OF REPORT</u>

The purpose of this report is to provide an update to Scrutiny Members in relation to:

• Children's Services response to the continuing impact of the pandemic, recovery and contingency planning.

2. <u>RECOMMENDATIONS</u>

It is recommended that Members:

- **2.1** Acknowledge the information contained within the report.
- **2.2** Scrutinise and comment on the information provided.

3. BACKGROUND

3.1 A Scrutiny Committee on 9th September, Children's Services provided a verbal report in relation to the functioning of the service during the Pandemic and the developing Recovery Plan. The period since has been a demanding one

operationally, and has seen the service move to a contingency planning mode, then adjusting to a business critical one in preparation for the national Fire Break following the First Minister's announcement on 19th October. The service is poised to respond to additional adjustments to restrictions at the exit of the Fire Break phase on 9.11.20.

Children's Services' Recovery Planning

- **3.2** Much of Children's Services' provision is required by statute, and is not altered by the Pandemic and related legislation, hence, for the most part, we have been able to adjust our delivery method by working from home, using technology more, risk assessing face to face contact with families, and providing staff with PPE, but very little else has changed.
- **3.3** There continues to be uncertainty about the specific mid and long term impact of the Pandemic for vulnerable families, however, given the rate of referral and the conditions families face which, in many cases are understood to compound adversity, the service is sadly projecting increasing demand, whilst working to connect as many families as possibly to early help or preventative services.
- **3.4** The activity of the Recovery Plan has been developed in line with the following principles which are agreed as a national framework for children's services' recovery plans:
 - The safety and well-being of children and young people and their families are paramount
 - The rights and voices of children and young people must be regarded
 - The well-being of staff and their families to be looked after
 - Realistic delivery of priorities ensuring capacity and capability
 - Working to clear and consistent guidance
 - Keeping the whole system dynamic and responsive to meet the needs of children and young people by fulfilling care & support plans and moving children and families on through appropriate services as/when necessary
 - Working with third sector organisations to support children and families
- **3.5** The following table provides an update on the Children's Service recovery plan which includes the following actions:

Planning is underway for YEPS to commence proactive street based youth work by following the Firebreak (subject to restrictions) across RCT working alongside, the YOS, (including CCTV) and BAROD

- **3.6** In anticipation of increasing Covid infection in the community, and in line with the Council's expectation, a contingency plan was considered and finalised in September 2020, the result of which has seen the service continue to prioritise business critical services and adjust the pace of our recovery planning business.
- **3.7** In preparation for the Firebreak Period, the services is re-categorising all cases by risk and need into red, amber and green. Notwithstanding that situations and

circumstances can change rapidly, responses to red cases only will be prioritised during the 2 week period whilst maintaining our business critical services which includes the following business areas :

Access to Services and Family Support

- Emergency Duty Team (EDT)
- Front Door for referrals Information Advice and Assistance / MASH
- Assess and provide support at home where there is breakdown or where input is critical to support children and young people to remain at home
- Direct Payment Clients we will prioritise these individuals as some may be assessed as high risk and there may be a risk of carer breakdown/withdrawal due to need for carers to isolate.
- MASH Business Support all Child Protection functions
- High risk cases identified by Resilient Families Service
- High risk cases identified by Youth Engagement and Participation Service

Safeguarding Duties

- Strategy discussions, meetings and child protection investigations
- Child protection visits- children at the most immediate risk will be identified and prioritised
- Record of key decisions and drafting of Child Protection Plans
- Child protection medicals-dependent on Health Service capacity
- Children requiring placements
- Child protection conferences-virtual
- Decision making in respect of threshold for Professional Concerns
- Pre-birth assessments (remotely wherever possible)
- Public Law Outline meetings for emergency cases that require agreement to placement or court application
- Access to Child Protection Register and arranging temporary registration in other Local Authorities
- Hospital discharges of children at risk

Children Looked After

- Providing care to children placed in our residential children's homes
- Children looked after statutory visits- children at the most immediate risk will be identified and prioritised including potential placement break down otherwise contact will be by telephone
- Continue payments to all providers caring for children
- Non-essential visits to children's residential homes will be restricted
- RCT residential children's homes will be kept open for placements
- Adoption transitions for children following joint risk assessment with VVC.
- Contact for parents will be assessed on a case by case basis particular consideration being given to new-born babies and court agreed arrangements

Youth Offending

- Children held in police stations and requiring an appropriate adult (on basis of full access to PPE)
- Young people on Intensive Supervision and Surveillance Orders and Intensive Supervision and Surveillance Bail support
- Young people who are remanded into the secure estate or sentenced and residing in the secure estate
- Transition and resettlement of young people being released from the secure estate
- Young people deemed to be a 'high risk' to themselves and the community
- Young people appearing in Court

1. <u>PURPOSE OF REPORT</u>

1.1 The purpose of this report is to update Scrutiny Members on the outcome of Care Inspectorate Wales' (CIW) inspection and review activities with Children's Services during the last year and actions taken by the service to date.

Please note that the report outlining the findings of the Disabled Children's Service Review and proposed next steps was brought to Scrutiny Committee on the 4/12/2019 for consideration and comment. See link below:

CIW activity has included:

- The inspection of children's services, focusing on support for disabled children in December 2019.
- Focused activity with regard to support for care leavers in March 2020.

 CIW's Quality of Care Review Reports 1/4/2019 to 31/3/2020 in respect of Children's Residential Care and Fostering Services have also been completed.

2. <u>RECOMMENDATIONS</u>

3. BACKGROUND

Disabled Children's Service

Children's Services received CIW's Inspection Report on the provision of early help, care and support and seamless transition for disabled children and their families in Rhondda Cynon Taf in March 2020. See link below:

The report identified a number of strengths which included:

- A strong vision for remodelling services for disabled children.
- An effective and improved response at the 'front door' of children's services.
- The multi-agency safeguarding hub (MASH) evidenced good joint working arrangements.
- An understanding of the social model of disability within our prevention and early intervention services and an intention to improve equality of access for disabled children.
- The Children with Additional Needs Service (CANS) is an effective and valued service, with a focus on family strengths and the achievement of personal outcomes.
- Rhondda Cynon Taf County Borough Council (RCTCBC) provides its own psychological support for children and practitioner consultation.
- That staff were positive and felt well supported by colleagues and managers.
- Evidence of partnership working in the development of an emotional well-being service jointly with Cwm Taf Morgannwg University Health Board.

Areas for improvement were also identified they included:

- Increased focus on family strengths and the identification of personal outcomes.
- Improved practice in relation to assessments of parent carers.
- Ensuring greater promotion of the voice of the child including the use of advocacy.
- Greater support for siblings of disabled children.
- To develop alternative approaches to providing respite/short breaks.
- The local authority and the health board need to reach greater resolution on eligibility for continuing care arrangements for children with complex needs.
- Improving quality assurance within DCT.
- Consideration to be given to the benefits to disabled young people of earlier active involvement by adult services social workers and Personal Advisors (PAs).
- Re-establish the disability register.
- CTMUHB and RCTCBC to continue to focus efforts to achieve a more joined up strategic approach to the advantage of citizens.

As outlined in the December 2019 Disabled Children's Service Review Report to Scrutiny Committee, work was already underway to change the delivery model for disabled children prior to the CIW inspection. Where further areas for improvement were identified they have been incorporated into the Disabled Children's Services Remodelling Implementation Plan.

16+ Teams

At the end of March 2020, Children's Services received CIW feedback in relation to the focused activity undertaken earlier that month with the 16+ teams. The strengths identified by inspectors that Personal Assistants (PAs) were committed to promoting the well-being of young people; that young people valued their PAs; and that there were good examples of good contact between the PAs and other professionals. The areas for improvement identified included:

- Improving the outcome focused approach, ensuring that young people's wishes and feelings are evident in pathway planning.
- Ensuring Pathway Plans are reviewed in a timelier manner and involve updates from relevant agencies.
- Improving quality assurance.
- Ensuring young people have an active offer of a service in Welsh.

4. <u>NEXT STEPS</u>

Action plans have been developed for both the Disabled Children's Service and 16+ Teams which incorporate the areas for improvement identified by CIW. As previously noted in the case of the Disabled Children's Services they have been included in the Remodelling Implementation Plan.

Due to the unprecedented circumstances relating to Covid 19, on the 23rd of March 2020 Children's Services Management Team made changes and adjustments to working arrangements. Four critical areas of work on which to focus activity were identified: access to services and family support, safeguarding duties, children looked after and youth offending. A reduced service was delivered in these areas by prioritising those at greatest level of risk and need. All development and improvement activity was placed on hold.

Quality Assurance monitoring was reduced to two key indicators:

- Communication and support for staff
- Quality of work

RCT Children's Services has developed a recovery plan, and a separate report is being provided in that regard. We are now beginning to deliver what is likely to be a staged return of services; having regard to changes in local restrictions and any future national requirements which will impact on the extent and rate of recovery. The guiding principle must be how we safeguard the health and wellbeing of our service users and staff as well as minimise the ongoing risk of infection.

We are now in a position to begin to take forward elements of the action plans that have been prioritised (subject to the impact of local restrictions). They are as follows:

Disabled Children's Service:

- Implement the revised Disabled Children's Service Structure and model of working.
- Develop a clear pathway for disabled children that strengthens early intervention and transition.
- Improve strength based assessment and outcome focused planning through changes to Disabled Children's Service model of working and training for practitioners.
- Children's Services Quality Assurance Framework to be embedded within the service.
- Work is underway with colleagues in adult services to incorporate the 'carers' conversation' into a new carers assessment.

16+ Teams:

- A strengths based outcome focused approach has been identified as a priority training need for Children's Services. A training programme is being developed.
- Focus on team development. Consider the culture of the team, how things currently operate, strengths, opportunities for development.
- Review and amend guidance to practitioners in 16+ Teams concerning roles and responsibilities with regard to the implementation of the SSWB (Wales) Act 2014.
- Children's Services Quality Assurance Framework to be embedded within the service.
- Utilise performance data, greater use to be made of available information to analyse and explore outcomes for young people.

10. CONCLUSION

There is a strong commitment within RCT Children's Services to support the Disabled Children's Service and the 16+ Teams to implement positive change, whilst acknowledging and building upon the strengths identified. Steering groups have been established and the action / remodelling plans provide a clear framework to facilitate and drive change to deliver improved outcomes for children and young people within RCT.
