19 Welcome

The Chair welcomed Members to the meeting and welcomed Councillor G. Hughes to his first meeting of the Strategic Culture & Arts Steering Group.

The Chair advised Members that the agenda would be dealt with out of sequence due to the confidential nature of certain agenda items and that Item 8 would be dealt with first.

20 Declaration of Interest

In accordance with the Council's Code of Conduct, County Borough Councillor J. Brencher declared the following personal interest: "I am a Trustee of the YMCA".

21 Minutes

It was **RESOLVED** to approve the minutes of 2^{nd} December 2019 as an accurate reflection of the meeting.

22 Developing a framework for cultural assets provision in Pontypridd

The Director, Public Health, Protection & Community Services provided Members with a presentation in respect of the restoration of the Muni Arts Centre and the potential synergies with the development of the YMCA.

The presentation outlined the structure of the Muni Arts Centre and the opportunities that have been provided by its original architectural design, such as making the Muni more energy efficient by the use of water from its roof. The Director emphasised that detailed negotiations have been held between the Council and Awen Cultural Trust to develop a capital scheme of works and to propose an ambitious long-term vision for the Muni, including the restoration of the original architecture and the significant enhancements to the facility to create an arts and entertainment venue of regional importance.

The Chair advised the Steering Group that the Cabinet have agreed a revenue contribution of £105k for 2020/21 for the restoration of the Muni Arts Centre.

The Service Director Community Services continued by providing the Steering Group with a presentation in respect of the Council's plans to redevelop the YMCA in Pontypridd. This venue will also include a performance space, albeit smaller in capacity to that of the Muni. The Service Director emphasised the importance of ensuring that both venues complement each other and the importance of retaining the fabric of the building. The Service Director informed Members of the plans for the redevelopment such as the plans for a studio theatre, a café and a gallery.

Discussions ensued and a number of Member praised the exciting and ambitious plans. A Member emphasised the importance of ensuring that there will be a disabled access entrance at the front of the YMCA. A Member also emphasised the huge opportunities ahead, particularly in respect of the metro and the opportunity to bring visitors into the valleys. The Steering Group agreed that the National Eisteddfod Wales in 2022 will be a huge opportunity to bring visitors to the region and that the metro and the Muni will allow the Council to capitalise on these opportunities.

A Member of the Steering Group cautioned that cultural assets only work if there is an economic base to make them work and emphasised the importance of ensuring that the redevelopments are robustly supported by the Council. Discussions continued and Members of the Steering Group emphasised the importance of capitalising on the number of visitors and students to the University in Pontypridd and the cultural benefits that this could bring to the region.

The Chair emphasised that working collaboratively with Awen in respect of the Muni is an ambitious long term vision and that the redevelopment fits into the Council's wider town centre redevelopment structure strategy. The Chair emphasised that the Cabinet is committed to sustaining its long term vision for the Muni Arts Centre and the YMCA.

The Steering Group praised the ambitious plans, however, a Member emphasised the importance of ensuring that the transport infrastructure is in place throughout the valleys to support the Council's strategy.

The Steering Group agreed that the demographic is changing in Pontypridd and agreed that the Council must maximise every opportunity in this area. Members praised the Council's continued investment in the arts, particularly in times of austerity.

The Director, Public Health, Protection & Community Services emphasised the importance of transforming community assets and referred the Steering Group to the development of community hubs. The Director emphasised that a strategic framework for the provision of cultural assets only works when the assets complement each other. The Service Director Community Services commented that the arts can reduce the community's reliance on statutory services and can often enhance wellbeing in the community.

To conclude, the Chair thanked the Director, Public Health, Protection & Community Services for providing a detailed overview to the Steering Group and thanked Members for their feedback.

Following discussion, Members **RESOLVED** to note the updated report presented to Cabinet on the 17th December 2019 in respect of the community asset transfer of the Muni Arts Centre.

23 Programme Update and Highlights of the Spring Season at RCT Theatres

The Theatre Programme and Audience Development Manager updated Members in respect of the theatre season to date and upcoming events at RCT theatres.

Members were informed that RCT Theatres has recently co-produced a tour with AdLib Cymru 'An evening with Shane Williams' which has seen many theatres reporting an influx in first time bookers and that it has been a successful season to date. Members were advised that events such as this have have a ticket fee a charge of £20 a ticket, which was felt to be a reasonable ticket fee by members of the local community. The Theatre Programme and Audience Development Manager referenced the recent performance at RCT Theatres of the R&D of 'The Night Porter' and advised the Steering Group that it was well received by members of the community. There were three performances in the Park & Dare Theatre, which attracted 170 visitors from all over Wales and from a diverse range of backgrounds. The Manager advised the Steering Group that following these performances, they received 74 evaluation feedback forms, which demonstrated that the performances were well received.

Discussions continued andthe Theatre Programme and Audience Development Manager referenced the positive step forward in respect of the Stiwdio 1 launch at the end of February in the Park & Dare Theatre. The Steering Group were also reminded about the upcoming National Eisteddfod Wales 2022 and the preparatory work being done by RCT Theatres in respect of the event. The Manager concluded by reminding the Steering Group of the season ahead and the upcoming programme of events.

Discussions ensued and a Member queried whether RCT Theatres had any plans in place to engage teachers with the local arts programme. The Theatre Programme and Audience Development Manager advised the Group that they will be continuing to work closely to develop a further programme of events with schools in the County Borough.

To conclude, the Chair thanked the Manager for the update, commenting that he looked forward to seeing the upcoming spring season at RCT Theatres.

24 To consider passing the following resolution:-

25 Arts Council of Wales Investment Review

The Strategic Arts & Culture Manager provided the Steering Group with a report on the Arts Services' Arts Council Wales Investment Review application and future focus.

Following a lengthy discussion, the Strategic Culture and Arts Steering Group **RESOLVED** that the feedback and comments of the Steering Group would be reported to the Cabinet at its March meeting to inform their decision.

26 The Forte Project

The Music Industry Co-Ordinator provided the Steering Group with a report on the progress of the Forte Project and future plans for enhancing its reach and impact.

Following a lengthy discussion, the Strategic Culture and Arts Steering Group **RESOLVED** to note the content of the report regarding the Forte Project and its future development.

27 Chairs Closing Remarks

The Chair thanked Members for attending and advised Members that they were welcome to visit the Mayor's Parlour to see its original architecture following the conclusion of the meeting.

1. <u>PURPOSE OF THE REPORT</u>

1.1 The purpose of the report is to provide the Strategic Culture & Arts Steering Group with information on the key issues to be considered in the 2020/21 Municipal Year.

2. <u>RECOMMENDATIONS</u>

It is recommended that:

- 2.1 Members of the Steering Group provide comment as appropriate on the draft work programme (which is attached as Appendix 1 to the report)
- 2.2 Subject to any amendments, the Steering Group approve the draft work programme as a basis, which can be amended to reflect any changing priorities throughout the year.

3. REASONS FOR RECOMMENDATIONS

3.1 The need to ensure that the areas identified as 'Going Forward' are considered by the Steering Group.

4. BACKGROUND

- 4.1 In September 2018, the Strategic Culture & Arts Steering Group held its inaugural meeting, whereby it was agreed to produce a forward work programme to provide Members with the opportunity to raise any matters that they would like to consider during the year.
- 4.2 Members will also recall that the <u>Local Authorities (Coronavirus)</u> (Meetings) (Wales) Regulations 2020, published at the end of April 2020, provided the opportunity for committee functions to operate virtually.

5. DRAFT WORK PROGRAMME

5.1 The themes identified for consideration over the Municipal Year are:-

Serving our Communities

• An update on the Arts during the COVID-19 Pandemic.

ACW Investment Review

- Arts and Health
- Arts and Regeneration
- 5.2 It is proposed that each of the themes is put forward against a scheduled Strategic Culture and Arts meeting date, although depending on changing priorities these may be subject to change.
- 5.2 The Council's focus on the impact of the pandemic and its associated plans for response and recovery is acknowledged. The desire to resume a 'business as usual' approach is noted; however, Members will need to be mindful of ongoing pressures. Members are asked to acknowledge the balance required for a flexible and supportive work programme that has clear objectives, expectations and lines of questioning. Importantly, this approach allows for business-critical matters to be prioritised.
- 5.3 The Strategic Culture & Arts Steering Group forward work programme, attached at Appendix 1, sets out a manageable and realistic activity for the 2020/21 Municipal Year, allowing for the more pressing matters to be considered whilst having the flexibility to respond to emerging issues.
- 5.4 Members are reminded that given the current climate the forward work programme priorities are subject to change should other business need to be considered.
- 5.5 The Strategic Culture & Arts Steering Group is invited to consider areas for further development.

6. <u>CONCLUSION</u>

6.1 The proposed draft work programme is a fluid document, allowing the programme to be amended with changing priorities, particularly in light of the COVID-19 pandemic. The programme is based on factors highlighted in meetings of the Strategic Culture & Arts Steering Group or other items officers deem appropriate to bring forward for discussion.

AN UPDATE ON THE PROGRESS OF THE RCT ARTS SERVICES IN SERVING OUR COMMUNITIES DURING THE COVID-19 PANDEMIC 2020

1. <u>PURPOSE OF THE REPORT</u>

1.1 The purpose of the report is to update members of the steering group on the progress of the Arts Services in serving our communities during the COVID-19 pandemic.

2. <u>RECOMMENDATIONS</u>

It is recommended that the Strategic Culture and Arts Steering Group:

- 2.1 Note the update within the report.
- 2.2 Consider whether they would like any further information.

3 **REASONS FOR RECOMMENDATIONS**

3.1 That the members are updated on the progress of the Arts Service in serving our communities during the COVID-19 pandemic.

4. <u>BACKGROUND</u>

- 4.1 On 17th March 2020 Rhondda Cynon Taf Theatres, the Coliseum Theatre and the Park and Dare Theatre, closed following public health advice and have remained closed to the public.
- 4.2 The programme of live events at RCT Theatres has been rescheduled or cancelled, with the first live event now scheduled for 11th August 2021 at the Park and Dare Theatre Francis Rossi: I Talk Too Much and at the Coliseum Theatre on 10th September 2021 The 80s Live.

- 4.3 The Take pART participatory programme at the theatres has also been postponed until further notice; however, workshop delivery transferred to an online platform and thereafter, when permitted and following strict government guidelines, workshops were held in community venues.
- 4.5 The Arts and Creative Industries Team with its commissioned Youth Arts and SONIG Youth Music Industry programmes, and the externally funded Forte project, quickly transferred provision online in order to continue to deliver a service that met the needs of young people.
- 4.6 The Arts Service has developed staff skills and responded to needs to provide an online offer for audiences and participants to continue to be creatively active, supporting with home schooling, positive mental health and wellbeing, and providing a connection for many.

5 SERVING OUR COMMUNITIES DURING THE PANDEMIC

5.1 FRONTLINE COVID-19 RESPONSE

- 5.1.1 First and foremost, Arts Service staff were deployed to support priority services, this included the Community Resilience Centres, supporting residents who were shielding, and later, Test, Track and Protect and Mass Testing.
- 5.1.2 50% of the Senior Management Team were redeployed to Test, Track and Protect, playing a key role in establishing this new service within Cwm Taf Morgannwg.
- 5.1.3 Members of the Wider Management Team were deployed to assist the Test, Track and Protect Service. At present, 1 member of staff is seconded into a Contact Tracer role, and 2 members of staff continue to provide support to the Test, Track and Protect Team and, as required, to the Mass Testing provision.
- 5.1.4 Members of the Theatre Technician Team and Sales and Box Office Team continue to assist in providing support for our communities at the Community Resilience Centres and on an individual basis, for example, dog walking for a shielding resident.
- 5.1.5 Casual members of staff are also supporting the Mass Testing provision, as required.
- 5.1.6 All service staff understand the urgency and pressures to respond to our communities needs at this challenging time and all have been prepared to be deployed to support in the Council's response to the pandemic.

5.2 **CREATIVE PROVISION – RCT THEATRES**

- 5.2.1 Throughout the pandemic RCT Theatres has continued to offer creative opportunities that encourage residents of all ages to be creatively active, thus supporting their positive health and wellbeing at such a difficult and challenging time for many.
- 5.2.2 As an Arts Council of Wales Arts Portfolio Wales client, RCT Theatres have been able to provide a free programme of arts events and activities online from April to December 2020:

- 5.2.3 RCT Theatres' pantomime is a key production within the annual calendar. With theatres' remaining closed a proposal was made to Cabinet to produce an online Christmas offer that would be free and fully accessible with BSL, audio description and captions. With further financial support from the Council, 'Once Upon a Panto' a series of 5 stories performed by traditional pantomime characters, were filmed at Orchard Studios, adhering to strict workplace guidance, and release online via the RCT Theatre's YouTube channel from 20th December 24th December 2020.
- 5.2.4 The Live! Brochure has not been produced this year and our offer has instead been promoted via social media platforms and our community partner organisations.
- 5.2.5 The Coliseum Theatre and Park and Dare Theatre Facebook pages have exceeded 347,356 reaches combined. By reach we mean the number of people who have viewed posts. We are encouraged by this level of engagement having not utilised this platform previously in this manner.

5.3 CREATIVE ACTIVITY – ARTS AND CREATIVE INDUSTRIES TEAM

5.3.1 Throughout the pandemic the Arts and Creative Industries Team have continued to offer opportunities for children and young people via the Families First commissioned Youth Arts and SONIG Youth Music Industries programmes, Forte (funded by the Arts Council of Wales and the PRS Foundation), and Beacons (funded by Arts Council of Wales and Welsh Government's Creative Wales).

- 5.3.2 Many young people have felt disconnected from their peers during this challenging year. Feedback received from participants noted that they welcomed the opportunities to participate. The pandemic has been a real interruption to the social and creative journeys of many young people and we recognise that providing these opportunities supports their resilience.
- 5.3.3 Fortitude 2020:
 - Transferred online immediately following lockdown in March with 1:1 mentoring and support for participants. An online sharing took place in October 2020 followed by a Christmas Concert on Facebook Live bringing together Fortitude participants from the last five years in December 2020.
 - The intimate online events gave extremely moving insights into the impact that the course has had on the lives of some of the participants. One of the young people following 1:1 mentoring repaired family relationships and enrolled for a college course.
- 5.3.4 Young Promoters Network
 - With no live events to support, participants were offered masterclasses online with industry professionals.
 - Having succeeded in gaining full-time employment at Coleg y Cymoedd, the departure of the projects lead created opportunity for two young promoters to gain paid experience within the sector.
 - To meet participant needs whilst adhering to government guidance, a new scheme has been developed to provide a loanable recording kit to individuals for creating content to share online.
- 5.3.5 Youth Service Support
 - Identified creative practitioners for the provision of arts and creative industries activity at the key worker childcare hubs during the Summer school holidays.
 - Supported the Poppy Art Workshops and Competition for Remembrance 2020.
 - Potential for pathways for young people accessing Youth Service provision who are interested in the visual arts have been identified.

- 5.3.6 Hot Jam Rock School
 - An online summer school for young people aged 8 and over to develop instrumental and songwriting skills.
- 5.3.7 Dance Activity
 - Programme of online Youth Dance workshops provided by Afon Dance during Summer 2020 for young people aged 16 and over
 - An online Performing Arts Summer School provided by Artis Community and Ransack Dance Company for ages 8 to 18 years old
- 5.3.8 Children's Service Support:
 - The provision of craft packs created by Craft at Heart for children at risk of and looked after.
 - Keyworkers observed that the activity enabled a different and positive focus for their engagement with at risk young people and, in turn, some young people's engagement with their families improved.
- 5.3.9 Visual Arts
 - The Search the Rainbow Graffiti Challenge and the Illustration Challenge were set for young people, also linking to schools.
 - Bespoke activity boxes were provided for young people without resources at home to enable them to participate.
- 5.3.10 Creative Writing
 - A series of Creative Writing sessions with hip hop and poetry artist Rufus Mufasa launched via Zoom in December 2020 for young people aged 11 to 17 years old.
- 5.3.11 Libraries Service Support
 - The Engaging Libraries Fake News project, In collaboration with Liverpool University and funded by Carnegie UK, is being delivered by the Library and Arts Services' Teams.
 - Following an open call, artist/researcher and filmmaker duo Mud and Thunder have been commissioned to engage with our communities and capture their experiences of fake news.

5.4 ARTS AND CREATIVE INDUSTRIES SECTOR SUPPORT

- 5.4.1 Culture Recovery Fund Freelancer Funding
 - This fund was administered by the Arts Service, with the support of ICT, Corporate Communications and Finance, on behalf of Welsh Government's Creative Wales department.
 - Delivered across three phases from October to December, the Arts Service assessed 214 applications from freelancers based with RCT
 - 181 applicants were eligible and received a grant of £2,500 each.
 - One applicant noted:

"I'm absolutely over the moon to have been offered a Freelancer Fund Grant. After months of being worried if I could sustain myself, this grant will mean that I can continue to stay in the field of work that I've trained in and professionally worked in for 6 years. Stories, entertainment and the arts is even more important now than it was before and all of these elements are created by freelancers."

- Another captured the uncertainty to a long-standing career:

"The grant means a safety net for a short while. A chance to consolidate and plan for what seems to be an uncertain future in my chosen profession of 36 years."

5.4.2 The Arts Service has provided employment to in excess of 100 freelancers this financial year to date, many of whom are RCT residents.

6 ARTS SERVICE CHALLENGES

- 6.1 Due to the RCT Theatres box office system only being available at the theatres, and limited access for staff throughout the pandemic, refunds and transfers for ticket holders are slow to be processed.
- 6.2 The implementation of the new cloud-based box office system ProVenue has been delayed due to the pandemic.
- 6.3 Capital works at the theatres have also been delayed, including the completion of Stiwdio 1 and the redevelopment of the gentlemen's toilets on the ground floor at the Coliseum Theatre.

- 6.4 With no certain date as to the reopening of theatres, the live event and participation programme continues to be under-review.
- 6.5 An advantage to the enforced closure of the theatres is that the works listed above can be completed without disrupting service delivery; however, with pressures faced by support services such as Corporate Estates and ICT as this time, this is a challenge.
- 6.6 With staff salaries and building costs continuing to be paid and no income from ticket sales and secondary spend generated this financial year to date, and unlikely to be generated at all, the Council was very grateful to have a successful application to the Arts Council of Wales' Culture Recovery Fund and receive a grant of £458k.
- 6.7 With the Arts Council of Wales Lottery Scheme temporarily closed, the Forte Project sourced alternative funding to continue to provide opportunities for young artists' development and launch Forte 6. Successful applications to the Arts Council of Wales' Culture Recovery Fund for £13k and a further £19k from the PRS Foundation has ensured its continued delivery until May 2021.

7 <u>CONTINUING TO SERVE OUR COMMUNITIES IN 2021</u>

- 7.1 As a public arts service we need to consider the impact of Covid on our staff, communities and the creative sector. As such, 2021 will be a year in which we pause to review what and how we do things, and ensure that the service meets identified needs.
- 7.2 Our focus will be on having conversations with staff, other Council services, the third sector, our communities and creatives to identify needs and provide a service that is relevant based on our values of:
 - Creativity recognising, valuing and unleashing the creativity of our communities
 - Rootedness understanding our place and being a part of our communities
 - Calon welcoming to all sectors of our communities
 - Connectedness joining the dots and sharing our networks
 - Joy celebrating and improving the quality of life with our communities
- 7.3 In essence, we will not be co-producing or developing new projects during 2021 whilst we create capacity to support and develop with our communities through creative conversations.
- 7.4 As stated in the Arts Council of Wales' 'Re-setting the dial: Responding to Covid-19' (November 2020):

"Areas of Wales blighted by poverty and economic disadvantage have been harshly affected by Covid-19. And the heightened attention in recent months given to the lived experiences of Black Asian Minority Ethnic and People of Colour has filled our newspapers and television screens. No-one can now be unaware of the disproportionate impact of the Covid-19 virus on diverse communities and disabled people. But if our culture is the reflection of who we think we are, then the Black Lives Matter and We Shall Not be Removed movements are telling us that we still haven't recognised that society continues to reinforce discrimination and lack of equality. Entitlement to culture shouldn't only be for the entitled."

- 7.5 During 2021, the Arts Service will review its processes and procedures, programme, partnerships and public value to provide a service to our communities that considers fairness and equality to meet our communities' needs.
- 7.6 Early in 2021 we will be recruiting for an Assistant Creative Producer as one of the chosen hosts for the Weston Jerwood Creative Bursary Fellow scheme, which will be a step-change in our journey to be inclusive and relevant to our communities.
- 7.7 Due to the delayed Welsh Government budget announcement, the Arts Council of Wales are unable to share definitively the revenue funding award to its Arts Portfolio Wales clients for 2021-22 until after their Council has met on 18 Jan.
- 7.8 The Arts Council of Wales Culture Recovery Funding received to for service staff and its theatres as well as the Forte Project is for support to 31st March 2021.
- 7.9 There is no certainty as to when the Arts Council of Wales' Lottery scheme will reopen to applications.
- 7.10 The Arts Service's RCT Theatres is currently exploring an application to the Arts Council of Wales' Connect & Flourish scheme in collaboration with identified partners, particularly focused on support for emerging artists within the Valleys region.
- 7.11 The Youth Arts and SONIG Youth Music Industry programmes commission from Families First is until 31st March 2021. The programme has been commissioned annually providing no certainty to the programmes future.

- 12.1 The Arts Services offer during the pandemic has enabled us to continue to support the delivery of the Council's corporate priorities.
- 12.2 Our plans to pause, reflect and review during 2021 will enable us to contribute more effectively to the Council's corporate priorities, by acknowledging our operating context and recognising the impact of Covid-19 on our communities and their subsequent needs.
- 12.3 Our online provision and our focus going forward will enable us to more effectively contribute to the seven national wellbeing goals, particularly:
 - A Wales of vibrant culture and thriving Welsh language
 - A prosperous Wales
 - A healthier Wales
 - A Wales of cohesive communities
- 12.4 The service provision and way of working is consistent with the sustainable approach promoted by the Wellbeing of Future Generations (Wales) Act through the five ways of working:
 - Long-term understanding our public value and relevance enables us to gain support for a long-term and sustainable arts and creative industries provision within the county borough.

- Prevention by understanding our community's needs, concerns, opportunities and aspiration we can provide engagement and participation opportunities that address needs identified as a result of Covid-19.
- Integrated understanding our public value and relevance will enable us to contribute more effectively to a range of local, regional and national strategic priorities, in an integrated and coherent way.
- Collaboration understanding our public value and relevance will enable us to identify stakeholders (locally, regionally and nationally), whose values align with ours and with whom we can work in partnership to meet our communities' needs.
- Involvement exploring the communities' needs and exploring how the service can support through creative conversations, cocreation, collaboration and professional networks.

13 <u>CONCLUSION</u>

- 13.1 This report updates members of the Steering Group on the progress of the Arts Services in serving our communities during the COVID-19 pandemic.
- 13.2 RCT Theatres have developed an online offer of live events and arts activities for all ages, as well as a partnership to broadcast content to our communities via Rhondda Radio, and the distribution of activity packs via the Council's Libraries, community organisations and businesses.
- 13.3 The Arts and Creative Industries Team have continued to support children and young people through online provision across a variety of art forms.
- 13.4 Service staff have developed new skills and knowledge in their support of key frontline services and in their development of online provision.
- 13.5 The Arts Service will pause, review ad reflect in 2021 to consider the impact of the pandemic on our communities and the sector, in order to establish a way forward that meets identified needs.
