## 27 Adolygiad o Ddeddf Trwyddedu 2003 ac o Ddeddf Gamblo 2005

Cyflwynodd y Cyfarwyddwr – Iechyd a Diogelwch y Cyhoedd, a Gwasanaethau Cymuned yr adroddiad i'r Pwyllgor. Roedd yr adroddiad yn trafod materion perthnasol mewn perthynas â Deddf Trwyddedu 2003 a Deddf Gamblo 2005, yn ogystal â materion atodol eraill sy'n codi o gyfrifoldebau'r Pwyllgor.

Rhodddwyd gwybod y bu cynnydd mawr yn nifer yr Hysbysiadau Achlysuron Dros Dro (TEN's) yn ystod y cyfnod adrodd diwethaf, cynnydd o 74 yn ystod y cyfnod hwn. Cafodd hyn ei ragweld yn yr adroddiad diwethaf, a'r rheswm dros hynny yw ailagor tafarnau a chlybiau. Caiff Hysbysiadau Achlysuron Dros Dro eu defnyddio gan amlaf i wneud y gorau o'r lle sydd ar gael i gynyddu capasiti'r lleoliad o ganlyniad i gyfyngiadau'r coronafeirws. Nid oes modd i'r clybiau gwerthu alcohol i'w yfed oddi ar y safle oni bai'u bod nhw ar agor i werthu alcohol i'w yfed ar y safle, felly roedd angen TEN ar sefydliadau i werthu alcohol yn yr awyr agored tra roedd y clybiau ar gau.

Ar y cyfan, mae nifer y ceisiadau wedi cynyddu'n raddol, o 99 adeg yr adroddiad diwethaf i 163 yn ystod y cyfnod yma. Mae hyn, eto, yn adlewyrchiad o'r ffaith bod modd i fusnesau â thrwydded ailagor, ac roedd y mwyafrif yn geisiadau trosglwyddo.

Roedd y Cyfarwyddwr hefyd wedi nodi bod ceisiadau am drwydded bersonol a cheisiadau Goruchwylwr Safle Dynodedig (DPS) yn parhau i fod yn gyson. Mae hyn oherwydd bod nifer o weithwyr yn y maes wedi symud i swydd arall yn ystod y cyfyngiadau, ac mae angen llenwi'r swyddi hynny nawr wrth i'r tafarnau a chlybiau chwilio am Oruchwylwr Safle Dynodedig a deiliaid trwydded bersonol newydd.

Rhodddod y Cyfarwyddwr wybod bod un apêl mewn perthynas â chais am Amrywio Trwydded Eiddo wedi cael ei gyflwyno ers y cyfarfod Pwyllgor diwethaf. Rhodddwyd gwybod hefyd bod ymgeisydd White Lion Hotel wedi cyflwyno apêl. Roedd y cais yma wedi'i nodi yn yr adroddiad diwethaf fel cais i ddod, ond mae'r cais wedi cael ei ohirio erbyn hyn a bydd dyddiad newydd yn cael ei drefnu.

Cyfeiriodd y Cyfarwyddwr yr Aelodau at adran 4.3 yr adroddiad lle mae arolygiadau o eiddo a thor rheolau'n cael eu hamlinellu. Cafodd yr Aelodau gwybod bod lefel cyflawniad ar gyfer eiddo sydd wedi'u harchwilio yn 91%% o hyd, sy'n gyson â'r canlyniadau blaenorol, ac na chynhaliwyd arolygiadau trwyddedu penodol yn ystod y cyfnod adrodd hwn oherwydd bod swyddogion yn cynnal archwiliadau'r coronafeirws.

Aeth y Cyfarwyddwr ymlaen i drafod y cyfnod adrodd cyfredol sydd wedi gweld yr holl dafarnau, clybiau a bwytai trwyddedig yn ailagor yn dilyn y cyfyngiadau a gafodd eu rhoi ar waith gan Lywodraeth Cymru er mwyn brwydro yn erbyn pandemig y coronafeirws. I gychwyn, roedd y

cyfyngiadau yma'n caniatáu i'r adeilad agor yn yr awyr agored ond erbyn hyn mae modd iddyn nhw fasnachu dan do.

Rhoddwyd gwybod bod cwynion wedi cael eu cyflwyno mewn perthynas â busnesau lle nad oedden nhw'n cydymffurfio â'r canllawiau, gan gynnwys diffyg cadw pellter cymdeithasol, peidio â nodi manylion Orlhain Cysylltiadau, gwasanaeth wrth y bwrdd ac ati. Mae nifer o gwynion yn ymwneud â sŵn sy'n dod o fannau awyr agored, mae hyn wedi codi ledled RhCT, ac mae llawer o'r dryswch a rhwystredigaeth yn deillio o gemau megis pŵl, dartiau, bowlio ac ati.

Cafodd yr Aelodau wybod bod Hysbysiadau Gwella Eiddo wedi cael eu cyflwyno i'r rheiny sydd ddim yn dilyn cyngor swyddogion, a oedd yn rhoi cyfle i'r eiddo ddatrys unrhyw gamgymeriadau. Roedd hawl gan swyddogion gyflwyno Hysbysiad Cau Eiddo mewn achosion lle'r oedd enghreifftiau o dorri'r rheolau o hyd.

Ar ben hynny, mae Swyddogion wedi bod yn mynychu cyfarfodydd Pubwatch, sydd wedi ailgychwyn yn RhCT.

Rhoddwyd gwybod bod dau eiddo wedi gorfod rhoi'r gorau i werthu alcohol oherwydd absenoldeb Goruchwyliwr Safle Dynodedig.

Rhoddodd y Cyfarwyddwr wybod am broblemau'n gysylltiedig â phobl fainc dan 18 oed yn yfed alcohol a nodwyd bod yr Awdurdod yn gweithio gyda phartneriaid megis yr Heddlu, Safonau Masnach a Swyddogion Ymgysylltu â Phobl Ifainc, sydd wedi ymweld â siopau yn yr ardaloedd hynny i drafod pa ddogfennau adnabod sy'n dderbyniol a'r broblem o werthu alcohol drwy ddirprwy. Bydd swyddogion yn cael gwybod os yw rhagor o wybodaeth yn dod i law. Ar ben hynny, mae cylchoedd trafod canol tref Pontypridd ac Aberdâr wedi ailgydio yn eu gwaith ac mae'r Gorchymyn Diogelu Mannau Agored Cyhoeddus (PSPO) yn cael ei werthuso i lywio adolygiad gan y Cabinet ym mis Medi.

O ran adennill ffioedd blynyddol, cafodd yr Aelodau wybod bod yr Adran Drwyddedu wedi penderfynu yn y lle cyntaf i beidio gorfodi talu ffioedd ar unwaith yn ystod y cyfnod oherwydd y caledi economaidd sy'n wynebu safleoedd, ond ei bod bellach yn gofyn am daliadau oherwydd gofynion y Ddeddfwriaeth. ### **23 Apologies for Absence**

Apologies for absence were received from County Borough Councillors A. Cox and L. Hooper.

### **24 Declaration of Interest**

In accordance with the Council's Code of Conduct, there were no declarations made pertaining to the agenda.

### **25 Human Rights Act 1997 and Crime and Disorder Act**

It was **RESOLVED** to note that when Members determine the licensing and registration matters before them, they have a duty not to act in a manner that is incompatible with the convention on Human Rights and the Crime and Disorder Act.

### **26 Minutes**

It was **RESOLVED** to approve the minutes of the 4<sup>th</sup> May 2021 as an accurate reflection of the meeting.

## 27 **Review of the Licensing Act 2003 & Gambling Act 2005**

The Director, Public Health, Protection and Community Services provided the Committee with the report on relevant issues with regard to the Licensing Act 2003 and the Gambling Act 2005, together with ancillary matters arising from the responsibilities charged to the Committee.

It was reported that the number of Temporary Events Notices (TEN's) during the period have risen dramatically since the last reporting period to 74 during this period. This was predicted during the last report, the reason being re-opening of pubs and clubs. TENs have predominantly been used to allow premises to utilise their space to increase their capacity due to limitations under the coronavirus regulations with the largest number having being used by clubs, because clubs are not permitted to allow 'off-sales' unless they are open for 'on-sales', therefore when premises were only permitted to open outdoors clubs required a TEN to allow them to trade.

Furthermore, applications as a whole have also steadily increased, jumping up from a total of 99 last report to 163 during this period, which again is a reflection of the licensed trade opening back up and the majority being transfer applications.

The Director also noted that personal licence applications remain consistent as does vary DPS applications, as during the lockdown period for pubs and clubs many personnel moved trade which required backfilling, hence the changes of DPS and new personal licence holders.

The Director reported that since the last Committee report, there had been one contested application for Variation of a Premises Licence. It was also reported that an Appeal from the applicant of the White Lion Hotel had been lodged and reported as pending in the last report but had since been adjourned and a new date is to be determined.

The Director referred Members to section 4.3 of the report, where the premises inspections and infringements were outlined. Members learned that there is no change to the current performance level for inspected premises which as reported last was 90.5% and that specific licensing inspections had not been conducted during this reporting period due to officers conducting coronavirus inspections.

The Director went on to describe the current reporting period which has seen all licensed pubs, clubs and restaurants re-open following their enforced closures due to the restrictions imposed by Welsh Government to combat the coronavirus pandemic, where Initially the premises were only permitted to open outdoors but are also now allowed to trade indoors.

It was reported that complaints have been received relating to premises not adhering to the guidelines such as lack of, social distancing, track and

trace details, table service etc. Many complaints have involved noise nuisance emanating from outside areas, this has been across the whole of RCT, and also much confusion and frustration from the trade has surrounded the issue of playing pub games such as pool, darts, skittles etc.

Members learned that where premises have not followed advice officers have issued Premises Improvement Notices (PINs) which gave the premises time to rectify any wrongs. Where breaches were so significant officers were permitted to issue a Closure Notice.

Furthermore, Officers have been active in Pubwatch meetings which have now resumed in most areas of RCT.

It was reported that two premises were enforced the cessation of alcohol sales for an absence DPS.

The Director reported on the issues of underage drinking and noted that the Authority is working with partners such as Police, Trading Standards and Youth Engagement Project (YEP) Officers who visited some off licenses in those areas to discuss acceptable forms of ID and the issue of proxy sales. Officers will be kept informed if any further information becomes known. Furthermore, Pontypridd and Aberdare town centre forums have restarted and also the Public Space Protection Order (PSPO) is being evaluated to inform a review by Cabinet in September.

In terms of the recovery of annual fees, Members were reminded that the Licensing department had initially taken the decision to not chase immediate payment of the fees during the past year due to the economic hardship placed on premises, but had to begin chasing payments due to Legislation requirements. It was noted that the total income received as at 31<sup>st</sup> May 2021 was £4,660.00 which was attributed to the hard work of the team.

Members noted that there were no significant changes in terms of the Gambling Act 2005. Members were advised that the local RCT statement of principles was due for review in the Autumn Term and that the process would begin during the next reporting period.

Members took the opportunity to thank the Licensing Team for their continuous hard work and it was **RESOLVED:-**

- a) To note the contents of the report in respect of the **Licensing Act 2003** and;
- b) To note the contents of the report in respect of the **Gambling Act 2005**.

#### 1. PURPOSE OF THE REPORT

The purpose of the report is to update Members on relevant issues, with regard to

- the **Licensing Act 2003**
- the **Gambling Act 2005**

#### 2. RECOMMENDATION

#### 3. BACKGROUND

Members will be aware that a quarterly meeting is convened to review and discuss the implementation and progress of the Licensing Act 2003, together with any ancillary matters arising from responsibilities with which this particular Committee is charged.

Such ancillary matters include the Gambling Act 2005. (There may also be ancillary matters arising from the impact of the Smoke-Free Premises Regulations, which have the potential to affect all licensed premises).

#### 4. **LICENSING ACT 2003**

##### 4.1 **Application Process**

Applications received since the last update (**21<sup>st</sup> June, 2021 to 17<sup>th</sup> October, 2021**) are as follows:-

The number of TENs applications received have continued to rise as we saw some easing of the coronavirus regulations. An analysis of the TENs applications indicate, 23 for existing premises licences, 42 for permitted community events and 16 from Private Members Clubs.

One TEN was for a 3 day music festival at Pentwyn Fawr Farm. Following objections from both South Wales Police and Environmental Health department the TEN was withdrawn by the applicant.

No.12 Drinks Emporium and Llantrisant Guildhall have been using TENs to operate while their Premises Licence applications are pending. This can be a useful tool to demonstrate to Responsible Authorities how the applicants intend to run their business.

The number of applications the licensing department have had to consider has again increased since the last reporting period, jumping up from a total of 163 last report to 221 during this period. Again this is a reflection of the licensing trade opening back up. Personal Licence applications and a change of Designated Premises Supervisor has been particularly busy.

A summary of TEN's, is reproduced for Members information as **Appendix 1A**.

**In accordance with the advice received in respect of data protection matters, the summaries of Personal Licences and Premises Licences**

issued under delegated authority are now reproduced for information as a Part II restricted item.

### **4.3 Premises Inspection & Infringements**

The relevant Performance indicator for the Licensing Team is "*the premises licences found to be broadly compliant following inspection by Licensing Officers*". Officers will consider confidence in management, compliance with licence conditions and business competency when determining the risk rating of the premises when considering whether they are broadly compliant.

Licensing inspections have now restarted due to officers now not being involved in coronavirus inspections. During this reporting period there has not been a vast amount of inspections due to officers dealing with applications and



complaints, the current performance level for inspected premises which as reported last was **91.48%**.

#### **4.4 Complaints, Advice and Guidance**

Since the reopening of pubs and clubs the licensing authority has seen an increase in complaints involving noise and anti-social behaviour. This was foreseen and expected due to local residents having licensed premises nearby closed for a long time throughout the Covid restricted period.

Complainants are being directed to use the 'Noise App' where there are noise nuisance issues. Officers can then listen to problem and make a more informed decision on the best action.

The licensing team have continued their excellent partnership working with South Wales Police, with both authorities working in collaboration to resolve complaints. This relationship continues to excel and is a key tool in the way licenced premises are encouraged, advised and managed.

Members will note from the above that following a licensing sub-committee hearing, Players Sports Bar, on the Broadway in Pontypridd was revoked of it's premises licence. This followed an application from South Wales Police, which was supported by various Responsible authorities. This decision has since been appealed by the premises licence holder with assistance of a legal representative. The appeal is ongoing and therefore should not openly discussed at this present time. Members will be updated on the outcome in due course.

Members may also note from section 4.1 above that the licensing authority was involved in a TEN to hold a three day event including music and alcohol on a field within the Mountain Ash area. The event requested was deemed to be a larger event than anticipated. Officers from responsible authorities visited the site and following discussion with the event organiser sought to object on a number of issues, relating to each of the four licensing objectives. Following advice from the authorities the applicant withdrew the TEN.

A licensed premises within the Llantwit Fadre area has recently caused many issues to South Wales Police relating to violence, further complaints have also been received. Officers have been active in investigating the concerns. Members will be updated during the next reporting period on this issue.

As previously detailed in this report applications have increased and officers have worked diligently to process these within statutory timescales, while also ensuring the applications are submitted correctly, and mediating between applicants and responsible authorities. This takes a large amount of officer time.

As part of the application process and as advocated within the Section 182 national guidance, officers have been involved in pre-application meetings, these have assisted the application process to enable the applicant to submit appropriate operating schedules, and ease the application process. This is something we advise applicants in advance of submitting the application.

There have also been a number of alleged underage sales. Our partners within Trading Standards have taken the lead on these allegations in relationship with South Wales Police and are visiting the premises, checking the conditions and CCTV, and providing advice and literature.

A premises within the Rhondda has been continuously associated with public nuisance. This is being investigated by the Environmental Health team.

The Cynon valley has recently seen some serious violence associated with licensed premises. A premises within Penywaun has come to the authorities attention due to an assault that has resulted in a murder enquiry. The enquiry into the incident is being conducted by South Wales Police. The conditions of licence are being discussed with the premises licence holder/designated premises supervisor to seek to update to make them suitable for purpose. Members will be updated in due course.

A further incident occurred within the Mountain Ash area where a person was assaulted with a knife within a licensed premises. Again this incident is being dealt with by South Wales Police, with their licensing department taking the lead on licensing matters.

The authority has received nuisance reports about another premises in Aberdare. The premises has been spoken to and has denied the issues are due to the premises. Officers will conduct a visit to observe at the relevant times.

Further noise issues are impacting a nightclub within the Porth area. Complaints have been received, which was followed with a meeting between a licensing officer, environmental pollution officer and two councillors. This premises will be monitored to observe the allegations. Many of the allegations involve anti-social behaviour from customers after leaving the premises and loud music.

A licensed convenience store has come to attention for sales of illegal cigarettes/tobacco and for breaches of licence. This premises is now subject to Review following an application from Trading Standards.

Pubwatch meetings are continuing to take place, these are always good forums to discuss local issues and raise awareness of initiatives.

Members may be aware that people in Wales now need an NHS Covid pass to legally enter nightclubs and large events. Anyone aged over 18 will be required to show the pass to prove they are either fully vaccinated or have had a negative lateral flow test result within the last 48 hours. RCT have a Covid team who are available to provide assistance and advice on this, the team will also visit premises to proactively advise.

The payment of annual fees are at a positive level for this stage of the year. Officers have acted to make contact with any overdue payments, with many premises then making full payment. Some premises have been suspended for non-payment, officers will monitor these premises and visit to ensure they are not open and trading. This is a priority at the moment to ensure there is no illegal trading.

### 5.3 Recovery of Annual Fees
