Adroddwyd bod nifer y ceisiadau am Hysbysiadau Digwyddiad Dros Dro sydd wedi dod i law wedi parhau i gynyddu wrth i ni weld rheoliadau coronafeirws yn lleihau ac mae dadansoddiad o'r ceisiadau Hysbysiadau Digwyddiad Dros Dro yn cynnwys 23 cais ar gyfer trwyddedau eiddo presennol, 42 ar gyfer achlysuron cymunedol a ganiateir ac 16 gan Glybiau Aelodau Preifat.

Ar ben hynny, mae nifer y ceisiadau y bu'n rhaid i'r adran drwyddedu eu hystyried wedi cynyddu eto ers y cyfnod adrodd diwethaf, gan godi o'r 163 cais a nodwyd yn yr adroddiad diwethaf i 221 cais yn ystod y cyfnod yma. Mae hyn eto'n adlewyrchiad o eiddo â thrwyddedau yn ailagor. Mae ceisiadau am Drwyddedau Personol a cheisiadau i newid Goruchwyliwr Safle Dynodedig hefyd wedi bod yn arbennig o brysur.

Dywedodd y Cyfarwyddwr y bu un cais a wrthwynebwyd am Amrywio Trwydded Safle ers adroddiad diwethaf y Pwyllgor. Serch hynny, tynnwyd y cais hwnnw yn ôl. Gofynnodd Heddlu De Cymru am adolygiad yn ystod y cyfnod lle penderfynodd yr Is-bwyllgor y dylid dirymu'r drwydded ac roedd apêl ar y gweill. Nododd y Cyfarwyddwr, ers ailagor tafarndai a chlybiau, fod yr awdurdod

30 Apologies for Absence

Apologies for absence were received from County Borough Councillors S. Bradwick, T. Williams and L. Hooper.

31 Declaration of Interest

In accordance with the Council's Code of Conduct, there were no declarations made pertaining to the agenda.

It was **RESOLVED** to note that when Members determine the licensing and registration matters before them, they have a duty not to act in a manner that is incompatible with the convention on Human Rights and the Crime and Disorder Act.

33 Minutes

It was **RESOLVED** to approve the minutes of the 6th July 2021 as an

accurate reflection of the meeting.

34 Review of the Licensing Act 2003 & Gambling Act 2005

The Director, Public Health, Protection and Community Services provided the Committee with the report on relevant issues with regard to the Licensing Act 2003 and the Gambling Act 2005, together with ancillary matters arising from the responsibilities charged to the Committee.

It was reported that the number of TENs applications received have continued to rise as we saw some easing of the coronavirus regulations and an analysis of the TEN's applications indicate, 23 for existing premises licences, 42 for permitted community events and 16 from Private Members Clubs.

Furthermore, the number of applications the licensing department have had to consider has again increased since the last reporting period, jumping up from a total of 163 last report to 221 during this period, which again is a reflection of the licensing trade opening back up. Also, Personal Licence applications and a change of Designated Premises Supervisor has been particularly busy.

The Director reported that since the last Committee report, there had been one contested application for Variation of a Premises Licence but had since withdrew their application. Furthermore, there had been a review requested by South Wales Police during the period whereby the Sub-Committee determined that the license be revoked and that an appeal was pending, however, during this period, it had since been determined that the appeal was out of time and that the license is now fully revoked. Also, the Director informed the Committee that there were two further pending reviews scheduled for November 2021, which would be reported back to a future Committee.

It was also reported that the last Committee report advised that an Appeal from the applicant of the White Lion Hotel had been lodged and reported as pending but this has since withdrawn following a transfer of a license.

The Director referred Members to section 4.3 of the report, where the premises inspections and infringements were outlined. Members learned that there is no change to the current performance level for inspected premises which as reported last was 91.48% and that Licensing inspections have now restarted due to officers now not being involved in coronavirus inspections.

The Director noted that since the reopening of pubs and clubs the licensing authority has seen an increase in complaints involving noise and anti-social behaviour, which was foreseen and expected due to local residents having licensed premises nearby closed for a long time throughout the Covid restricted period. Furthermore, complainants are being directed to use the 'Noise App' where there are noise nuisance

issues so that Officers can then listen to problem and make a more informed decision on the best action.

The Director reported that the licensing team have continued their excellent partnership working with South Wales Police, with both authorities working in collaboration to resolve complaints and this relationship continues to excel and is a key tool in the way licenced premises are encouraged, advised and managed.

Furthermore, Pubwatch meetings are continuing to take place which are always useful forums to discuss local issues and raise awareness of initiatives. The recent publicity in relation to spiking of drinks is a noted concern of the trade and patrons, and the Director advised a report to update committee on work on this issue would be presented to a future meeting.

Members learned that people in Wales now need an NHS Covid pass to legally enter nightclubs and large events and anyone aged over 18 will be required to show the pass to prove they are either fully vaccinated or have had a negative lateral flow test result within the last 48 hours. Also, RCT have a Covid team who are available to provide assistance and advice on this, the team will also visit premises to proactively advise.

1. PURPOSE OF THE REPORT

The purpose of the report is to update Members on relevant issues, with regard to

- the Licensing Act 2003
- the Gambling Act 2005

2. RECOMMENDATION

Members are requested to: -

- (i) note the contents of the report in respect of the **Licensing Act 2003** which has been provided for information;
- (ii) note the contents of the report in respect of the **Gambling Act 2005**, which has been provided for information.

3. BACKGROUND

Members will be aware that a quarterly meeting is convened to review and discuss the implementation and progress of the Licensing Act 2003, together with any ancillary matters arising from responsibilities with which this particular Committee is charged.

Such ancillary matters include the Gambling Act 2005. (There may also be ancillary matters arising from the impact of the Smoke-Free Premises Regulations, which have the potential to affect all licensed premises).

4. **LICENSING ACT 2003**

4.1 **Application Process**

Applications received since the last update (**18th October, 2021 to 16th January, 2022**) are as follows:-

The number of TENs applications received have fallen from 81 in the last report to a total of 58 during this period which can be attributed in part to the coronavirus restrictions that were introduced from Boxing Day such as nightclubs being forced to close, groups of no more than six people could meet in licensed premises, table service only and the two metre social-distancing rule returned.

An analysis of the TEN's applications indicate, 30 for existing premises licences, 14 for permitted community events and 14 from Private Members Clubs.

This period included some of the autumn rugby internationals for which some of the TENS were issued.

The festive period also saw TENS for activities such as Christmas markets, carol concerts and the sale of alcohol in non-licensed premises.

Cwm and Llantwit Welfare Hall applied for a late TEN and a normal TEN. The late TEN was submitted out of time therefore this could not be proceed. The standard TEN was initially objected to by South Wales Police, however discussions between the parties enabled a mediation of the conditions on the TEN which allowed it to proceed.

A summary of TEN's, is reproduced for Members information as **Appendix 1A**.

In accordance with the advice received in respect of data protection matters, the summaries of Personal Licences and Premises Licences issued under delegated authority are now reproduced for information as a Part II restricted item.

4.3 Premises Inspection & Infringements

The relevant Performance indicator for the Licensing Team is "*the premises licences found to be broadly compliant following inspection by Licensing Officers*". Officers will consider confidence in management, compliance with licence conditions and business competency when determining the risk rating of the premises when considering whether they are broadly compliant.

The number of inspections has been minimal during the current reporting period with officers dealing more with complaints and other aspects of the Licensing Act 03. The inspections undertaken have primarily been conducted following complaints, with those premises being deemed to be higher risk due to alleged non-compliance issues. This is shown in the slight decrease since last reported in the current performance level for inspected premises which is now at **90.42%**.

4.3 Complaints, Advice and Guidance

- Officers have reported that this has been quieter than usual due to the restrictions imposed by covid regulations – many licensed premises reporting issues with staff and needed to close over the Christmas/New Year period due to isolating staff. Premises are also struggling to get SIA supervisors – pre pandemic they were costing £10 an hour and now the cost has increased to around £18.50 per hour. This is tough for the trade to get SIA staff as so many have not renewed their registration or found work elsewhere.
- Pubwatch activities continue to proceed in the Taf area. The Treforest Pubwatch has been expanded to include Rhydyfelin, Treforest Ind Est and Hawthorn areas in the hope of getting a higher attendance – letters have been sent out to licensed premises with dates planned for the rest of the year. The Pontypridd Pubwatch held an extra meeting to enable the Covid Enforcement Team attend to explain the new rules to those present, everyone was afforded the opportunity to ask questions, this was a great benefit to the licence holders.
- Soul Suite within Pontypridd has closed it's doors for the last time and will not be reopening as the Soul Suite. There remains a licence on the premises so a new venture may open there in the future.
- Squares nightclub in Porth has continued to cause issues for the department with continuous complaints from residents involving noise nuisance and anti-social behaviour from customers when leaving. Many complaints have also been forward through local councillors. Licensing and Environmental Health officers have monitored the issues, including from within a nearby residents' property. Contact was made with the club and discussions held regarding the complaints and ways to resolve or minimise the concerns. The club made amendments to the way customers leave the premises however this has failed to rectify the issue. The premises has been forced to close since Christmas due to Covid restrictions, though officers are continuing discussions on how best to proceed with this matter.
- Well established licensed premises in the Graig area of Pontypridd is up for sale and isn't certain that it will remain as a licensed premises going forward.
- Complaints have been received about the Carpenters Arms in Efail Isaf, issues regarding music noise when utilising a new space. This has now been addressed and full advice given to the Premises Licence Holder and DPS.
- Three Late Night refreshment Premises in Pontypridd town centre have been causing some issues by allowing youths to congregate outside. Full advice has been given to the premises and inspections have been carried out.
- The Senior Licensing Officer and South Wales Police Licensing officer met with the Committee and the Stewardess (manager) of Treorchy RFC following an incident where a large fight broke out and children were still on the premises. Appropriate advice provided. The licensing authority is anticipating a Premises Licence application to be submitted soon. Amended conditions at the very least are required on this Club Premises Certificate.

- Similarly officers attended Porth RFC where they met with the Committee of the club following an incident where a fight broke out. Advice given.
- Officers accompanied by South Wales Police met with Club Ice management at Pontypridd Police Station following a number of allegations made to South Wales Police of spiking and a noise complaint. Following the discussions all appears to be in order, allegations of spiking were found to be untrue and the noise complaint was due to having a different door open to the cloakroom – this was put right and we have no further complaints of noise.
- Trading Standards Officers issued a warning to the Coed Ely Club due to suspected underage sales.
- There has been a premises within the Rhondda that has caused concerns to South Wales Police regarding an organised crime group frequenting the premises. Officers visited the premises and raised concerns which appear to have resolved the issue. A full inspection of the premises was also conducted.
- There are ongoing complaints regarding anti-social behaviour and other concerns at a premises in Cwmparc, these are currently under investigation therefore full details are not currently afforded.
- An advice meeting was arranged with Police officers at Taffs Well RFC which has resulted in the premises submitting a minor variation to amend conditions.
- Aberdare has been quite quiet during this reporting period. Both Police and licensing have seen a decline in noise and Anti-social behavioural complaints in the area. Judges nightclub has not reopened since lockdown as the management don't feel it is viable with current restrictions. The Bush only opened for five weeks with the new manager having now surrendered the lease back to Admiral Taverns. Other premises have closed intermittently either due to covid outbreaks or covid restrictions. It is thought that the Aberdare regulars are now travelling to Merthyr or Pontypridd for their nights out.
- Queries and complaints are continuing to take up officer time.
- The licensing Manager and Senior Licensing Officer attended the Institute of Licensing Annual Conference. This was an opportunity to attend a large number of events regarding the whole of the licensing regime, to gain knowledge on current and upcoming issues and refresh knowledge in other fields.

4.4 Spiking

During last committee members were informed that since January 2021 there have been 20 reports relating to spiking in the RCT area. However, there were no confirmed cases of spiking – partly due to the nature of the reporting as it is generally retrospective. Of the 20 reports:-

- 1 is historic – from 11 years ago
- 1 relates to school pupils putting hand sanitiser in a water bottle
- 1 report relates to a tobacco spiking
- 7 reports have been negated from CCTV enquiries
- 10 reports that have not been proven....one of which appears to be a false report from CCTV but cannot be negated.

Concerns were expressed over a potential increase in spiking over the Christmas period, however, after consulting with South Wales Police, we can advise that there have been no reported incidents over the festive period. Whilst this is good news, we must be mindful of the increased Covid restrictions that were put in place for the hospitality sector that may have had an impact.

On Tuesday 21 December 2021, the Wales Safer Communities Network, with support from the Wales Violence Prevention Unit, hosted a Spiking Workshop to discuss the approaches being taken to tackle and reduce the risk of 'spiking' in Wales with public bodies, third sector organisations and private companies. The workshop gave an opportunity to share information from across Wales and ensure that there are no gaps being left between the different agencies and partnerships, ensuring there is a coordinated and joined up response. This workshop was the first of a number of workshops and discussions on the topic.

From within the workshop a representative of the NHS gave information which noted that drink spiking with drugs is incredibly uncommon and spiking through needles even more uncommon.

The Local Government Association has also met and following discussion with partner agencies have stated so far there has been very little, if any, evidence that there is an issue of spiking.

However the licensing authority has supported the Wales wide Christmas campaign / Police anti spiking campaign by posting information of the social media site, an example is shown as Appendix 2.

4.5 Ask Angela

This initiative is being co-ordinated by Community Safety, Licensing and Domestic Violence staff and was relaunched w/c 15th November 2021 to coincide with Safeguarding week. The Local Authority have printed and distributed 'Ask Angela' literature to all the licensed premises within RCT. The lead officer is following this up by attending targeted licensed premises and providing face to face awareness sessions. She is also attending all pubwatch meetings to provide awareness. The awareness sessions are ongoing. This member of staff is the point of contact for any person who makes contact with us regarding the scheme and works very

closely with the RCT licensing officers. Licensing Officers check the location of posters etc whilst conducting their routine inspections of licensed premises.

Within the first couple weeks of the campaign, a female presented herself to staff at a premises within the Pontypridd area and asked for Angela. The staff member ensured her safety and arranged for her to get home in a safe manner.
