#### **5      Adolygiad o Ddeddf Trwyddedu 2003 ac o Ddeddf Gamblo 2005**

Cyflwynodd y Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio yr adroddiad i'r Pwyllgor. Roedd yr adroddiad yn trafod materion perthnasol o ran Deddf Trwyddedu 2003 a Deddf Gamblo 2005, yn ogystal â materion atodol eraill sy'n deillio o gyfrifoldebau'r Pwyllgor.

Clywodd yr Aelodau fod nifer yr Hysbysiadau Achlysuron Dros Dro (TENs) wedi cynyddu'n rheolaidd ers llacio'r cyfyngiadau o ran y Coronafeirws, a bod nifer yr hysbysiadau wedi dyblu ers y cyfnod adrodd diwethaf. Mae'r cynnydd yma i'w weld o ganlyniad i achlysuron yn y gymuned ac achlysuron ym maes

chwaraeon. Yn ogystal â hynny, mae Jiwbil'r Frenhines a'r dathliadau Balchder sydd ar y gweill wedi cyfrannu at y twf yma.

Mae dadansoddiad o'r ceisiadau am Hysbysiadau Achlysuron Dros Dro a ddaeth i law yn dangos bod 37 o drwyddedau personol wedi'u cyflwyno. Mae hwn yn gam calonogol i'r diwydiant o ran tafarndai a lletygarwch. Ni chafodd unrhyw geisiadau eu herio yn ystod y cyfnod yma, ond cafodd 5 adolygiad eu cynnal. Cafodd yr Aelodau eu cyfeirio at y tabl ar dudalen 13 yn y pecyn adroddiad. O ran y Collier Arms ym Mhen-y-Waun, penderfynwyd bod angen dileu rhai amodau nad oedd yn berthnasol mwyach oddi ar y drwydded, yn ogystal ag ychwanegu rhai amodau penodol. Cafodd trwydded Chippy Plus ei dileu hefyd, ond mae'r ymgeisydd yn ystyried gwerthu'r eiddo/neu'n ystyried ildio ei drwydded. Mae'r adolygiad arall yn ymwneud â'r hen swyddfa bost yn y Porth, sy'n cael ei hadnabod fel clwb nos 'Squares'. Mae deiliaid y Drwydded wedi cyflwyno apêl, a bwriedir iddo gael ei gynnal ar 1 Awst. Cafodd trwydded 'Food For You' ei dileu hefyd. Mae'r garfan ar ddeall bod y sefydliad yn bwriadu cyflwyno apêl yn erbyn y penderfyniad yma, ond does dim apêl wedi'i brosesu hyd yma. Cafodd trwydded 'Mountain Ash Stores' ei dileu hefyd ac mae'r cwmni wedi cyflwyno apêl i'r Llysoedd.

Ymhellach, nododd y swyddog fod un apêl wedi bod yn destun gwaith cyfryngu rhwng y safle a'r Awdurdodau Cyfrifol ers y cyfnod adrodd diwethaf, a bod hyn wedi osgoi'r angen am wrandawriad yn y Lllys. Y ddwy apêl sy'n cael eu prosesu ar hyn o bryd yw 'Chippy Plus' a 'Squares', a'r dyddiad adolygu ar eu cyfer yw 1 Awst.

Cyfeiriodd Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio yr Aelodau at amlinelliad o'r arolygon safle a'r troseddau. Cafodd 97 o safleoedd eu harolygu ledled y Fwrdeistref, ac roedd angen cynnal ymweliadau dilynol â nifer ohonyn nhw. Bwriad yr ymweliadau yma oedd targedu safleoedd sydd ddim wedi cydymffurfio yn y gorffennol, yn ogystal ag ymchwilio i gwynion. Ychydig iawn o arolygiadau a gynhaliwyd yn ystod y pandemig ac felly roedd disgwyl y byddai'r arolygiadau'n dangos nad yw rhai safleoedd bellach yn cydymffurfio'n llawn ag amodau eu trwydded o bosib. Caiff hyn ei brofi'n gywir ar ôl i staff ganfod bod nifer o safleoedd ddim yn cydymffurfio'n llawn â'u trwyddedau. Roedd hyn am amrywiaeth o resymau, o gamgymeriadau bach i bryderon mwy sylweddol megis diffyg Teledu Cylch Cyfyng ac absenoldeb Goruchwylwyr Dynodedig. Mae hyn i'w weld yn y gostyngiad bychan yn lefel cyflawniad safleoedd a arolygwyd ers y cyfnod adrodd diwethaf. Y ffigur erbyn hyn yw **87%**.

Mae swyddogion yn gweithio'n barhaus gyda'r safleoedd yma i sicrhau eu bod nhw'n cydymffurfio.

Mewn perthynas â nifer y cwynion a dderbyniwyd, clywodd yr Aelodau fod y diwydiant alcohol wedi parhau i deimlo effaith pandemig Covid, gyda nifer yr ymwelwyr yn parhau i fod yn is nag yr oedd cyn y pandemig. Mae rhai wedi aros ar gau. Y gobaith yw y bydd modd ailgydio mewn rhyw fath o normalrwydd yn y dyfodol, a fydd yn helpu'r diwydiant i ddod yn fwy cynaliadwy. Mae un enghraifft o effaith y pandemig i'w weld yn y Rhondda Hotel, sydd bellach ar werth oherwydd nad oedd deiliad y drwydded o'r farn bod y busnes yn hyfyw mwyach. Mae unigolyn newydd wedi gwneud ymholiadau ynglŷn â throsglwyddo'r drwydded. Mae cyngor ac arweiniad wedi'u darparu. Mae Awdurdod y Diwydiant Diogelwch (SIA) hefyd wedi profi effaith y pandemig. Amcangyfrifir bod 40,000 yn llai o unigolion cofrestredig yn y DU nag yr oedd cyn y pandemig, sydd yn ei dro yn effeithio ar y safleoedd sydd angen staff o'r fath.

Mae cwynion problematig parhaus yn dal i ddod i law ers y cyfnod adrodd blaenorol. Bu'n anodd ymchwilio'n drylwyr i'r rhain gan fod angen i swyddogion barhau i weithio o fewn cyfyngiadau Covid. Doedd dim modd monitro cwynion am sŵn ac ati mewn modd trylwyr oherwydd bod pobl yn teimlo'n nerfus am gael swyddogion yn eu cartrefi. Mae hyn yn gwbl ddealladwy, ond mae'n rhwystro swyddogion rhag cynorthwyo'r cyhoedd drwy asesu'r effaith yn gywir.

Mae'r ymgyrch 'Gofyn am Angela' neu 'Ask for Angela' (fel y codwyd mewn adroddiadau blaenorol) yn gweithio ac wedi cael ei roi ar waith yng nghanol tref Pontypridd. Mae unigolion wedi derbyn gofal yn ein safleoedd trwyddedig o ganlyniad i'r cynllun yma. Fel y soniwyd yn flaenorol, mae hon yn ymgyrch gadarnhaol iawn i gynorthwyo unrhyw berson sy'n teimlo dan fygythiad tra'u bod nhw allan mewn tafarn/clwb. Mae rheolwyr y safleoedd yma bellach yn effro i hyn, ac yn hyfforddi staff i fod yn effro i'r cynllun hefyd. Mae pob achos o rywun yn manteisio ar y cynllun yma yn dangos ei fod yn llwyddiant, ac yn rhoi sicrwydd i'r cyhoedd bod cymorth i'w gael gan staff y safle. Er mai creu elw a llwyddo'n fasnachol yw prif nod y busnesau yma, mae hyn yn dangos eu bod nhw hefyd yn ystyried diogelwch y cyhoedd. Mae'r llwyddiant yma yn dod yn sgil gwaith da gan swyddogion mewn adrannau ac asiantaethau amrywiol, sydd wedi bod yn hyrwyddo materion o'r fath.

Fel y soniwyd yn yr adroddiad diwethaf, mae Cynllun Gwarchod Tafarndai Trefforest (Pubwatch) bellach wedi'i ehangu i gynnwys ardaloedd Rhydfelen a'r Ddraenen Wen. Mae hyn wedi bod yn llwyddiannus gan fod y cynllun blaenorol a oedd ar waith yn yr ardaloedd hyn yn ddiffygiol. Mae ehangu'r cynllun i gynnwys yr ardaloedd yma wedi adfywio rhywfaint ar y diwydiant lleol, sy'n newyddion gwyb. Mae'r cynllun yn ffordd dda o alluogi deiliaid trwyddedau i rannu'u pryderon â'r adran drwyddedu a rhoi gwybod i'r heddlu am unrhyw broblemau lleol neu genedlaethol. Yn ogystal â hynny, mae'n fodd o annog deiliaid trwyddedau i gyfathrebu â'i gilydd.

Cafodd yr Aelodau hefyd eu hatgoffa fod James Button, sy'n arbenigwr ym maes trwyddedu, wedi darparu hyfforddiant i aelodau'r pwyllgor. Roedd y swyddog yn gobeithio bod yr hyfforddiant wedi rhoi cipolwg ar ofynion a disgwyliadau'r Aelodau a Swyddogion Trwyddedu.

Mae'r Awdurdod Trwyddedu'n eistedd ar y Grŵp Cynghori ar Ddiogelwch Achlysuron (ESAG). Mae'r grŵp yma o aelodau'n cwrdd â'r rheiny sy'n awyddus i drefnu achlysuron er mwyn canfod pa swyddogaethau Cyngor sydd eu hangen arnynt i sicrhau bod unrhyw achlysur yn cael ei gynnal mewn modd diogel a chyfreithlon. Mae hwn yn grŵp amlddisgyblaethol gydag aelodau o'r Awdurdod Lleol yn cynnwys Trwyddedu, Iechyd yr Amgylchedd, Parciau, Achlysuron a Phrifyrdd, ac asiantaethau allanol fel Heddlu De Cymru, Gwasanaeth Tân De Cymru, a'r Gwasanaeth Ambiwylans ymhlith eraill. Yn ystod y ddwy flynedd diwethaf mae llawer o achlysuron wedi'u canslo neu eu gohirio, sy'n golygu bod y grŵp wedi bod yn arbennig o brysur eleni, yn enwedig oherwydd penwythnos y Jiwbilî! Yn y cyfnod cyn penwythnos y Jiwbilî ym mis Mehefin, roedd y grŵp yn cyfarfod bob pythefnos, ac yn siarad bron bob dydd i sicrhau bod yr achlysuron a drefnwyd ledled RhCT yn cael eu cynnal yn ddiogel. Mae'r gwaith yma'n cymryd llawer o amser, ond mae'n hanfodol er mwyn galluogi RhCT i gynnal achlysuron o bob maint yn llwyddiannus ac, yn bwysicach fyth, yn ddiogel.

Atgoffwyd yr Aelodau bod Stryd Fawr Treorci wedi ennill gwobr pencampwr stryd fawr Prydain Fawr ym mis Ionawr 2020. Mae tafarn y Lion, sydd wedi'i lleoli ar y

stryd fawr, yn ganolbwynt i'r gymuned yma, ac ar 5 Gorffennaf trefnir ymweliad Brenhinol i nodi'r gamp. Mae hyn wedi'i ei ohirio ers 2020 oherwydd Covid. Bydd Ei Uchelder Brenhinol y Tywysog Charles yn ymweld â'r Lion, lle bydd hefyd yn cyfarfod â busnesau eraill. Mae tafarn y Lion wedi bod yn rhagweithiol iawn dros y blynyddoedd diwethaf ac yn parhau i wneud hynny. Sefydlodd y cwmni standin gwerthu llysiau yn ei ardd gwrw, a oedd yn hynod lwyddiannus. Mae hyn wedi arwain at agor 'Green Valley', sef siop ddiwastraff sydd hefyd yn gwerthu llysiau. Mae'r busnes hefyd wedi gosod blwch ffôn coch yn yr ardd a'i droi'n llyfrgell fach, gyda silffoedd yn llawn llyfrau at ddefnydd pawb. Yn ogystal â hynny, mae'n arddangos gwaith celf gan blant ysgol lleol. Mae hyn yn dangos bod modd i safleoedd trwyddedig gael effaith cadarnhaol iawn ar y gymuned leol pan maen nhw'n cael eu rheoli'n gyfrifol.

Mae achlysuron eraill yn y Fwrdeistref yn cynnwys Tyson Fury yn ymweld â Chanolfan Hamdden Rhondda Fach ar 15 Gorffennaf a 3 achlysur ar wahân ym Mharc Pontypridd (9 Gorffennaf), Parc Gelligaled (16 Gorffennaf) a Pharc Aberdâr (23 Gorffennaf) i ddathlu gweithwyr hanfodol a chyflwyno 'Rhyddid y Fwrdeistref' i rai ohonyn nhw. Bydd yr achlysuron yn darparu gweithgareddau llawn hwyl i blant ac yn cynnwys perfformiadau gan gorau a bandiau pres.

Yn ogystal â hynny, bydd Cwm Rhondda'n croesawu Gŵyl Gerddoriaeth Treorci ar 30 Gorffennaf, a bydd nifer o safleoedd trwyddedig yn cymryd rhan yn y dathliadau. Mae Gŵyl Fwyd a Diod Treorci ar 27 Awst hefyd, a bydd achlysuron Pride yn cael eu cynnal ar 16 Gorffennaf yn Flamingo Bar.

Mae tafarn Ivor Hael yn Llwynypia yn cynnig bargaen lle mae modd talu am bris cynhwysion y pryd yn unig. Bydd y cynnig yma ar waith am y mis/chwe wythnos nesaf. Rhaid i bobl sy'n prynu'r prydau bwyd yma gael taleb o fanc bwyd. Wedyn, mae modd iddyn nhw gyfnewid y daleb gyda'r dafarn am brydau penodol. Mae'r safle wedi bod yn gweithio gyda'r Cyng Wendy Lewis ac eraill i roi trefn ar y logisteg. Dyma enghraifft gadarnhaol arall o safle trwyddedig sy'n ceisio cynorthwyo'r gymuned.

Clywodd yr Aelodau fod Cynllun Gwyllo Tafarndai Canolbarth y Rhondda a'r Porth wedi aildddechrau yn dilyn y pandemig. Bydd y cynllun ar gyfer Cwm Rhondda Uchaf yn cychwyn yn fuan. Mae hyn eto'n dangos arwyddion calonogol o'r parodrwydd i symud ymlaen a chydweithio mewn partneriaethau.

O ran Cwynion, ymholiadau a chanllawiau, maent wedi parhau yn ystod y cyfnod yma, ac yn cynnwys:

- Cwmparc Legion – problemau gyda Goruchwyliwr Dynodedig absennol a arweiniodd at gau'r dafarn am gyfnod byr, mae hyn bellach wedi'i ddatrys ac mae Goruchwyliwr Dynodedig newydd wedi'i benodi.
- Gorsaf Betrol Pentre yn gwerthu alcohol y tu allan i'r oriau a ganiateir. Mae'r rheolwyr wedi cymryd camau cadarnhaol, yn ogystal rhoi'r gorau i werthu alcohol. Does dim angen cymryd camau pellach.
- Cyfarfod cynghori cyn agor tafarn yn Abercwmboi. Roedd y safle wedi bod ar gau ers nifer o flynyddoedd, ac yn cael ei adnewyddu, yn barod i ailagor yn ystod yr wythnosau nesaf. Safle o'r enw Cap Coch Inn.
- Ymwelodd swyddog â siop yn Aberaman (Blaengwawr Stores) yn dilyn



adroddiadau bod y Goruchwyliwr Dynodedig wedi marw. Roedd y Goruchwyliwr Dynodedig hefyd yn Ddeiliad Trwydded, ac roedd marw 3 wythnos ynghynt, felly heb ymyrraeth brydlon, byddai'r drwydded wedi dod i ben (mae terfyn o 28 diwrnod ar gyfer trosglwyddo trwydded ar ôl marwolaeth).

- Cyfarfod ar y cyd â Swyddog Iechyd yr Amgylchedd yng Nghlwm Cyn-filwyr Ffynnon Taf i drafod materion sŵn ac ymddygiad gwrthgymdeithasol mewn parti i ddathlu pen-blwydd yn 18 oed. Mae'r clwb wedi cytuno i beidio â chynnal rhagor o bartïon pen-blwydd 18 oed.
- Ymweliad ag eiddo yng Nghwm-bach (Lleng Cwm-bach) yn dilyn adroddiadau bod yr eiddo'n masnachu tra'i fod wedi'i atal am beidio â thalu ffioedd blynyddol. Talwyd ffioedd blynyddol am ddwy flynedd yn brydlon, gan ganiatáu i'r safle ailagor.
- Rhoi cyngor cyn ymgeisio i fenter newydd yn Aberpennar (Neuadd y Dref).

### 1. PURPOSE OF THE REPORT

The purpose of the report is to update Members on relevant issues, with regard to

- **the Licensing Act 2003**
- **the Gambling Act 2005**

### 2. RECOMMENDATION

### 3. BACKGROUND

Members will be aware that a quarterly meeting is convened to review and discuss the implementation and progress of the Licensing Act 2003, together with any ancillary matters arising from responsibilities with which this particular Committee is charged.

Such ancillary matters include the Gambling Act 2005. (There may also be ancillary matters arising from the impact of the Smoke-Free Premises Regulations, which have the potential to affect all licensed premises).

#### 4. LICENSING ACT 2003

##### 4.1 Application Process

Applications received since the last update (**27<sup>th</sup> June, 2022 to 16<sup>th</sup> October, 2022**) are as follows:-

The Number of TENs applications remain on the increase. The Summer months have seen a welcome return to events in the community that we used to enjoy pre-covid epidemic such as the Aberdare Bike Race, The Big Welsh Bite and family fun days. Treorchy Food and Drink Festival was a new event which utilised Tens for various stalls, bringing the community together. Indeed, artisan craft markets are increasing in popularity at several venues.

D J Newsagents in Glyncoch utilised the temporary event process to facilitate trading while they applied for a Premises Licence.

Dare Valley Country had a bar and BBQ to raise funds for a disabled charity.

Again officers have had to spend time assisting the process for a number of notifications due to incorrect information, but also notifications being submitted out of time.

A summary of TEN's, are reproduced for Members information as **Appendix 1A**.

In accordance with the advice received in respect of data protection matters, the summaries of Personal Licences and Premises Licences issued under delegated authority are now reproduced for information as a Part II restricted item.

### 4.3 Premises Inspection & Infringements

The relevant Performance indicator for the Licensing Team is "*the premises licences found to be broadly compliant following inspection by Licensing Officers*". Officers will consider confidence in management, compliance with licence conditions and business competency when determining the risk rating of the premises when considering whether they are broadly compliant.

Officers are continuing to inspect premises and are putting much time into this. In total there has been 70 premises inspected throughout the Borough, some of whom have again required follow up visits due to concerns on adherence to their licence.

The proactive work being conducted has shown an increase in the current performance level for inspected premises which is now at **90.66%** compared to 89.7% during the previous reporting period.

Officers are working continuously with these premises to ensure they become compliant.

### 4.4 Complaints, Advice, Guidance & Information

- The 'Ask Angela' campaign continues to be promoted among premises. This is a very positive step to reassure the public that licensed premises are safe and individuals can approach staff.
- Pubwatch remains strong within RCT, with meetings taking place throughout the Borough. In particular, Pontypridd pubwatch has successfully made the National Pubwatch Awards final for the second year. The chair of the group was invited to the House of Lords for an awards evening. This is a positive story, especially that Pontypridd is the main hub for the night time economy within RCT.
- The senior licensing officer has worked solidly to manage a number of premises within the Taf area, four of which were very problematic, and three of whom had the alcohol removed from sale due to no DPS presence. It is pleasing to note that each of these premises are now compliant. This shows that where possible a stepped approach and much patience and guidance is needed. This is very positive, and negated the need for further enforcement action which would have been the next step.
- Complaints received of a licensed premises within Llantwit Fardre remaining open beyond their conditioned hours. A warning letter has been sent, and the premises will be monitored during the forthcoming weeks.
- Noise complaints continue to be regular throughout the Borough, these were especially prevalent during the summer period. Such complaints are usually responded to by letter to premises and a phone call to advise. If and when the issues persist the licensing team then works in partnership with the Environment Pollution team to resolve. Positively the majority were mediated due to licensed premises adapting behaviour and taking appropriate advice.

- There remains one premises in the Rhondda that continuously receives complaints of noise and anti-social behaviour. This remains a key issue for the team with ongoing monitoring and actions being taken.
- There has been a PSPO breach in Pontypridd town centre from a licensed premises, suitable advice has been given. Officers will continue to monitor.
- The Safety Advisory group which is a multi-agency platform held a meeting in September to discuss events being held across the Borough to the end of 2022. This is required to understand the nature of events and provide appropriate advice from the onset to enable the event to run safely.
- Information was received of some sports grounds selling alcohol pitch side without the required licence. A letter was sent to all clubs across RCT advising of the requirement to have a premises licence or a TEN.
- A joint visit with Trading Standards was conducted to a licensed premises in the Porth area due to allegations of underage sales. This visit was followed by a random visit from SWP. No underage customers were located on the premises.
- Joint visit with SWP to a Beddau licensed premises to check for underage customers being present, no underage found on the premises at that time.
- Officers identified a premises in the Cynon area with an absent DPS. This has now been resolved.
- Monthly meetings are now held with South Wales Police, Trading Standards, Environmental Health and Licensing to discuss any ongoing issues. This is very positive as each Authority has their own perspective on issues. This will continue into the future.
- An officer attended a Gambling conference to understand current concerns within this field.
- A very positive news story is that the Lion Pub in Treorchy won the 'Best Community Pub in Great Britain'. This was open to over 50,000 pubs and the competition was fierce. The reward was prize money of £10,000, which is to be spent on a charity, good cause or local initiative. The owner has decided to donate the winnings to the whole town for Christmas. This will involve paying for the Christmas parade, town loyalty scheme, late night shopping, Santa's grotto every Saturday, and a load more. The owner commented 'We have won this award because of the support we get from our community, so we want to give back to the town'.

The payment of annual fees remains at an expected level. Officers are monitoring and where needed issuing reminder notices and contacting by phone to obtain the payment. This process will continue. The authority has a very robust process to ensure payment is received and will take action such as suspension where necessary. A number of premises have had their licence suspended during this period, which has triggered a reaction and payment from the premises resulting in the suspension being lifted.
