Minutes of the virtual meeting of the Licensing Act 2003 held on Tuesday, 12 July 2022 at 4.30 pm.

#### **1 Declaration of Interest**

In accordance with the Council's Code of Conduct, there were no declarations made pertaining to the agenda.

#### **2 Apologies**

Apologies of absence were received from County Borough Councillors D. Williams and S. Bradwick.

#### **3 Human Rights Act 1997 and Crime and Disorder Act**

It was **RESOLVED** to note that when Members determine the licensing and registration matters before them, they have a duty not to act in a manner that is incompatible with the convention on Human Rights and the Crime and Disorder Act.

#### **4 Minutes**

It was **RESOLVED** to approve the minutes of the 1<sup>st</sup> February 2022 as an accurate reflection of the meeting.

#### **5 Review of the Licensing Act 2003 & Gambling Act 2005**

The Head of Service for Public Protection and Regulatory Services provided the Committee with the report on relevant issues with regard to the Licensing Act 2003 and the Gambling Act 2005, together with ancillary matters arising from the responsibilities charged to the Committee.

It was reported that since the removal of the Coronavirus restrictions the number of TEN's has steadily increased and more than doubled since the last reporting period. This increase is as a result of community events and sporting events. This was also attributed to the Jubilee events and upcoming PRIDE events.

Furthermore, an analysis of the TEN's applications indicate 37 new personal

licenses that have been allocated, which will show a positive step for the industry for staff in terms of pubs and hospitality. There have been no contested applications during this period but there have been 5 reviews. Members were referred to the table on page 13 of the report pack. The Collier Arms in Penywaun and the outcome was that they had some outdated conditions to be moved and specific conditions added to their license. Chippy Plus also had their licence removed but the applicant is considering selling the premises/or considering surrendering his licence. The other review is the old post office in Porth, which is known as 'square'. The License holders have appealed with a view for this to be held on the 1<sup>st</sup> August. 'Food For You' also had their license revoked but the team have been informed that they have appeal this decision but that the appeal has not been processed yet. The other license revoke happened for Mountain Ash Stores and they have also appealed to the Courts.

Furthermore, it was reported that since the last report, one appeal was mediated between the Premises and the Responsible Authorities, removing the need for a Court hearing. The two appeals relate to the 'Chippy Plus' and 'Squares', both with an associated review date of 1<sup>st</sup> August.

The Head of Service for Public Protection and Regulatory Services referred Members the premises inspections and infringements were outlined. In total there has been 97 premises inspected throughout the Borough, a number of which have required follow up visits. These visits have primarily targeted premises that are previously non-compliant, or related to complaints. Very few inspections were conducted during the pandemic and it was anticipated that the inspections show premises may not now be fully compliant with conditions of their licence. This has proven to be correct with many premises being determined broadly non-compliant, reasons range from minor indiscretions to major concerns such as CCTV not working and absent DP's. This is shown in the slight decrease since last reported in the current performance level for inspected premises which is now at **89.7%**.

Officers are working continuously with these premises to ensure they become compliant.

It was reported that in relation to the number of complaints received, the alcohol industry has continued to feel the impact of the Covid pandemic, with premises not receiving the same footfall as pre-pandemic. Some have remained closed. Moving forward it is hopeful that some form of normality will resume to allow the trade to be sustainable. This is highlighted by a licensee placing his pub for sale (Rhondda Hotel) as it is not a viable business because of Covid. A new person has made enquiries about transferring the licence. Advice and guidance has been provided. This is also the same for the Security Industry Authority (SIA) where it is estimated there are 40,000 less SIA registered individuals in the UK than pre pandemic, which in turn impacts on the premises that require such staffing.

Ongoing problematic complaints have continued since the previous report. These have been tricky to investigate thoroughly as officers have had to continue to work within the confines of Covid concerns. Noise complaints etc have been unable to be monitored properly due to people feeling nervous about having officers in their homes. This is wholly understandable but creates barriers to officers when trying to assist the public to accurately assess the issues.

The 'Ask Angela' campaign (as raised in previous reports) has been proven

effective when utilised in Pontypridd town centre – this has been used and people have been taken care of by our licensed premises. As mentioned in previous reports, this is a very positive campaign to assist any person who feels threatened while out in the pub/club scene. Management of premises are now aware of this and train their staff to be aware of this. Any time this is utilised is a success and reassures the member of the public that staff within premises are there to assist. Whilst businesses are there to succeed and make profit it shows that public safety is considered. This is down to good work from officers within various departments and agencies promoting such topics.

As mentioned within the last report the Treforest Pubwatch has been extended to include the Rhydyfelin and Hawthorn areas. This has proved successful of late as this was a failing Pubwatch group. Extending to these areas appears to have reinvigorated the group, enhancing its effectiveness in allowing licence holders and DPS opportunities to raise concerns to the licensing department and the police about local and national issues, and to also interact with each other.

Members were also reminded that training has been provided to committee members from James Button who is recognised as a leading expert in the field of licensing. Hopefully the training gave an insight into the requirements and expectations of both members and licensing officials.

The Licensing Authority sit on the event Safety Advisory Group ESAG, this group of members discuss and meet with potential event organisers to ascertain what Council functions they require to ensure any event is run safely and legally. This is a multi-discipline group with members from the Local Authority including Licensing, Environmental Health, Parks, Events and Highways, and external agencies such as South Wales Police, South Wales Fire Service, Ambulance Service amongst others. During the past two years many events have been cancelled or postponed, meaning this year especially with the Jubilee weekend – the ESAG have been particularly busy!! In the run up to the Jubilee weekend in June, the group met fortnightly, and realistically spoke on an almost daily basis to ensure the events organised throughout RCT were run safely. This is a time-consuming exercise but an essential one to allow RCT to hold events of all scales successfully and more importantly safely.

Members were reminded that Treorchy High Street was awarded the champion high street of Great Britain in January 2020. The Lion Pub located on the street is a hub of this community and on 5th July a Royal visit is arranged to mark this achievement. This has been delayed since 2020 due to Covid. HRH Prince Charles will be attending the Lion where he will also meet with other businesses at the pub. The Lion pub has been very proactive over the past few years and continues to do so. They have held an outdoor green grocer in their front beer garden which was highly successful, this has led to the opening of Green Valley – zero waste shop and greengrocers. The premises has also positioned a red phone box in the garden and turned it into a mini library with shelves full of books for people's use and displays art work from local school children. This shows that licenced premises can be very positive in the local community when managed responsibly.

Other events within the Borough include Tyson Fury coming to Rhondda Fach Sports Centre on 15th July and 3 separate events held in Pontypridd Park (9<sup>th</sup> July), Gelligaled Park (16th July) and Aberdare Park (23rd July) to celebrate key workers and present 'Freedom of the Borough' to some. The events will provide

fun activities for children and include choirs and brass bands.

Within the Rhondda there is also the Treorchy Music Festival on 30th July in which licensed premises taking part. There is a Treorchy Food & Drink Festival on 27th August, and Pride events taking place on 16th July at Flamingo Bar.

The Ivor Hael pub in Llwynypia is running a scheme – cost of ingredients meal deal. Within the next month to 6 weeks, they will be selling food at cost price. Persons buying meals must get a voucher from a food bank, they can then exchange with the pub for cost price meals. The premises has been working with Cllr Wendy Lewis and others to sort out the logistics. This is another positive action from a licensed premises looking to assist the community.

Members were informed of the Mid Rhondda pub watch and Porth pub watch have re-started following the pandemic. Upper Rhondda pub watch will be starting soon. This again shows encouraging signs for the willingness to move forward and work together in partnerships.

In terms of Complaints, queries and guidance, they have continued during this period and include:

- Cwmparc Legion – problems with an absent DPS which led to the pub having to close for a short time, this has now been resolved and new DPS is in place.
- Pentre Service Station selling alcohol outside of the conditioned hours, positive action has been taken by the management, as well as alcohol being taken of sales. No further action is now deemed necessary.
- Pre-opening advice meeting at pub in Abercwmboi. The premises had been closed for several years and is being refurbished, ready to reopen in the next few weeks. Premises known as 'Cap Coch Inn'.
- An officer visited a store in Aberaman (Blaengwawr Stores) following reports that the DPS had died. The DPS was also PLH and had died 3 weeks before prior so without prompt intervention the premises licence would have lapsed (28 day limit for transfer after death).
- Joint meeting with an Environmental Health Officer at club in Taffs Well (Taffs Well Ex-Servicemen Club) to discuss noise and ASB issues at an 18<sup>th</sup> birthday party. Club have agreed not to hold any more 18th birthday parties.
- Visit made to a premises in Cwmbach (Cwmbach Legion) following reports that the premises was trading whilst suspended for non-payment of annual fees. Two years annual fees were promptly paid allowing the premises to reopen.
- Pre application advice given to new venture in Mountain Ash (Mountain Ash Town Hall).
- Joint enforcement visit with Police & Home Office Immigration officers to a store in Mountain Ash following underage sales at the premises. Evidence gained during this visit prompted a premises review.



- The Ship Inn in Llantwit Fadre has been subject to complaints over a prolonged period of time. This has been a time-consuming exercise. These complaints are now being assessed by the Environmental Pollution team.
- There are ongoing concerns with door staff at a premises within Pontypridd; this issue is being discussed with police colleagues.
- Noise complaints from Lanelay Hall in Talbot Green.
- Underage drinking in the Bush, Clydach Vale
- Treorchy RFC, several issues that has required a meeting between the premises, police and licensing.
- Spar, Pontyclun, major concerns regarding the running of the business and potential absent DPS.

Members were given the good news that as part of a partnership approach to Covid Enforcement Officers Maria Meek and Bethan Walters have been awarded with a Special Recognition Award from the Chief Constable and Police Crime Commissioner for South Wales Police. This is well deserved. The officers worked tirelessly during the pandemic in partnership with the police to give advice and to enforce legislation. This was not always welcomed by some premises, but it was conducted to ensure the public remained safe.

As something to note by Members, the licensing team regularly receive complaints from members of the public via councillors, which is good and expected. However, given there are new councillors on the committee, the licensing department wish to advise that it is in the best interest of the constituent to contact the department directly and provide specific details of the complaint and how it affects them personally and to provide contact details. Officers need to follow up complaints, without the full information and the avenue to contact the individual it is difficult to make full enquiries. In terms of spiking, it was reported that there have been no issues with RCTCBC. Awareness is being raised throughout the industry and within South Wales Police and the Licensing department. The senior licensing officer attended a two-hour course in relation to Anti Spiking Awareness, the course was provided by SOS or 'Stamp Out Spiking'. The invitation was provided from the Pontypridd BID as part of a pubwatch initiative in Pontypridd – this highlights the partnership work that goes on behind the scenes within the licensing arena.

In terms of recovery, Members were informed that the team are chasing up the payments.

Under the Gambling Act, Members were referred to page 20 of the report pack. In terms of recovery of annual fees, Members were advised that an officer is to attend a webinar at the end of July which discusses The Future of Gambling in the UK: Reforming Legislation to Prevent the Rise of a New Generation of Problem Gamblers. Any new additions to legislation and concerns will be highlighted and fed back to the team.

The Chair thanked the Officer for the update and took the opportunity to advise that there had been a technical error with the graphic on the pack and that the full pack will be sent out tomorrow.

Another Member also queried whether he could continue to sit on meetings for the Cwm Fadre Welfare Hall and was advised that there was no conflict with this.

Members took the opportunity to thank the Licensing Team for their continuous hard work and it was **RESOLVED:-**

- 1 To note the contents of the report in respect of the **Licensing Act 2003** and;
- 2 To note the contents of the report in respect of the **Gambling Act 2005**.

### 3. **BACKGROUND**

Members will be aware that a quarterly meeting is convened to review and discuss the implementation and progress of the Licensing Act 2003, together with any ancillary matters arising from responsibilities with which this particular Committee is charged.

Such ancillary matters include the Gambling Act 2005. (There may also be ancillary matters arising from the impact of the Smoke-Free Premises Regulations, which have the potential to affect all licensed premises).

#### 4. LICENSING ACT 2003

##### 4.1 Application Process

The Number of TENs applications remain on the increase. The Summer months have seen a welcome return to events in the community that we used to enjoy pre-covid epidemic such as the Aberdare Bike Race, The Big Welsh Bite and family fun days. Treorchy Food and Drink Festival was a new event which utilised Tens for various stalls, bringing the community together. Indeed, artisan craft markets are increasing in popularity at several venues.

D J Newsagents in Glyncoch utilised the temporary event process to facilitate trading while they applied for a Premises Licence.

Dare Valley Country had a bar and BBQ to raise funds for a disabled charity.

Again officers have had to spend time assisting the process for a number of notifications due to incorrect information, but also notifications being submitted out of time.

A summary of TEN's, are reproduced for Members information as **Appendix 1A**.

In accordance with the advice received in respect of data protection matters, the summaries of Personal Licences and Premises Licences issued under delegated authority are now reproduced for information as a Part II restricted item.

### 4.3 Premises Inspection & Infringements

The relevant Performance indicator for the Licensing Team is "*the premises licences found to be broadly compliant following inspection by Licensing Officers*". Officers will consider confidence in management, compliance with licence conditions and business competency when determining the risk rating of the premises when considering whether they are broadly compliant.

Officers are continuing to inspect premises and are putting much time into this. In total there has been 70 premises inspected throughout the Borough, some of whom have again required follow up visits due to concerns on adherence to their licence.

The proactive work being conducted has shown an increase in the current performance level for inspected premises which is now at **90.66%** compared to 89.7% during the previous reporting period.

Officers are working continuously with these premises to ensure they become compliant.

### 4.4 Complaints, Advice, Guidance & Information

- The 'Ask Angela' campaign continues to be promoted among premises. This is a very positive step to reassure the public that licensed premises are safe and individuals can approach staff.
- Pubwatch remains strong within RCT, with meetings taking place throughout the Borough. In particular, Pontypridd pubwatch has successfully made the National Pubwatch Awards final for the second year. The chair of the group was invited to the House of Lords for an awards evening. This is a positive story, especially that Pontypridd is the main hub for the night time economy within RCT.
- The senior licensing officer has worked solidly to manage a number of premises within the Taf area, four of which were very problematic, and three of whom had the alcohol removed from sale due to no DPS presence. It is pleasing to note that each of these premises are now compliant. This shows that where possible a stepped approach and much patience and guidance is needed. This is very positive, and negated the need for further enforcement action which would have been the next step.
- Complaints received of a licensed premises within Llantwit Fardre remaining open beyond their conditioned hours. A warning letter has been sent, and the premises will be monitored during the forthcoming weeks.
- Noise complaints continue to be regular throughout the Borough, these were especially prevalent during the summer period. Such complaints are usually responded to by letter to premises and a phone call to advise. If and when the issues persist the licensing team then works in partnership with the Environment Pollution team to resolve. Positively the majority were mediated due to licensed premises adapting behaviour and taking appropriate advice.

- There remains one premises in the Rhondda that continuously receives complaints of noise and anti-social behaviour. This remains a key issue for the team with ongoing monitoring and actions being taken.
- There has been a PSPO breach in Pontypridd town centre from a licensed premises, suitable advice has been given. Officers will continue to monitor.
- The Safety Advisory group which is a multi-agency platform held a meeting in September to discuss events being held across the Borough to the end of 2022. This is required to understand the nature of events and provide appropriate advice from the onset to enable the event to run safely.
- Information was received of some sports grounds selling alcohol pitch side without the required licence. A letter was sent to all clubs across RCT advising of the requirement to have a premises licence or a TEN.
- A joint visit with Trading Standards was conducted to a licensed premises in the Porth area due to allegations of underage sales. This visit was followed by a random visit from SWP. No underage customers were located on the premises.
- Joint visit with SWP to a Beddau licensed premises to check for underage customers being present, no underage found on the premises at that time.
- Officers identified a premises in the Cynon area with an absent DPS. This has now been resolved.
- Monthly meetings are now held with South Wales Police, Trading Standards, Environmental Health and Licensing to discuss any ongoing issues. This is very positive as each Authority has their own perspective on issues. This will continue into the future.
- An officer attended a Gambling conference to understand current concerns within this field.
- A very positive news story is that the Lion Pub in Treorchy won the 'Best Community Pub in Great Britain'. This was open to over 50,000 pubs and the competition was fierce. The reward was prize money of £10,000, which is to be spent on a charity, good cause or local initiative. The owner has decided to donate the winnings to the whole town for Christmas. This will involve paying for the Christmas parade, town loyalty scheme, late night shopping, Santa's grotto every Saturday, and a load more. The owner commented 'We have won this award because of the support we get from our community, so we want to give back to the town'.

The payment of annual fees remains at an expected level. Officers are monitoring and where needed issuing reminder notices and contacting by phone to obtain the payment. This process will continue. The authority has a very robust process to ensure payment is received and will take action such as suspension where necessary. A number of premises have had their licence suspended during this period, which has triggered a reaction and payment from the premises resulting in the suspension being lifted.
