Mae dadansoddiad o geisiadau ar gyfer Hysbysiadau Achlysuron Dros Dro yn dangos bod 30 o drwyddedau personol newydd wedi'u dyrannu a bod nifer y ceisiadau'n parhau i gynyddu gan ein bod ni wedi gallu dechrau cynnal achlysuron yn y gymuned, fel oedd yn digwydd cyn cyfnod y pandemig, ers yr haf. Yn ogystal â hyn, mae nifer y marchnadoedd crefftau sy'n cael eu cynnal yn cynyddu ac mae rhai yn parhau i ddefnyddio'r broses achlysur dros dro os oes problemau yn codi o ran trwydded eiddo.

Rhoddodd y Cyfarwyddwr Iechyd a Diogelwch y Cyhoedd a Gwasanaethau Cymuned wybod bod un cais wedi'i herio ers yr adroddiad diwethaf i'r Pwyllgor, a hynny'n gais i Amrywio Trwydded Eiddo a oedd wedi cael ei wrthod. Nid yw'r ymgeisydd wedi cyflwyno cais am apêl. Doedd dim ceisiadau wedi'u herio yn ystod y cyfnod yma, fodd bynnag, mae yna sawl apêl gan Ymgeiswyr yr Hen Swyddfa Bost (Squares), Food For You a Mountain Ash Stores. Mae'r rhain yn cael eu hystyried ar hyn o bryd. Yn ogystal â hyn, rhoddwyd gwybod yn yr adroddiad diwethaf bod yr apêl ar gyfer cais Chippy Plus yn cael ei ystyried, ond o ganlyniad i drosglwyddo'r drwydded eiddo ar 26 Gorffennaf, 2022, penderfynwyd rhoi gorau i'r apêl.

Cyfeiriodd y Cyfarwyddwr Iechyd a Diogelwch y Cyhoedd a Gwasanaethau Cymuned yr Aelodau at adran 4.3 yn yr adroddiad, lle mae arolygiadau o eiddo a thor rheolau'n cael eu hamlinellu. Cafodd 70 o safleoedd eu harolygu ledled y Fwrdeistref, ac roedd angen cynnal ymweliadau dilynol â nifer ohonyn nhw.

Cafodd yr Aelodau wybod bod gwaith rhagweithiol wedi cael ei gynnal, mae'r gwaith yma'n dangos cynnydd yn lefel cyflawniad ar gyfer eiddo a arolygwyd. Y ffigur erbyn hyn yw 90.66%, o'i gymharu â 89.7% yn ystod y cyfnodau blaenorol. Mae swyddogion yn parhau i weithio gyda'r eiddo yma i sicrhau eu bod nhw'n cydymffurfio.

Cafodd yr Aelodau eu hatgoffa bod ymgyrch 'Gofynnwch am Angela' yn parhau i gael ei hyrwyddo ymhlith eiddo trwyddedig. Mae hyn yn cynrychioli cam cadarnhaol iawn tuag at dawelu meddwl y cyhoedd o ran diogelwch eiddo trwyddedig gan ddangos bod modd i'r cyhoedd fynd at staff am gymorth.

Tynnodd y Cyfarwyddwr sylw at bwysigrwydd cynllun Pubwatch sy'n

parhau i fod yn gryf yn RhCT, gyda chyfarfodydd yn cael eu cynnal ledled y Fwrdeistref. Mae Pubwatch Pontypridd wedi llwyddo i gyrraedd rownd derfynol Gwobrau Pubwatch Cenedlaethol am yr ail flwyddyn yn olynol. Cafodd Cadeirydd y grŵp ei wahodd i Dŷ'r Arglwyddi ar gyfer seremoni wobrwyo.

Yn ogystal â hyn, mae gan eiddo trwyddedig ran i'w chwarae wrth weithio tuag at amcanion trwyddedu a hyrwyddo amcanion trosedd ac anrhefn.

Cynhaliodd y Grŵp Cyngori ar Ddiogelwch Achlysuron, grŵp amlasiantaeth, gyfarfod ym mis Medi i drafod yr achlysuron sy'n cael eu cynnal ledled y Fwrdeistref Sirol hyd at ddiwedd 2022. Mae angen gwneud hyn er mwyn deall natur yr achlysuron a rhoi'r cyngor priodol o'r cychwyn i sicrhau bod yr achlysur yn ddiogel.

- Cynhaliwyd ymweliad ag eiddo trwyddedig ar y cyd â'r Adran Safonau Masnach yn ardal Porth yn dilyn honiadau ynghylch gwerthu nwyddau i bobl dan oed. Yn dilyn yr ymweliad yma, roedd Heddlu De Cymru wedi cynnal ymweliad arall. Nid oedd unrhyw gwsmeriaid dan oed ar y safle.
- Cynhaliwyd ymweliad â safle trwyddedig yn ardal Beddau, ar y cyd â Heddlu De Cymru, i wirio a oedd cwsmeriaid dan oed yn bresennol. Doedd dim unigolion dan oed yn bresennol yn yr eiddo ar y pryd.

Cafodd yr Aelodau wybod am lwyddiant tafarn The Lion yn Nhreorci, a enillodd gwobr 'Tafarn Gymunedol Orau'r Deyrnas Unedig'. Roedd y gystadleuaeth yn agored i dros 50,000 o dafarndai. Bu cryn gystadlu amdani a'r wobwr gyntaf oedd gwobr ariannol gwerth £10,000, sydd i'w rhoi i elusen, achos da neu fenter leol. Fodd bynnag, mae'r perchennog wedi penderfynu rhoi'r enillion i'r dref gyfan ar gyfer y Nadolig.

O ran adennill ffioedd blynyddol, cafodd yr Aelodau wybod bod taliadau ar gyfer ffioedd blynyddol yn parhau i fod ar y lefelau a disgwylir ac mae swyddogion yn monitro'r sefyllfa, gan anfon negeseuon atgoffa a chysylltu â'r unigolion dros y ffôn i adennill y taliad lle bo angen. Yn ogystal â hyn, mae gan yr Awdurdod broses gadarn iawn o ran sicrhau bod y taliad yn cael ei dderbyn a gweithredu os nad yw'n derbyn taliad, trwy atal trwyddedu dros dro lle bo angen. Mae trwyddedau sawl eiddo wedi cael eu hatal dros dro yn ystod y cyfnod yma, sydd wedi arwain at ymateb a thaliad gan yr eiddo.

Minutes of the hybrid meeting of the Licensing Act 2003 held on Monday, 14 November 2022 at 4.30 pm.

8 Declaration of Interest

In accordance with the Council's Code of Conduct, there were no declarations made pertaining to the agenda.

9 Apologies

Apologies of absence were received from County Borough Councillors M. Powell and J. Turner.

10 Human Rights Act 1997 and Crime and Disorder Act

It was **RESOLVED** to note that when Members determine the licensing and registration matters before them, they have a duty not to act in a manner that is incompatible with the convention on Human Rights and the Crime and Disorder Act.

11 Minutes

It was **RESOLVED** to approve the minutes of the 12th July 2022 as an accurate reflection of the meeting.

12 **Review of the Licensing Act 2003 & Gambling Act 2005**

The Director of Public Health, Protection and Community Services provided the Committee with the report on relevant issues with regard to the Licensing Act 2003 and the Gambling Act 2005 for the period 27th June to 16th October 2022, together with ancillary matters arising from the responsibilities charged to the Committee.

An analysis of the TEN's applications indicate 30 new personal licenses that have been allocated and that the number of applications remain on the increase as the summer months have seen a welcome return to events in the community that we used to enjoy pre-covid epidemic. Furthermore, artisan craft markets are increasing in popularity at several venues and premises continue to be able to utilise their temporary event process where there are issues with their premises license.

The Director of Public Health, Protection and Community Services reported that since the last Committee report, there had been one contested application for a Variation of Premises Licence which had been refused and no appeal has been lodged. Also, there were no contested applications to report during this period, however, there are a number of appeals from Applicants at the Old Post Office (Squares), Food For You and Mountain Ash Stores which are currently pending. Furthermore, in the last report, it was reported that the appeal for Chippy Plus was pending but due to a transfer of the premises licence on the 26th July, 2022, this appeal was then abandoned.

The Director of Public Health, Protection and Community Services referred Members to section 4.3 of the report, where the premises inspections and infringements were outlined. In total there has been 70 premises inspected throughout the Borough, a number of which have required follow up visits.

Members learned that the proactive work being conducted has shown an increase in the current performance level for inspected premises which is now at 90.66% compared to 89.7% during the previous reporting period and officers are working continuously with these premises to ensure they become compliant.

Members were reminded that the 'Ask Angela' campaign continues to be promoted among premises which is a very positive step to reassure the public that licensed premises are safe and individuals can approach staff.

The Director highlighted the importance of Pubwatch which remains strong within RCT, with meetings taking place throughout the Borough. In particular, Pontypridd pubwatch has successfully made the National Pubwatch Awards final for the second year whereby the chair of the group was invited to the House of Lords for an awards evening.

It was reported that in relation to the number of complaints received,

these have continued to be problematic and the general behaviour post pandemic is a challenge for many of our communities. Furthermore, Licensing premises have their part to play in working towards licensing objectives and promoting crime and disorder objectives.

It was also reported that the Safety Advisory group which is a multi-agency platform held a meeting in September to discuss events being held across the Borough to the end of 2022 and this is required to understand the nature of events and provide appropriate advice from the onset to enable the event to run safely.

In terms of Complaints, queries and guidance, they have continued during this period and include:

- A joint visit with Trading Standards was conducted to a licensed premises in the Porth area due to allegations of underage sales. This visit was followed by a random visit from SWP. No underage customers were located on the premises.
- Joint visit with SWP to a Beddau licensed premises to check for underage customers being present, no underage found on the premises at that time.

Members were advised of a very positive news story in that the Lion Pub in Treorchy won the 'Best Community Pub in Great Britain'. This was open to over 50,000 pubs and the competition was fierce and the reward was prize money of £10,000, which is to be spent on a charity, good cause or local initiative. However, the owner has decided to donate the winnings to the whole town for Christmas.

In terms of the recovery of annual fees, Members were advised that the payment of annual fees remains at an expected level and officers are monitoring and where needed issuing reminder notices and contacting by phone to obtain the payment. Furthermore, the authority has a very robust process to ensure payment is received and will take action such as suspension where necessary and a number of premises have had their licence suspended during this period, which has triggered a reaction and payment from the premises resulting in the suspension being lifted.

The Director of Public Health, Protection and Community Services referred Members to section 5.1 of the report and provided them with an update in terms of the Gambling Act 2005.

Members took the opportunity to thank the Licensing Team for their continuous hard work and it was **RESOLVED:-**

- 1 To note the contents of the report in respect of the **Licensing Act 2003** and;
- 2 To note the contents of the report in respect of the **Gambling Act 2005**.

Such ancillary matters include the Gambling Act 2005. (There may also be ancillary matters arising from the impact of the Smoke-Free Premises Regulations, which have the potential to affect all licensed premises).

It has once again been a busy period for Officers processing TENs applications. The month of November brought a flurry of applications to extend hours in licensed premises and Clubs for the Football World Cup.

This led into the festive period which saw TENS increase in number to cover activities such as Christmas markets, carol concerts, and the sale of alcohol in non-licensed premises, along with the extension of hours for the retail sector and other licensed premises to trade over the holidays.

An analysis of the TEN's applications indicates, 68 for existing premises licences, 22 for permitted community events and 39 from Private Members Clubs.

A summary of TEN's is reproduced for Members information as **Appendix 1A**.

In accordance with the advice received in respect of data protection matters, the summaries of Personal Licences and Premises Licences issued under delegated authority are now reproduced for information as a Part II restricted item.

4.3 Premises Inspection & Infringements

The relevant Performance indicator for the Licensing Team is "*the premises licences found to be broadly compliant following inspection by Licensing Officers*". Officers will consider confidence in management, compliance with licence conditions and business competency when determining the risk rating of the premises when considering whether they are broadly compliant.

Officers are continuing to inspect premises and are putting much time into this. In total there has been 47 premises inspected throughout the Borough, some of whom have again required follow up visits due to concerns on adherence to their licence.

The proactive work being conducted has shown an increase in the current performance level for inspected premises which is now at **90.38%** compared to 90.66% during the previous reporting period.

Officers are working continuously with these premises to ensure they become compliant.

Officers have visited Mountain Ash Stores on 2 separate occasions to conduct test purchases for alcohol and ensure that they were complying with their suspension. On both occasions there was no alcohol on display and when asked, the member of staff refused any sale. They were complying with their 3-month suspension.

4.4 Complaints, Advice, Guidance & Information

- Two Licensing Officers attended the National Training Conference in Stratford Upon Avon in November 2022, along with the Chair of Licensing Committee Councillor Fox. We were very fortunate to be awarded a free place for one Officer as conference is an important date in the Licensing annual calendar and places are limited. The Officer will now make a presentation to the other members of the Wales Institute of Licensing group on 8th February, to share the experience. All three who attended agreed it was a full conference with plenty of informative sessions.
- Members may have noticed an article in the press relating to a premises in Porth. The premises was subject to enforcement action by South Wales Police resulting in a cannabis factory being discovered. While this has been a concern to the Licensing Authority it should be noted that the premises has not traded for several months, and the Premises Licence has now been surrendered.
- The Tumble area of Pontypridd Town Centre is currently looking a little different with just 4 of the 6 licensed premises trading. The old Players premises on the Broadway has not re-opened yet, despite being Granted a new Premises Licence. The Soul Suite has not re-opened since March 2020 and remains empty, the Premises Licence is still valid.
- A small convenience store was found to be non-compliant as no DPS was employed at the premises, a visit was conducted by Licensing Officers and all alcohol sales were ceased. New owners of the premises applied for a Transfer and Vary DPS application within 3 days, rendering the premises once again compliant.
- The DPS of a premises in the Cynon Valley has been recommended for an award by South Wales Police Licensing Officers. In the early hours of New Year's Eve, the DPS heard shouts of help coming from the nearby river and without a thought for his own safety negotiated a steep ravine and located a male in the water. He then pulled the male out of the water. Police Officers attended shortly after who recovered the male to the police vehicle. The male suffered injuries from being in the cold water and was conveyed to hospital for treatment. It is clear the quick actions from the DPS saved this man's life.
- A late-night premises in Aberdare town centre has opened for the first time since the pandemic. This premises has now closed again for January due to an expectation of a quiet January.
- We have a celebrity taking over a premises in Blaencwm, Martin Roberts from Homes under the Hammer TV programme has bought the pub and the licence is now transferred into his company's name.
- A Vape shop in Aberdare has seen some enforcement action over the past few months, particularly coming to the attention of Trading Standards Officers. Although the shop involved was not a licensed premises, it was attracting youths and school children to the area causing concern to the licensed premises in the area. Trading Standards were successful in obtaining a Closure Notice from the Courts and this premises has now been secured and is unable to re-open for a 3 month period.

- A pre application advice meeting was held with the new occupiers of a premises on Victoria Square, Aberdare. Enquiries prior to this meeting led the Authorities involved to believe the new owners were linked to the premises mentioned above. Concern was expressed during the meeting, there appeared to be a lack of local knowledge or a concern for the promotion of the Licensing Objectives. As a result of the pre application meeting the applicant decided not to submit an application, however the premises is currently open and trading without the sale of alcohol. Trading Standards are continuing to monitor the situation.
- Pubwatch remains strong within RCT, regular meetings continue to take place across the Borough. Support and guidance are offered by Licensing Officers at these meetings and premises are encouraged to attend.
- The Safety Advisory group which is a multi-agency platform held a meeting in early January to discuss the events coming up for the year, many event organisers have been in contact with the group to ensure events in our Borough run safely and legally.
- In the last report Licensing Officers had recently visited a Licensed Premises in Beddau with South Wales Police to check for underage customers being present, none were found on the premises at that time. Since that time a further allegation has been made by a local resident and Officers have visited again. Noncompliance has been identified and Officers from both Licensing and Trading Standards are working with the premises to ensure compliance.
- During the December Pubwatch meeting in Aberdare, licensees and SIA door staff were invited to attend a presentation in relation to safeguarding women. The presentation by South Wales Police focused on vulnerability & violence against women. There was also a discussion about the Ask Angela scheme, due to its relevance to this subject. The meeting was held in the Core Business Solution Centre in Aberdare and was well attended which was positive to see.
- During recent premises inspections in Aberdare town centre, licensees have been complimentary of both the South Wales Police 'After Dark' team and the RCT Community Wardens who are monitoring the PSPO in the area. These positive comments have been fed back to South Wales Police and the Community Safety team.
- Licensing Officers received eleven separate noise complaints about a single licensed premises in Aberaman during November 2022 which resulted in a joint monitoring exercise with Environmental Health Officers on 26th November. Music noise was audible that evening in a nearby residential property. Officers visited the premises that same evening to offer advice and a meeting was held a few days afterwards with the Premises Licence Holder and DPS. The management of the premises took the decision to cease all DJ events and youth discos. Since that time no further complaints have been received.

- A pre application advice meeting has been held at a licensed premises in Pontypridd. The Premises Licence Holder has built a small brewing room within the courtyard area of the pub, in addition to a smoke house and will be renovating the outside area to a high standard to offer his clientele a new experience. Licensing Officers have offered advice and guidance in the application process and made appropriate suggestions to assist in the promotion of the Licensing Objectives.
- A pre application advice meeting has been held at a licensed café style premises in Treorchy. The Premises Licence Holder and DPS wishes to extend the hours she currently trades on an ad hoc basis. This premises has operated in this way for quite some time utilising Temporary Event Notices and by Varying the Premises Licence it should afford the licence holder a greater flexibility.
- Two good news stories came from the Treforest Pubwatch group in January. One licensed premises took an elderly lady in when she had been involved in an accident with a car in the street, they offered her tea and warmth while she waited for an ambulance to arrive. Another licensed premises in the area noticed a male on the street in the cold, took him in to their premises and gave him something warm to eat and a warm drink. The licence holder believes the male lives in the area but was concerned for him that day in the cold weather.

The payment of annual fees remains at an expected level for this time of the year. Licence holders typically delay payment until after Christmas period. Officers are monitoring and where needed issuing reminder notices and contacting by phone to obtain the payment. This process will continue. The authority has a very robust process to ensure payment is received and will take action such as suspension where necessary. Several premises have had their licence suspended during this period, which has triggered a reaction and payment from the premises resulting in the suspension being lifted. Officers have noted that there is an increase in time spent chasing fees for premise licence holders that have left the business, but not surrendered the licence and informed the team accordingly.

7 premises have surrendered their licence during this period, all of which are located in the Rhondda area.
