ADOLYGIAD O DDEDDF TRWYDDEDU 2003 AC O DDEDDF GAMBLO 2005

Cyflwynodd y Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio yr adroddiad i'r Pwyllgor. Roedd yr adroddiad yn trafod materion perthnasol o ran Deddf Trwyddedu 2003 a Deddf Gamblo 2005 ar gyfer y cyfnod rhwng 16 Ionawr 2023 a 31 Mawrth 2023, yn ogystal â materion atodol eraill sy'n deillio o gyfrifoldebau'r Pwyllgor.

Mae dadansoddiad o'r ceisiadau am Hysbysiadau Achlysuron Dros Dro yn nodi bod 21 wedi'u rhoi i safleoedd sydd â thrwydded eisoes, 15 wedi'u rhoi ar gyfer achlysuron yn y gymuned a 18 wedi'u rhoi i glybiau preifat. Mae nifer y ceisiadau am hysbysiadau ddaeth i law yn ystod y cyfnod ychydig yn is nag yr oeddwn nhw dros y Nadolig a'r Flwyddyn Newydd. Ymhellach, mae'n ymddangos bod tuedd i'r rhain gael eu cyflwyno ar gyfer gwerthu alcohol mewn gemau rygbi a chwaraeir mewn clybiau lleol a hefyd marchnadoedd crefftwyr neu ffermwyr sy'n gwerthu alcohol i'w yfed oddi ar y safle. Yn ogystal â hynny, cafodd rhai Hysbysiadau eu cyflwyno gan safleoedd sy'n gwerthu alcohol yn hwyr y nos pan aeth y clociau ymlaen yn y gwanwyn, er mwyn caniatáu i'r safleoedd yma fod agor am yr un nifer o oriau ag arfer.

Dywedodd Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio fod dim penderfyniadau wedi'u herio ers cyflwyno'r adroddiad diwethaf i'r pwyllgor, a bod dim adolygiadau i'w trafod yn ystod y cyfnod yma. Serch hynny, mae'r Hen Swyddfa Bost (Squares) wedi cyflwyno apêl sy'n mynd rhagddo ar hyn o bryd.

Cafodd yr Aelodau eu cyfeirio at adran 4.3 yr adroddiad, lle caiff arolygiadau o safleoedd a thor rheolau eu hamlinellu. Arolygwyd cyfanswm o 46 o safleoedd ledled y fwrdeistref sirol. Roedd angen ymweliadau dilynol ar rai ohonyn nhw oherwydd pryderon ynghylch cydymffurfio â manylion eu trwyddedau.

Clywodd yr Aelodau fod y gwaith rhagweithiol sy'n cael ei gynnal wedi arwain at ychydig o ostyngiad yn y lefel cyflawniad presennol ar gyfer safleoedd a arolygwyd. Mae bellach yn 89.94% o'i chymharu â 90.38% yn ystod y cyfnod adrodd blaenorol. Mae'r swyddogion yn dal ati i gydweithio â'r safleoedd hyn er mwyn sicrhau cydymffurfiaeth.

Dywedodd y Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio y byddai Aelodau'n cofio mater a amlinellwyd mewn adroddiad blaenorol, sef clwb yn ardal Aberaman yn achosi niwsans sŵn i drigolion. Cafodd y broblem ei lliniaru gan Swyddogion Trwyddedu ac lechyd yr Amgylchedd ar ôl ymarfer monitro. Yn anffodus, mae cwynion pellach wedi dod i law, fodd bynnag, mae cyngor wedi'i roi i'r clwb ac ers hynny ni chafwyd unrhyw gŵyn pellach.

Clywodd yr Aelodau fod 2 eiddo trwyddedig (1 yng Nghwm-bach ac 1 yn

Ynys-y-bwl) wedi cael Hysbysiad Cau Adran 19 yn dilyn torri amodau o ran Teledu Cylch Cyfyng. Mae'r safleoedd wedi cydymffurfio â'r Hysbysiadau hyn hyd yma a byddant yn aros yn eu lle hyd nes y cyflawnir cydymffurfiaeth lawn. Wedyn bydd Swyddog yn cynnal ymweliad arall i sicrhau cydymffurfiaeth.

Dywedwyd bod tafarn yn Aberdâr wedi ffonio Heddlu De Cymru yn gofyn am gymorth ynghylch ymgyrch 'GOFYNNWCH AM ANGELA'. Roedd staff wedi gweld dyn yn ceisio cusanu menyw gan wneud iddi deimlo'n anghyfforddus. Mynychodd Heddlu De Cymru a gofyn i'r dyn adael, ac fe wnaeth e hynny. Doedd y cwsmer benywaidd ddim eisiau gwneud cwyn. Mae'r Garfan Drwyddedu

yn dwyn hyn i sylw Aelodau i ddangos bod cynllun Gofynnwch am Angela yn cael ei ddefnyddio ar draws y Fwrdeistref a'i fod yn llwyddo i wneud i bobl agored i niwed deimlo'n fwy diogel tra'u bod yn ymweld â'n safleoedd trwyddedig.

Yn ogystal â hynny, mae clwb aelodau preifat yn ardal Trallwng ym Mhontypridd wedi cael problemau blaenorol gyda chwynion am sŵn ac ymddygiad gwrthgymdeithasol - yn deillio'n bennaf o'i ardal ysmegu. Mae'r Swyddogion Trwyddedu wedi ymweld â'r safle i gynnig cyngor ac arweiniad, ar y cyd â Heddlu De Cymru. Mae Swyddogion Trwyddedu a'r eiddo wedi cytuno i gyflwyno cais Mân Amrywiad i gynnwys TCC yn yr eiddo a'r man ysmegu.

Mae cwynion wedi dod i law drwy aelodau Gwarchod Tafarndai (Pubwatch) Pontypridd bod safle trwyddedig yng nghanol tref Pontypridd yn aros ar agor yn hwyrach na'r hyn a ganiateir. Hefyd, cynhaliwyd ymweliad ar y cyd gan Swyddogion Awdurdod Lleol a Heddlu De Cymru lle nodwyd bod y safle ddim yn cydymffurfio ag amodau'r drwydded ac mae ymchwiliadau pellach yn parhau. Bydd diweddariad am hyn yn yr adroddiad nesaf.

Hysbyswyd yr Aelodau bod Swyddogion Iechyd yr Amgylchedd a Swyddogion Trwyddedu wedi rhoi cyngor ar achlysuron mewn clwb aelodau preifat ym Mhont-y-clun, ac maen nhw wrthi'n ystyried opsiynau o ran newid i Drwydded Safle i sicrhau cydymffurfiaeth â Deddf Trwyddedu 2003 wrth gynnal yr achlysuron dan sylw.

Atgoffwyd yr aelodau bod Heddlu De Cymru a Swyddogion Trwyddedu'r Awdurdod Lleol wedi cynnal ymweliad ar y cyd yn dilyn ymosodiad mewn eiddo trwyddedig ym Mhontypridd a arweiniodd at ymosodiad ar ddau Heddwys y tu allan i'r eiddo. Ymhellach, mae cyngor ac arweiniad llawn wedi'u cynnig i Ddeiliad y Drwydded Safle a'r Goruchwyliwr Penodedig, gyda chynllun gweithredu i'w roi ar waith i wella amodau'r Drwydded Safle gyfredol. Fodd bynnag, roedd y safle'n cyflogi dau aelod o staff drws Awdurdod y Diwydiant Diogelwch ar y noson dan sylw. Mae Deiliad y Drwydded Safle wedi rhoi sicrwydd i'r Awdurdodau na fyddant yn dychwelyd i'r eiddo mewn swydd gyflogedig.

Dywedodd y Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio fod ymchwiliadau parhaus i eiddo sydd â thrwydded hwyr yn ardal y Porth sydd wedi bod yn destun nifer uchel o gwynion sŵn dros y 3 blynedd diwethaf, a bod Swyddogion Iechyd yr Amgylchedd, Swyddogion Trwyddedu a Heddlu De Cymru yn cydweithio ar y mater. Dywedodd hefyd bod disgwyl i'r apêl gael ei gynnal ar 7 Mehefin 2023.

Rhodddwyd gwybod i'r aelodau am gyfarfod cyn ymgeisio sydd wedi'i gynnal yn Swyddfeydd y Cyngor i drafod Trwydded Safle ar gyfer Swyddfa'r Post yng Nghanol Tref Pontypridd. Rhodddwyd cyngor ac arweiniad i'r darpar ymgeisydd mewn perthynas â gwerthu alcohol i'w yfed oddi ar y safle a'r problemau penodol o fewn canol y dref, megis y PSPO, lleoliad asiantaethau a'r economïau yn y dydd a'r nos. Yn ogystal, mae gan yr ymgeisydd posibl nifer o eiddo trwyddedig ac roedd yn gallu dangos i'r Awdurdodau ei fod wedi rhoi ystyriaeth ddyledus i'r Amcanion Trwyddedu, fodd bynnag, nid oes cais wedi'i gyflwyno hyd yma.

Ymhellach, mae cyfarfod cyn ymgeisio wedi'i gynnal mewn perthynas â Chaniatáu Trwydded Safle yng nghanol tref Pontypridd ar gyfer pizzeria Eidalaidd ac fe gynigiodd yr ymgeisydd posibl rywfaint o sicrwydd i'r Awdurdodau ei fod yn awyddus i gydweithio yn y dyfodol. Hefyd, nododd y byddai'r amseroedd y gwnaed cais amdanynt yn bennaf yn ystod y dydd ac yn gynnar gyda'r nos gyda chaniatâd alcohol ar gyfer yfed ar y safle yn unig er mwyn diogelu'r PSPO. Mae'r cais wrthi'n cael ei adolygu.

Roedd yr Aelodau'n falch o glywed newyddion da am Westy'r Wyndham yn y Rhondda sydd wedi derbyn Canmoliaeth Uchel am Y Dafarn a Chlwb Cymdeithasol Gorau 2023 yng Ngwobrau Busnes Cymru. Mae'r dafarn falch iawn o'r cyflawniad hwn yn enwedig gan mai dim ond ers 18 mis y mae'r safle wedi bod ar agor o dan reolaeth newydd.

O ran adennill ffioedd blynyddol, cafodd yr Aelodau wybod bod talu ffioedd blynyddol yn parhau i fod ar y lefel ddisgwyliedig ar gyfer adeg yma'r flwyddyn. Serch hynny, mae deiliaid trwyddedau fel arfer yn gohirio talu tan ar ôl cyfnod y Nadolig.

Yn ogystal â hynny, mae swyddogion wedi bod yn monitro hyn ac yn mynd ar drywydd taliadau a gollwyd, yn dilyn y cynnydd mewn taliadau ym mis Ionawr/Chwefror 2023. Mae gan yr awdurdod broses gadarn iawn i sicrhau y derbynnir taliadau a bydd yn cymryd camau megis ataliad lle bo angen. Mae trwydded sawl safle wedi cael ei gohirio yn ystod y cyfnod hwn, sydd wedi sbarduno ymateb, gyda safleoedd yn gwneud taliad er mwyn cael gwared ar y gohiriad. Mae swyddogion wedi nodi bod cynnydd yn yr amser a dreulir yn mynd ar drywydd ffioedd ar gyfer deiliaid trwydded eiddo sydd wedi gadael y busnes, ond heb ildio'r drwydded a hysbysu'r garfan yn unol â hynny.

Cyfeiriwyd yr Aelodau at adran 5.1 o'r adroddiad ac fe gawson nhw ddiweddariad o ran Deddf Gamblo 2005.

21 DECLARATION OF INTEREST

In accordance with the Council's Code of Conduct, there were no declarations made pertaining to the agenda.

22 HUMAN RIGHTS ACT 1998 AND CRIME AND DISORDER ACT

It was **RESOLVED** to note that when Members determine the licensing and registration matters before them, they have a duty not to act in a manner that is incompatible with the convention on Human Rights and the Crime and Disorder Act.

23 MINUTES

It was **RESOLVED** to approve the minutes of the 6th February 2023 as an accurate reflection of the meeting.

The Head of Service for Public Protection and Regulatory Services provided the Committee with the report on relevant issues with regard to the Licensing Act 2003 and the Gambling Act 2005 for the 16th January 2023 to 31st March 2023, together with ancillary matters arising from the responsibilities charged to the Committee.

An analysis of the TEN's applications indicates, 21 for existing premises licenses, 15 for permitted community events and 18 from Private Members Clubs the number of TEN's submitted for this period has reduced slightly following the Christmas and New Year period. Furthermore, there appears to be a trend for TEN's to be submitted for the sale of alcohol at rugby games played in local clubs and also artisan or farmers markets selling alcohol as an off sale. In addition, a few TEN's submitted from the late-night alcohol premises as a result of the springtime change of hours, to allow them to open for the same number of hours as usual.

The Head of Service for Public Protection and Regulatory Services reported that since the last Committee report, there had been no contested applications and no reviews to report during this period, however, an Appeal had been lodged by the Old Post Office (Squares), Porth which is currently pending.

Members were referred to section 4.3 of the report, where the premises inspections and infringements were outlined. In total there has been 46 premises inspected throughout the Borough, some of whom have again required follow up visits due to concerns on adherence to their licence.

Members learned that the proactive work being conducted has shown an increase in the current performance level for inspected premises which is now at 89.94% compared to 90.38% during the previous reporting period, and officers are working continuously with these premises to ensure they become compliant.

The Head of Service for Public Protection and Regulatory Services reported that Members may recall an issue outlined in a previous report, of a club in the Aberaman area causing a noise nuisance to residents which was alleviated by both Licensing and Environmental Health Officers after a monitoring exercise. Unfortunately, further complaints have been received, however, advice has been given to the club and since then there have been no further complaint.

Members learned that 2 licensed premises (1 in Cwmbach and 1 in Ynysybwl) have had a Section 19 Closure Notice issued following a breach of their CCTV condition, and these Notices have been initially complied with and will stay in place until full compliance is achieved, which an Officer will reinspect to ensure compliance.

It was reported that a pub in Aberdare rang South Wales Police reporting assistance for 'ASK ANGELA', which they had witnessed a male attempt to kiss a female customer making her feel uncomfortable, South Wales Police attended and asked the man to leave, which he did, although the female customer did not want to make a complaint. Furthermore, the Licensing Team

are bringing this to the attention of members to show the Ask Angela scheme is being utilised across the Borough and is successful in making vulnerable people feel safer while in our licensed premises.

In addition, a private members club in the Trallwn area of Pontypridd has previously had issues with noise and anti-social behaviour complaints emanating primarily from its smoking area, whereby the Licensing Officers have visited the premises to offer advice and guidance along with South Wales Police Licensing Officers and as such the premises have agreed to submit a Minor Variation application to include CCTV on the premises and smoking area.

Complaints have been received through Pontypridd Pubwatch members that a licensed premises within Pontypridd town centre is staying open later than permitted. Also, a joint visit was conducted by Local Authority and South Wales Police Officers where it was discovered that there was non-compliance with licence conditions and further investigations are ongoing and will be updated in the next report.

Members were informed that advice has been given by Environmental Health Officers and Licensing Officers for events at a private members club in Pontyclun and they are currently considering options regarding changing to a Premises Licence to ensure compliance with the Licensing Act 2003 when offering these events.

Members were reminded that a joint visit from South Wales Police and Local Authority Licensing Officers was conducted following an assault in a licensed premises in Pontypridd which resulted in two Police Officers being assaulted outside the premises. Furthermore, full advice and guidance have been offered to the Premises Licence Holder and DPS, with an action plan to be put in place to improve the conditions on the current Premises Licence. However, the premises were employing two SIA door staff on the night in question, the Premises Licence Holder has assured the Authorities they will not be returning to the premises in an employed capacity.

The Head of Service for Public Protection and Regulatory Services reported that ongoing investigations into a late-night licensed premises in the Porth area whereby this premises has been the subject of a high number of noise complaints over the last 3 years and joint working from Environmental Health Officers, Licensing Officers, and South Wales Police. Also, that the appeal hearing is due to be heard on 7th June 2023.

Members were advised of a pre application meeting that has been held in the Council Offices for a Premises Licence in the Post Office Pontypridd Town Centre, advice and guidance was given to the potential applicant in relation to Off Sales and the specific issues within the town centre such as the PSPO, the location of agencies and the day and night-time economies. In addition, the potential applicant has a number of licensed premises and was able to show the Authorities he had given due concern to the Licensing Objectives, however, an application has not been submitted to date.

Moreover, a pre application meeting has been held in relation to the Granting of a Premises Licence in Pontypridd town centre for an Italian pizzeria and the potential applicant offered some assurances to the Authorities and would be happy to work with them in the future. Als, he indicated that the times applied for would be mainly for daytime and early evening with an alcohol permission for on sales only to protect the PSPO although an application is pending for this.

Members were pleased to hear that a good news story came from the Wyndham Hotel in the Rhondda which has been awarded Highly Commended for The Best Pub and Social Club 2023 in the Best of Welsh Business Awards, which they are very proud of this achievement especially as they have only been open under new management for 18 months.

In terms of the recovery of annual fees, Members were advised that the payment of annual fees remains at an expected level for this time of the year, however, Licence holders typically delay payment until after Christmas period.

In addition, officers have been monitoring this and chasing payment that can be seen by the increase in payments received in January/February 202, which the authority has a very robust process to ensure payment is received and will take action such as suspension where necessary. Furthermore, several premises have had their licence suspended during this period, which has triggered a reaction and payment from the premises resulting in the suspension being lifted, and officers have noted that there is an increase in time spent chasing fees for premise licence holders that have left the business, but not surrendered the licence and informed the team accordingly.

Members were referred to section 5.1 of the report and provided them with an update in terms of the Gambling Act 2005.

3. BACKGROUND

Members will be aware that a quarterly meeting is convened to review and discuss the implementation and progress of the Licensing Act 2003, together with any ancillary matters arising from responsibilities with which this particular Committee is charged.

Such ancillary matters include the Gambling Act 2005. (There may also be ancillary matters arising from the impact of the Smoke-Free Premises Regulations, which have the potential to affect all licensed premises).

4. **LICENSING ACT 2003**

4.1 **Application Process**

The number of TEN's submitted this period remains steady with a total of 48 received.

We once again see a trend for TEN's to be submitted for the sale of alcohol at rugby games played in local clubs selling alcohol as an off sale.

There have been several events in the community and on licensed premises to mark the King's Coronation. As the Summer months now approach, we are starting to receive TEN's for outdoor festivals such as the Big Welsh Bite.

An analysis of the TEN's applications indicates, 25 for existing premises licences, 18 for permitted community events and 5 from Private Members Clubs.

A summary of TEN's is reproduced for Members information as **Appendix 1A**.

In accordance with the advice received in respect of data protection matters, the summaries of Personal Licences and Premises Licences issued under delegated authority are now reproduced for information as a Part II restricted item.

4.3 Premises Inspection & Infringements

The relevant Performance indicator for the Licensing Team is "*the premises licences found to be broadly compliant following inspection by Licensing Officers*". Officers will consider confidence in management, compliance with licence conditions and business competency when determining the risk rating of the premises when considering whether they are broadly compliant.

The current performance level for inspected premises which is now at 90.15% compared to 89.94% during the previous reporting period.

Officers are working continuously with these premises to ensure they become compliant.

4.4 Complaints, Advice, Guidance & Information

Unfortunately, 2 premises have / or are due to close in the Cynon area:-

- The Mount Pleasant Hotel in Mountain Ash is due to close in June, and the premises is currently up for sale.
- The Cardiff Arms in Hirwaun has closed and is up for sale.

On a positive note, it looks like the Glancynon in Hirwaun will be reopening again later this Summer after being closed for several years.

A private members club in Cwmparc has surrendered their licence.

A pre application meeting was held with the new owners of the premises previously known as the Lighthouse and more recently, Troopers. The new owner indicated that he planned to operate as a wine bar, it is positive to see new businesses opening up.

A premises in Aberdare town centre has received a pre application meeting for an Off Licence, this meeting was a few months ago and since then it is believed the ownership has changed hands. As such, Licensing Officers have offered a further pre application meeting to the new owner. It appears the premises is currently operating primarily as a vape shop.

The Licensing Team along with their colleagues from other Responsible Authorities have attended several pre application meetings recently, for Off Licences, Late Night Refreshment establishments and On Licences, these meetings have been received well overall.

The CAP (Community Alcohol Partnership) Scheme is about to relaunch in Cynon. The scheme is aimed at educating youths about the dangers of alcohol but also preventing the sale of alcohol to underage. The coordinator, Mel Blayney has been in touch to discuss the involvement of Licensing Officers and licensed premises in the Cynon area.

The Rickards, in Treforest is another premises currently for sale, however this is still trading and is the venue for the Treforest and Rhydyfelin Pubwatch group.

A premises in Pontypridd town centre has been served with a Section 19 Closure Notice, due to a lack of CCTV and non-compliance with the conditions. This same premises was found to be trading over two hours after the licence authorises. South Wales Police and the Licensing Authority are in discussion in relation to this premises.

Good News Story:

The King (then Prince) came to Treorchy in June last year to commemorate the town becoming the Champion High Street of Great Britain.

Adrian Emmett, owner of The Lion in Treorchy played a pivotal role in bringing the community together and led the campaign to becoming the Champion High Street. In recognition of his efforts and his ongoing leadership role within the community he was invited to The Kings first Garden Party on Wednesday 3rd May.

Pubwatch:

As members are aware, there are several Pubwatch meetings attended throughout the Borough and Licensing Officers from both Local Authority and South Wales Police attend as invited guests. Most Pubwatch groups are well attended and run with assistance from the Business Crime Reduction Partnership (BCRP) and various BID groups.

Mike Jacklin has been a director of the BCRP for many years, and part of his role was to Co-Ordinate the Pubwatch meetings, Mr Jacklin retired in March this year. A new Pubwatch Co-Ordinator has been appointed and a meeting has been arranged with various parties to discuss new ways of working for the future.

The RCTCBC CCTV team have been attending meeting across the County Borough to offer advice and guidance in relation to Radionet and CCTV issues.
