## **6 ADOLYGIAD O DDEDDF TRWYDDEDU 2003 AC O DDEDDF GAMBLO 2005**

Cyflwynodd Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio yr adroddiad i'r Pwyllgor. Roedd yr adroddiad yn trafod materion perthnasol o ran Deddf Trwyddedu 2003 a Deddf Gamblo 2005 ar gyfer y cyfnod rhwng 1 Ebrill 2023 a 21 Mai 2023, yn ogystal â materion atodol eraill sy'n deillio o gyfrifoldebau'r Pwyllgor.

Mae dadansoddiad o'r ceisiadau am Hysbysiadau Achlysuron Dros Dro yn nodi bod 25 wedi'u rhoi i safleoedd sydd â thrwydded eisoes, 18 wedi'u rhoi ar gyfer achlysuron yn y gymuned a 5 wedi'u rhoi i glybiau preifat. Mae nifer yr Hysbysiadau Achlysuron Dros Dro a gafodd eu cyflwyno yn ystod y cyfnod yma'n parhau i fod yn gyson, sef cyfanswm o 48. Ymhellach, mae'n ymddangos bod tuedd i'r rhain gael eu cyflwyno ar gyfer gwerthu alcohol mewn gemau rygbi a chwaraeir mewn clybiau lleol sy'n gwerthu alcohol i'w yfed oddi ar y safle. Yn ogystal â hynny, mae nifer o achlysuron wedi cael eu cynnal yn y gymuned ac ar safleoedd sydd â thrwydded er mwyn dathlu Coroni'r Brenin. Wrth i fisoedd yr haf agosáu, rydyn ni'n dechrau derbyn Hysbysiadau Achlysuron Dros Dro ar gyfer gwyliau awyr agored megis Cegaid o Fwyd Cymru.

Dywedodd Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio fod dim penderfyniadau wedi'u herio ers cyflwyno'r adroddiad diwethaf i'r pwyllgor, a bod dim adolygiadau i'w trafod yn ystod y cyfnod yma. Serch hynny, roedd yr Hen Swyddfa Bost (Squares), Porth, wedi cyflwyno apêl. Mae'r llysoedd wedi cadarnhau y bydd y gwrandawriad yn cael ei aildrefnu a bydd dyddiad yn cael ei drefnu yn fuan ar gyfer cynnal y gwrandawriad.

Cafodd yr Aelodau eu cyfeirio at adran 4.3 yr adroddiad, lle caiff arolygiadau o safleoedd a thor rheolau eu hamlinellu. Adroddwyd mai'r lefel cyflawniad bresennol ar gyfer safleoedd wedi'u harolygu yw 90.15% ar hyn o bryd, o'i chymharu ag 89.94% yn ystod y cyfnod adrodd blaenorol. Mae swyddogion yn gweithio'n barhaus gyda'r safleoedd yma i sicrhau eu bod nhw'n cydymffurfio.

Cafodd Aelodau wybod bod 2 safle wedi / ar fin cau yn ardal Cwm Cynon, sef Gwesty'r Mount Pleasant yn Aberpennar sydd yn cau ym mis Mehefin ac sydd ar werth ar hyn o bryd, a The Cardiff Arms yn Hirwaun sydd wedi cau ac sydd ar werth.

Rhannodd Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio y newyddion da y bydd tafarn The Glancynon yn Hirwaun yn ailagor eto yn ystod yr haf eleni, a hynny ar ôl bod ar gau ers nifer o flynyddoedd.

Mae clwb preifat yng Nghwm-parc wedi ildio ei drwydded.

Adroddwyd bod cyfarfod cyn cyflwyno cais wedi cael ei gynnal gyda pherchnogion newydd y safle, sef The Lighthouse, ac yna Troopers, yn flaenorol. Rhoddodd y perchennog newydd wybod mai ei fwriad yw gweithredu bar gwin. Mae'n gadarnhaol gweld busnesau newydd yn agor.

Mae safle yng nghanol tref Aberdâr wedi cael cyfarfod cyn cyflwyno cais ar gyfer siop sy'n gwerthu alcohol i'w yfed oddi ar y safle. Cafodd y cyfarfod yma ei gynnal ychydig fisoedd yn ôl ac ers hynny, credir bod perchnogion newydd yno. Mae Swyddogion Trwyddedu wedi cynnig cynnal cyfarfod cyn cyflwyno cais arall i'r perchennog newydd. Mae'n ymddangos bod y safle'n gweithredu'n siop e-sigaréts (vape) ar hyn o bryd.

Cafodd Aelodau wybod bod y Garfan Drwyddedu, ynghyd â chydweithwyr Awdurdodau Cyfrifol eraill, wedi mynychu nifer o gyfarfodydd cyn cyflwyno cais yn ddiweddar, a hynny ar gyfer siopau sy'n gwerthu alcohol i'w yfed oddi ar y safle, safleoedd gwerthu bwyd gyda'r hwyr a safleoedd sy'n gwerthu alcohol i'w yfed ar y safle. Ar y cyfan, mae'r cyfarfodydd yma wedi bod yn boblogaidd.

Adroddwyd bod y Cynllun Partneriaeth Alcohol Gymunedol (CAP) ar fin cael ei ail-lansio yng Nghwm Cynon. Bwriad y cynllun yw addysgu pobl ifainc am beryglon alcohol ac atal safleoedd rhag gwerthu alcohol i bobl o dan 18 oed. Hefyd, mae'r cydlynnydd, Mel Blayney, wedi cysylltu i drafod gwaith Swyddogion Trwyddedu a safleoedd â thrwydded yn ardal Cwm Cynon.

Cafodd Aelodau wybod bod The Rickards yn Nhrefforest yn safle arall sydd ar werth ar hyn o bryd. Serch hynny, mae'r dafarn yn parhau i fasnachu ar hyn o bryd. Dyma leoliad grŵp Pubwatch Trefforest a Rhydfelen.

Cafodd Aelodau wybod am safle yng nghanol tref Pontypridd sydd wedi derbyn Hysbysiad Cau Adran 19 o ganlyniad i ddiffyg teledu cylch cyfyng a pheidio â chydymffurfio â'r amodau. Hefyd, darganfuwyd bod yr un safle yn masnachu dros ddwy awr ar ôl yr hyn sydd wedi'i awdurdodi ar y drwydded. Mae Heddlu De Cymru a'r Awdurdod Trwyddedu yn trafod y safle yma.

Roedd Aelodau'n falch o glywed newyddion da am ymweliad y Brenin (y Tywysog adeg yr ymweliad) â Threorci ym mis Mehefin y llynedd er mwyn dathlu ennill Gwobr Pencampwr Stryd Fawr Prydain Fawr. Chwaraeodd Adrian Emmett, perchennog The Lion yn Nhreorci, rôl hanfodol o ran dod

â'r gymuned at ei gilydd ac arwain yr ymgyrch i ddod yn Bencampwr Stryd Fawr. Er mwyn cydnabod ei ymdrechion a'i rôl arwain barhaus yn y gymuned, cafodd wahoddiad i Barti Gardd cyntaf y Brenin ddydd Mercher 3 Mai.

Cafodd Aelodau eu hatgoffa bod nifer o gyfarfodydd 'Pubwatch' yn cael eu cynnal ledled y Fwrdeistref ac mae Swyddogion Trwyddedu'r Awdurdod Lleol a Heddlu De Cymru yn cael gwahoddiad i fynychu. Yn ogystal â hyn, mae nifer dda yn mynd i'r rhan fwyaf o grwpiau Pubwatch ac maen nhw'n cael eu cynnal gyda chymorth Partneriaeth Lleihau Troseddau Busnes (BCRP) a grwpiau Ardal Gwella Busnes amrywiol. Mae Mike Jacklin wedi bod yn gyfarwyddwr BCRP ers nifer o flynyddoedd. Rhan o'i rôl oedd cydlynu cyfarfodydd Pubwatch. Fe wnaeth Mr Jacklin ymddeol ym mis Mawrth eleni. Mae Cydlynnydd Pubwatch newydd wedi cael ei benodi ac mae cyfarfod wedi'i drefnu gyda phobl amrywiol i drafod ffyrdd newydd o weithio yn y dyfodol.

Adroddwyd bod Carfan Teledu Cylch Cyfyng Cyngor RhCT wedi bod yn mynd i gyfarfodydd ledled y Fwrdeistref Sirol i gynnig cyngor a chymorth mewn perthynas â materion Radionet a theledu cylch cyfyng.

O ran adennill ffioedd blynyddol, cafodd Aelodau wybod bod gan yr Awdurdod broses gadarn iawn er mwyn sicrhau bod taliadau'n cael eu derbyn. Bydd yn cymryd camau gweithredu, megis atal trwydded dros dro, os bydd angen. Mae trwyddedau nifer o safleoedd wedi'u hatal dros dro yn ystod y cyfnod yma. Mae hyn wedi arwain at ymateb a thaliad gan y safleoedd dan sylw, felly mae'r mesurau atal trwydded dros dro wedi cael eu dirymu. O ganlyniad i natur statig y fasnach, does dim llawer o newidiadau i'r sefyllfa. Mae adennill 100% o'r ffioedd blynyddol yn safonol, a hynny'n bennaf oherwydd y darpariaethau cadarn yn y ddeddfwriaeth sy'n rhoi hawl i dynnu'r drwydded yn ôl mewn achosion o beidio â thalu'r ffioedd priodol.

Tynnodd Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio sylw Aelodau at adran 5.1 yr adroddiad a rhoddodd yr wybodaeth ddiweddaraf iddyn nhw am Ddeddf Gamblo 2005.

Cafodd Aelodau grynodedb o ganiatâd presennol mewn perthynas â phroffil masnachu safleoedd â thrywydded.

#### **1 APOLOGIES FOR ABSENCE**

An apology for absence was received from County Borough Councillors S. Powderhill and T. Williams.

#### **2 DECLARATION OF INTEREST**

In accordance with the Council's Code of Conduct, there were no declarations made pertaining to the agenda.

#### **3 HUMAN RIGHTS ACT 1998 AND CRIME AND DISORDER ACT**

It was **RESOLVED** to note that when Members determine the licensing and registration matters before them, they have a duty not to act in a manner that is incompatible with the convention on Human Rights and the Crime and Disorder Act.

#### **4 MINUTES**

It was **RESOLVED** to approve the minutes of the 18<sup>th</sup> April 2023 as an accurate reflection of the meeting.

## **5 PRESENTATION FROM TRADING STANDARDS**

The Committee received a presentation from Mr G. Lewis the Senior Food and Agricultural Standards Officer, in respect of the testing of alcohol in alcohol Premises Licenses in Rhondda Cynon Taf Council, as part of the routinely inspection carried out by the Trading Standards Service.

Members **RESOLVED** to note the presentation.

## **6 REVIEW OF THE LICENSING ACT 2003 & GAMBLING ACT 2005**

The Head of Service for Public Protection and Regulatory Services provided the Committee with the report on relevant issues with regard to the Licensing Act 2003 and the Gambling Act 2005 for the 1<sup>st</sup> April 2023 to 21<sup>st</sup> May 2023, together with ancillary matters arising from the responsibilities charged to the Committee.

An analysis of the TEN's applications indicates, 25 for existing premises licenses, 18 for permitted community events and 5 from Private Members Clubs. The number of TEN's submitted for this period remains steady with a total of 48 received. Furthermore, we once again see a trend for TEN's to be submitted for the sale of alcohol at rugby games played in local clubs selling alcohol as an off sale. In addition, there have been several events in the community and on licensed premises to mark the King's Coronation. Moreover, as the Summer months now approach, we are starting to receive TEN's for outdoor festivals such as the Big Welsh Bite.

The Head of Service for Public Protection and Regulatory Services reported that since the last Committee report, there had been no contested applications and no reviews to report during this period, however, an Appeal had been lodged by the Old Post Office (Squares), Porth whereby confirmation has been received from the courts that the hearing will be relisted and that a future date for the hearing to take place will be arranged shortly.

Members were referred to section 4.3 of the report, where the premises inspections and infringements were outlined. It was reported that the current performance level for inspected premises which is now at 90.15% compared to 89.94% during the previous reporting period and officers are working continuously with these premises to ensure they become compliant.

Members learned that, unfortunately, 2 premises have / or are due to close in the Cynon area namely The Mount Pleasant Hotel in Mountain Ash which is due to close in June, and the premises is currently up for sale, and also The Cardiff Arms in Hirwaun that has closed and is up for sale.

The Head of Service for Public Protection and Regulatory Services

reported that on a positive note, it looks like the Glancynon in Hirwaun will be reopening again later this Summer after being closed for several years.

Furthermore, a private members club in Cwmparc has surrendered their licence.

It was reported that a pre application meeting was held with the new owners of the premises previously known as the Lighthouse and more recently, Troopers., whereby the new owner indicated that he planned to operate as a wine bar, it is positive to see new businesses opening up.

In addition, a premises in Aberdare town centre has received a pre application meeting for an Off Licence, this meeting was a few months ago and since then it is believed the ownership has changed hands. As such, Licensing Officers have offered a further pre application meeting to the new owner. Also, it appears the premises is currently operating primarily as a vape shop.

Members learned that the Licensing Team along with their colleagues from other Responsible Authorities have attended several pre application meetings recently, for Off Licences, moreover, late Night Refreshment establishments and On Licences, these meetings have been received well overall.

It was reported that the CAP (Community Alcohol Partnership) Scheme is about to relaunch in Cynon whereby the scheme is aimed at educating youths about the dangers of alcohol but also preventing the sale of alcohol to underage. Also, the coordinator, Mel Blayney has been in touch to discuss the involvement of Licensing Officers and licensed premises in the Cynon area.

Members were informed that the Rickards, in Treforest is another premises currently for sale, however this is still trading and is the venue for the Treforest and Rhydyfelin Pubwatch group.

Members were advised of a premises in Pontypridd town centre has been served with a Section 19 Closure Notice, due to a lack of CCTV and non-compliance with the conditions. Also, this same premises was found to be trading over two hours after the licence authorises. Furthermore, South Wales Police and the Licensing Authority are in discussion in relation to this premises.

Members were pleased to hear of a good news story that the King (then Prince) came to Treorchy in June last year to commemorate the town becoming the Champion High Street of Great Britain. Moreover, Adrian Emmett, owner of The Lion in Treorchy played a pivotal role in bringing the community together and led the campaign to becoming the Champion High Street. Furthermore, in recognition of his efforts and his ongoing leadership role within the community he was invited to The Kings first

Garden Party on Wednesday 3rd May.

Members were reminded there are several Pubwatch meetings attended throughout the Borough and Licensing Officers from both Local Authority and South Wales Police attend as invited guests. Additionally, most Pubwatch groups are well attended and run with assistance from the Business Crime Reduction Partnership (BCRP) and various BID groups. Furthermore, Mike Jacklin has been a director of the BCRP for many years, and part of his role was to Co-Ordinate the Pubwatch meetings, Mr Jacklin retired in March this year. Also, a new Pubwatch Co-Ordinator has been appointed and a meeting has been arranged with various parties to discuss new ways of working for the future.

It was reported that the RCTCBC CCTV team have been attending meeting across the County Borough to offer advice and guidance in relation to Radionet and CCTV issues.

In terms of the recovery of annual fees, Members were advised that the authority has a very robust process to ensure payment is received and will take action such as suspension where necessary, and that several premises have had their licence suspended during this period, which has triggered a reaction and payment from the premises resulting in the suspension being lifted. Moreover, because of the static nature of the trade, there is little change to the position, where 100% recovery of annual fees is the standard, primarily due to the robust provisions contained within the legislation which allow for withdrawal of the licence/permit for non-payment of appropriate fees.

Permits The Head of Service for Public Protection and Regulatory Services

referred Members to section 5.1 of the report and provided them with an update in terms of the Gambling Act 2005.

#### 3. **BACKGROUND**

Members will be aware that a quarterly meeting is convened to review and discuss the implementation and progress of the Licensing Act 2003, together with any ancillary matters arising from responsibilities with which this Committee is charged.

Such ancillary matters include the Gambling Act 2005. (There may also be ancillary matters arising from the impact of the Smoke-Free Premises Regulations, which have the potential to affect all licensed premises).

#### 4. LICENSING ACT 2003

##### 4.1 Application Process

Applications received since the last update (22<sup>nd</sup> May 2023 to 20<sup>th</sup> August 2023) are as follows:-

The total number of applications have increased significantly during this period and this has been seen most dramatically in the number of TENs processed with a total of 151, as opposed to the 48 during the previous reporting period.

An analysis of the TEN's applications indicates, 49 for existing premises licences, 93 for permitted community events and 9 from Private Members Clubs.

As mentioned last time, TENs were starting to arrive for The Big Welsh Bite and this has continued with more for community events such as the Annual Motorcycle Race in Aberdare, the upcoming Love Treorchy Rhondda Arts Festival along with the smaller community summer fetes and sporting events.

Two premises have utilised the TENs process to allow them to hold licensable activities while they await the outcome of their Premises Licence applications. This process not only helps them in allowing them to trade but also gives the Responsible Authorities an insight into how their premises would operate in the event of their applications being granted.

A summary of TEN's is reproduced for Members information as **Appendix 1A**.

In accordance with the advice received in respect of data protection matters, the summaries of Personal Licences and Premises Licences issued under delegated authority are now reproduced for information as a Part II restricted item.

#### 4.3 Premises Inspection & Infringements

The relevant Performance indicator for the Licensing Team is "*the premises licences found to be broadly compliant following inspection by Licensing Officers*". Officers will consider confidence in management, compliance with licence conditions and business competency when determining the risk rating of the premises when considering whether they are broadly compliant.

The current performance level for inspected premises which is at 90.15%.

#### **4.4 Complaints, Advice, Guidance & Information**

- A Treorchy pub has been offering work experience to pupils from Ysgol Hen Felin, which has been well received within the community. Duties included cleaning up, helping with deliveries, serving customers, and maintaining the plants.
- Allegations of underage sales have been received for two premises within the Rhondda area. Details forwarded to Trading Standards and South Wales Police.
- Due to ongoing noise complaints from residents, further monitoring has been conducted at Squares in partnership with the Environmental Health Team. Officers noted there remains an issue with noise originating from customers of Squares. Details of the continuing issues will be provided within the ongoing appeal process.
- A premises in the Talbot Green area has been the cause of several complaints in relation to music noise. Licensing Officers have been working closely with Environmental Health Officers in an attempt to alleviate the issues. The Environmental Health Pollution Team are now looking into this further.
- Officers have received further complaints relating to a premises in the Llantwit Fardre area, specifically relating to the noise of patrons using the beer garden. Officers are liaising with Environmental Health Officers and monitoring exercises have been conducted.
- A premises in Pontypridd town centre has been issued with a Premises Licence, however due to planning issues, is unable to open fully at present. Licensing and Planning have been giving advice to the business owner.
- The new leaseholders at the Muni in Pontypridd have been in contact with officers for some advice in relation to a Premises Licence. I'm sure we all agree that it will be lovely to see the premises open and trading again. They will request a pre application meeting in a couple of months' time to gain advice from the Responsible Authorities.
- Complaints have been received regarding anti-social behaviour and patron noise from a premises in Cilfynydd. Licensing Officers are working with other Authorities to investigate this complaint. The premises has received a letter from the licensing Authority.
- A late-night premises in Pontypridd town centre has recently been subject to a number of Police incidents, the management of this premises met with officers and SWP licensing Officers to discuss those issues and to confirm future mitigating measures to be put in place.
- Officers have received recent complaints in relation to a licensed premises in the Beddau area. The complaint was in relation to noise from patrons and music, along with refuse being left outside by staff. Licensing Officers spoke to the

owner of the business about the noise complaint, and this has not been an issue since. Environmental Health Officer in the Pollution team are now looking at the refuse issue outside.

- A premises in Pontypridd town centre was issued with a Section 19 Closure Notice in April 2023, this has now been lifted due to compliance with their CCTV conditions.
- A late-night premises has been the subject of several noise complaints over the last 8 weeks, Officers have worked with the premises to alleviate this issue and the local residents have been satisfied with this. The noise was primarily music noise late into the night and early mornings, and the emptying of bottle bins in the early hours. The premises has altered their working practices to ensure this noise ceased.
- A pre application meeting has been held at Ty-Elai for a café business on Aberaman Industrial Estate. Responsible Authority Officers gave advice and guidance to the business owner and expect an application to be submitted in the coming weeks.
- A premises in Treforest has received a letter from the licensing team due to allegations of noise from the beer garden, the premises contacted Officers to explain that the premises is closed at the times alleged but they had fallen out with neighbours recently. No further complaint has been made.
- As members may be aware 'The Lion' pub in Treorchy won the Best Community Pub in Great Britain last year. The good news is that the pub has again been shortlisted this year, highlighting the continued good work being done.
- The Aberdare Music Festival took place on Saturday 19<sup>th</sup> August. Several premises participated, including The Conway Inn, The Bush Inn, Jacs, No.20 Bar, The National Tap, The Prince of Wales, Aberdare Rugby Club, The Bute Arms, Judges & Jury's, The White Lion and The Market Tavern. It appears the event was successful; no complaints have been received within the Licensing Authority.
- Treorchy Food and Drink Festival took place on Saturday 26<sup>th</sup> August. A Temporary Event Notice was provided for the supply of alcohol within the car park area of Treorchy Library.
- The Licensing Authority identified that a well-established premises in the Llantrisant area had fallen foul of licensing legislation, which appeared to be unintentional. The company who was Premises Licence Holder went into liquidation last year, therefore the licence lapsed immediately, however the premises had continued trading. Officers ensured the sales of alcohol ceased immediately, which caused major disruption to the business due to pre-booked weddings. TENs were utilised where possible to assist whilst the premises applied for a new licence.

The authority has a very robust process to ensure payment is received and will take action such as suspension where necessary. Several premises have had their licence suspended during this period, which has triggered a reaction and payment from the premises resulting in the suspension being lifted.
