The Head of Service for Public Protection and Regulatory Services provided Members with the report outlining the most recent enforcement activity, including any prosecution and appeals updates for the period 10<sup>th</sup> July 2023 to 20<sup>th</sup> August 2023.

Members were advised that in the last committee report concerns were raised by the trade that there could be a flood of Wolverhampton licensed vehicles and drivers operating in RCT, and Licensing concerns are that RCT officers have no enforcement powers to deal with these vehicles/drivers. Furthermore, this issue was raised by the Health Protection and Licensing Manager in the Licensing Expert Panel meeting which represents all Local Authorities across Wales, where it was agreed that LAs would monitor the situation.

The Head of Service for Public Protection and Regulatory Services reported that RCT has also submitted a Freedom of Information request that has yet been responded, however, this would be circulated to Committee upon receiving the information. In addition, further concerns are the standard of conditions for Wolverhampton vehicle/drivers compared to those licensed by RCT.
