### 13 **ADOLYGIAD O DDEDDF TRWYDDEDU 2003 AC O DDEDDF GAMBLO 2005**

Cyflwynodd Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio yr adroddiad i'r Pwyllgor. Roedd yr adroddiad yn trafod materion perthnasol o ran Deddf Trwyddedu 2003 a Deddf Gamblo 2005 ar gyfer y cyfnod rhwng 22 Mai 2023 a 20 Awst 2023, yn ogystal â materion atodol eraill sy'n deillio o gyfrifoldebau'r Pwyllgor.

Mae dadansoddiad o'r ceisiadau am Hysbysiadau Achlysuron Dros Dro yn nodi bod 49 wedi'u rhoi i safleoedd sydd â thrwydded eisoes, 93 wedi'u rhoi ar gyfer achlysuron yn y gymuned a 9 wedi'u rhoi i glybiau preifat. Cafodd yr Aelodau eu hatgoffa bod Hysbysiadau Achlysuron Dros Dro yn dechrau cyrraedd ar gyfer Cegaid o Fwyd Cymru ac mae hyn wedi parhau gyda rhagor ar gyfer achlysuron yn y gymuned megis y Ras Beiciau Modur Flynyddol yn Aberdâr, Caru Treorci, Gŵyl Gelfyddydau Cwm Rhondda, ynghyd â ffeiriau haf llai ac achlysuron chwaraeon yn y gymuned. Ar ben hynny, mae dau leoliad wedi defnyddio Hysbysiadau Achlysuron Dros Dro i'w caniatáu i gynnal gweithgareddau sydd angen trwydded tra'u bod nhw'n aros am ganlyniad eu ceisiadau am Drwydded Safle. Yn ogystal, mae'r broses yma nid yn unig yn eu caniatáu nhw i fasnachu ond hefyd yn rhoi cipolwg i'r Awdurdodau Cyfrifol ar sut y byddai eu safleoedd yn gweithredu pe bai eu ceisiadau'n cael eu cymeradwyo.

Dywedodd Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio fod dim penderfyniadau wedi'u herio ers cyflwyno'r adroddiad diwethaf i'r pwyllgor, a bod dim adolygiadau i'w trafod yn ystod y cyfnod yma. Serch hynny, mae'r Hen Swyddfa Bost (Squares) wedi cyflwyno apêl sy'n mynd rhagddo ar hyn o bryd.

Cafodd yr Aelodau eu cyfeirio at adran 4.3 yr adroddiad, lle caiff arolygiadau o safleoedd a thor rheolau eu hamlinellu. Cafodd ei nodi taw 90.15% yw'r lefel cyflawni presennol ar gyfer safleoedd wedi'u harolygu.

Roedd yr Aelodau'n falch o glywed bod tafarn yn Nhreorci wedi bod yn cynnig profiad gwaith i ddisgyblion Ysgol Hen Felin, rhywbeth y mae'r gymuned wedi'i groesawu. Roedd y dyletswyddau'n cynnwys glanhau, helpu gyda derbyn nwyddau, gwasanaethu cwsmeriaid, a chynnal a chadw'r planhigion.

Heblaw hynny, mae honiadau o werthu nwyddau i bobl dan oed wedi dod i law ar gyfer dau eiddo yn ardal Cwm Rhondda. Mae manylion wedi'u hanfon at yr adran Safonau Masnach a Heddlu De Cymru.

Dywedodd Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio bod monitro mwy manwl wedi'i gynnal yng nghlwb nos Squares gyda Charfan Iechyd yr Amgylchedd, oherwydd cwynion parhaus am sŵn gan breswylwyr. Yn ogystal, nododd swyddogion fod yna broblem o hyd gyda

sŵn yn dod o gwsmeriaid Squares a bydd manylion y problemau sy'n parhau yn cael eu rhannu yn unol â'r broses apelio barhaus.

Cafodd yr Aelodau wybod bod safle yn ardal Tonysguboriau wedi bod yn destun nifer o gwynion mewn perthynas â sŵn cerddoriaeth a bod Swyddogion Trwyddedu wedi bod yn gweithio'n agos gyda Swyddogion Iechyd yr Amgylchedd mewn ymgais i leddfu'r problemau. Hefyd, mae Carfan Llygredd adran Iechyd yr Amgylchedd bellach yn ymchwilio i hyn yn fwy manwl.

Cafodd ei adrodd bod swyddogion wedi derbyn rhagor o gwynion yn ymwneud ag eiddo yn ardal Llanilltud Faerdref, yn benodol yn ymwneud â sŵn cwsmeriaid yn defnyddio'r ardd gwrw. Mae swyddogion mewn cyswllt â Swyddogion Iechyd yr Amgylchedd ac mae ymarferion monitro wedi'u cynnal.

Clywodd yr Aelodau fod adeilad yng nghanol tref Pontypridd wedi cael Trwydded Safle, ond oherwydd problemau'n ymwneud â chynllunio, does dim modd iddo agor yn llawn ar hyn o bryd. Mae Trwyddedu a Chynllunio wedi bod yn rhoi cyngor i berchennog y busnes.

Yn ogystal, mae'r lesddeiliaid newydd yn y Miwni ym Mhontypridd wedi bod mewn cysylltiad â swyddogion i gael rhywfaint o gyngor mewn perthynas â Thrwydded Safle. Rydw i'n siŵr ein bod ni i gyd yn cytuno y bydd yn hyfryd gweld y lleoliad yn agor ac yn masnachu eto. Hefyd, maen nhw'n mynd i ofyn am gyfarfod cyn cyflwyno cais ymhen ychydig fisoedd i gael cyngor gan yr awdurdodau cyfrifol.

Mynegodd Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio bryderon ynghylch cwynion sydd wedi dod i law am ymddygiad gwrthgymdeithasol a sŵn cwsmeriaid o eiddo yng Nghilfynydd ac mae Swyddogion Trwyddedu yn gweithio gydag awdurdodau eraill i ymchwilio i'r gŵyn yma. Yn ogystal, mae'r eiddo wedi derbyn llythyr gan yr awdurdod trwyddedu.

Clywodd yr Aelodau bod yr heddlu wedi ymateb i sawl digwyddiad ar safle sy'n gweithredu'n hwyr y nos yng nghanol tref Pontypridd yn ddiweddar. Cafodd cyfarfod rhwng rheolwyr y safle, Swyddogion y Cyngor a Swyddogion Trwyddedu Heddlu De Cymru ei gynnal i drafod y problemau ac i gadarnhau mesurau i'w rhoi ar waith yn y dyfodol i leddfu'r broblem

Cafodd ei adrodd bod Swyddog wedi derbyn cwynion yn ddiweddar yn ymwneud â sŵn cwsmeriaid a cherddoriaeth mewn perthynas ag eiddo trwyddedig yn ardal Beddau, yn ogystal â gwastraff yn cael ei adael y tu allan gan staff. Siaradodd Swyddogion Trwyddedu â pherchennog y busnes am y gŵyn sŵn, a dyw hyn ddim wedi bod yn broblem ers hynny. Mae Swyddog Iechyd yr Amgylchedd yn y garfan Llygredd bellach yn ymchwilio i'r mater o sbwriel y tu allan.

Yn ogystal, rhoddwyd Hysbysiad Cau Adran 19 i eiddo yng nghanol tref

Pontypridd ym mis Ebrill 2023, ac mae hwn bellach wedi'i dynnu'n ôl oherwydd cydymffurfiaeth â'u hamodau teledu cylch cyfyng.

Ar ben hynny, safle sy'n gweithredu'n hwyr y nos wedi bod yn destun nifer o gwynion sŵn dros yr 8 wythnos diwethaf. Mae Swyddogion wedi gweithio gyda'r eiddo i leddfu'r problemau yma ac mae'r trigolion lleol wedi bod yn fodlon gyda hyn. Sŵn cerddoriaeth yn hwyr yn y nos ac yn gynnwys yn y bore oedd y sŵn yn bennaf, a gwagio biniau poteli yn yr oriau mân. Mae'r eiddo hefyd wedi newid eu harferion gwaith i sicrhau fod y sŵn yma'n dod i ben.

Clywodd yr aelodau fod cyfarfod cyn cyflwyno cais wedi'i gynnal yn Nhŷ-Elái ar gyfer caffi ar Ystâd Ddiwydiannol Aberaman. Rhoddodd swyddogion yr awdurdod cyfrifol gyngor ac arweiniad i berchennog y busnes ac maen nhw'n disgwyl i gais gael ei gyflwyno yn yr wythnosau nesaf.

Cymerodd sawl eiddo ran, gan gynnwys The Conway Inn, The Bush Inn, Jacs, No.20 Bar, The National Tap, The Prince of Wales, Clwb Rygbi Aberdâr, The Bute Arms, Judges & Jury's, The White Lion a The Market Tavern, ac mae'n ymddangos bod y digwyddiad wedi bod yn llwyddiannus. Dderbyniodd yr Awdurdod Trwyddedu dim cwynion.

Yn ogystal, cafodd Gŵyl Bwyd a Diod Treorci ei chynnal ddydd Sadwrn 26 Awst. Rhoddwyd Hysbysiad Digwyddiad Dros Dro ar ei chyfer er mwyn gwerthu alcohol ym maes parcio Llyfrgell Treorci.

Clywodd yr Aelodau fod yr Awdurdod Trwyddedu wedi nodi bod safle sydd wedi'i hen sefydlu yn ardal Llantrisant wedi mynd yn groes i ddeddfwriaeth drwyddedu. Roedd yn ymddangos yn weithred anfwriadol. Aeth y cwmni oedd yn ddeiliad Trwydded y Safle i'r wal y llynedd, felly daeth y drwydded i ben ar unwaith, ond roedd masnachu ar y safle wedi parhau. Yn ogystal, sicrhodd Swyddogion fod gwerthu alcohol yn dod i ben ar unwaith. Achosodd hynny aflonyddwch mawr i'r busnes yn sgil priodasau a oedd wedi'u trefnu'n barod ymlaen llaw. Defnyddiwyd Hysbysiadau Achlysuron Dros Dro lle'r oedd hynny'n bosibl i gynorthwyo tra bod y safle'n gwneud cais am drwydded newydd.



O ran adennill ffioedd blynyddol, cafodd Aelodau wybod bod gan yr Awdurdod broses gadarn iawn er mwyn sicrhau bod taliadau'n cael eu derbyn. Bydd yn cymryd camau gweithredu, megis atal trwydded dros dro, os bydd angen. Mae trwyddedau nifer o safleoedd wedi'u hatal dros dro yn ystod y cyfnod yma. Mae hyn wedi arwain at ymateb a thaliad gan y safleoedd dan sylw, felly mae'r mesurau atal trwydded dros dro wedi cael eu dirymu. O ganlyniad i natur statig y fasnach, does dim llawer o newidiadau i'r sefyllfa. Mae adennill 100% o'r ffioedd blynyddol yn safonol, a hynny'n bennaf oherwydd y darpariaethau cadarn yn y ddeddfwriaeth sy'n rhoi hawl i dynnu'r drwydded yn ôl mewn achosion o beidio â thalu'r ffioedd priodol.

Cyfeiriodd Pennaeth Diogelu'r Cyhoedd a Gwasanaethau Rheoleiddio yr Aelodau at adran 5.1 yr adroddiad a rhannodd yr wybodaeth ddiweddaraf gyda nhw o ran Deddf Gamblo 2005.

Cafodd Aelodau grynodedb o ganiatâd presennol mewn perthynas â phroffil masnachu safleoedd â thrwydded.

It was **RESOLVED** to note that when Members determine the licensing and registration matters before them, they have a duty not to act in a manner that is incompatible with the convention on Human Rights and the Crime and Disorder Act.

## **12 MINUTES**

It was **RESOLVED** to approve the minutes of the 6<sup>th</sup> June 2023 as an accurate reflection of the meeting.

## 13 REVIEW OF THE LICENSING ACT 2003 & GAMBLING ACT 2005

The Head of Service for Public Protection and Regulatory Services provided the Committee with the report on relevant issues with regard to the Licensing Act 2003 and the Gambling Act 2005 for the 22<sup>nd</sup> May 2023 to 20<sup>th</sup> August 2023, together with ancillary matters arising from the responsibilities charged to the Committee.

An analysis of the TEN's applications indicates, 49 for existing premises licenses, 93 for permitted community events and 9 from Private Members Clubs. Member were reminded that TENs were starting to arrive for The Big Welsh Bite and this has continued with more for community events such as the Annual Motorcycle Race in Aberdare, the upcoming Love Treorchy Rhondda Arts Festival along with the smaller community summer fetes and sporting events. Furthermore, two premises have utilised the TENs process to allow them to hold licensable activities while they await the outcome of their Premises License applications. In addition, this process not only helps them in allowing them to trade but also gives the Responsible Authorities an insight into how their premises would operate in the event of their applications being granted.

The Head of Service for Public Protection and Regulatory Services reported that since the last Committee report, there had been no contested applications and no reviews to report during this period, however, an Appeal had been lodged by the Old Post Office (Squares), Porth which is currently pending.

Members were referred to section 4.3 of the report, where the premises inspections and infringements were outlined. It was reported that the current performance level for inspected premises which is at 90.15%.

Members were pleased to hear that a Treorchy pub has been offering work experience to pupils from Ysgol Hen Felin, which has been well received within the community, and duties included cleaning up, helping with deliveries, serving customers, and maintaining the plants.

Furthermore, allegations of underage sales have been received for two premises within the Rhondda area. Details forwarded to Trading Standards and South Wales Police.

The Head of Service for Public Protection and Regulatory Services reported that due to ongoing noise complaints from residents, further monitoring has been conducted at Squares in partnership with the Environmental Health Team. In Addition, officers noted there remains an issue with noise originating from customers of Squares and details of the continuing issues will be provided within the ongoing appeal process.

Members were advised that a premises in the Talbot Green area has been the cause of several complaints in relation to music noise and

Licensing Officers have been working closely with Environmental Health Officers in an attempt to alleviate the issues. Also, the Environmental Health Pollution Team are now looking into this further.

It was reported that officers have received further complaints relating to a premises in the Llantwit Fardre area, specifically relating to the noise of patrons using the beer garden and that officers are liaising with Environmental Health Officers and monitoring exercises have been conducted.

Members learnt that a premises in Pontypridd town centre has been issued with a Premises Licence, however due to planning issues, is unable to open fully at present. Licensing and Planning have been giving advice to the business owner.

Additionally, the new leaseholders at the Muni in Pontypridd have been in contact with officers for some advice in relation to a Premises Licence and I'm sure we all agree that it will be lovely to see the premises open and trading again. Also, they will request a pre application meeting in a couple of months' time to gain advice from the Responsible Authorities.

The Head of Service for Public Protection and Regulatory Services expressed concerns regarding Complaints that have been received regarding anti-social behaviour and patron noise from a premises in Cilfynydd and Licensing Officers are working with other Authorities to investigate this complaint. Furthermore, The premises has received a letter from the licensing Authority.

Members were advised of a late-night premises in Pontypridd town centre has recently been subject to a number of Police incidents, the management of this premises met with Officers and SWP licensing Officers to discuss those issues and to confirm future mitigating measures to be put in place.

It was reported that an Officer has received recent complaints in relation to a licensed premises in the Beddau area whereby the complaint was in relation to noise from patrons and music, along with refuse being left outside by staff. In addition, Licensing Officers spoke to the owner of the business about the noise complaint, and this has not been an issue since, and the Environmental Health Officer in the Pollution team are now looking at the refuse issue outside.

In addition, a premises in Pontypridd town centre was issued with a Section 19 Closure Notice in April 2023, this has now been lifted due to compliance with their CCTV conditions.

Furthermore, a late-night premises has been the subject of several noise complaints over the last 8 weeks, Officers have worked with the premises to alleviate this issue and the local residents have been satisfied with this. Moreover, the noise was primarily music noise late into the night and

early mornings, and the emptying of bottle bins in the early hours. Also, the premises has altered their working practices to ensure this noise ceased.

Members learned that a pre application meeting has been held at Ty-Elai for a café business on Aberaman Industrial Estate and responsible Authority Officers gave advice and guidance to the business owner and expect an application to be submitted in the coming weeks.

It was reported that a premises in Treforest has received a letter from the licensing team due to allegations of noise from the beer garden, the premises contacted Officers to explain that the premises is closed at the times alleged but they had fallen out with neighbours recently. No further complaint has been made.

Furthermore, Members may be aware 'The Lion' pub in Treorchy won the Best Community Pub in Great Britain last year and the good news is that the pub has again been shortlisted this year, highlighting the continued good work being done.

The Head of Service for Public Protection and Regulatory Services give a mention to the Aberdare Music Festival took place on Saturday 19<sup>th</sup> August. Several premises participated, including The Conway Inn, The Bush Inn, Jacs, No.20 Bar, The National Tap, The Prince of Wales, Aberdare Rugby Club, The Bute Arms, Judges & Jury's, The White Lion and The Market Tavern, and it appears the event was successful; no complaints have been received within the Licensing Authority.

Additionally, the Treorchy Food and Drink Festival took place on Saturday 26<sup>th</sup> August whereby a Temporary Event Notice was provided for the supply of alcohol within the car park area of Treorchy Library.

Members learned that the Licensing Authority identified that a well-established premises in the Llantrisant area had fallen foul of licensing legislation, which appeared to be unintentional. Also, the company who was Premises Licence Holder went into liquidation last year, therefore the licence lapsed immediately, however the premises had continued trading. In addition, Officers ensured the sales of alcohol ceased immediately, which caused major disruption to the business due to pre-booked weddings, and TENs were utilised where possible to assist whilst the premises applied for a new licence.

In terms of the recovery of annual fees, Members were advised that the authority has a very robust process to ensure payment is received and will take action such as suspension where necessary, and also, several premises have had their licence suspended during this period, which has triggered a reaction and payment from the premises resulting in the suspension being lifted. In addition, because of the static nature of the trade, there is little change to the position, where 100% recovery of annual fees is the standard, primarily due to the robust provisions

contained within the legislation which allow for withdrawal of the licence/permit for non-payment of appropriate fees.

The Head of Service for Public Protection and Regulatory Services referred Members to section 5.1 of the report and provided them with an update in terms of the Gambling Act 2005.

Furthermore, Members were provided a summary of existing permissions in relation to Trade profile Gambling.

#### 3. **BACKGROUND**

Members will be aware that a quarterly meeting is convened to review and discuss the implementation and progress of the Licensing Act 2003, together with any ancillary matters arising from responsibilities with which this Committee is charged.

Such ancillary matters include the Gambling Act 2005. (There may also be ancillary matters arising from the impact of the Smoke-Free Premises Regulations, which have the potential to affect all licensed premises).

#### 4. **LICENSING ACT 2003**

##### 4.1 **Application Process**

Applications received since the last update (**21<sup>st</sup> August 2023 to 26<sup>th</sup> November 2023**) are as follows:-

It remains a busy time amongst the team with a rise in transfer, Vary DPS and Minor Variation applications some of which will have been the outcome of infringements picked up by the Officers during licensing inspections.

The TENs applications remain at a high level which can be expected at this time of the year. As we ended August, the food festivals which utilised the temporary permissions for the sale of alcohol gave way to Halloween discos, firework events and currently, Christmas fayres and extension of hours on licensed premises. These seasonal events are in addition to the typical TENs we receive throughout the year for fund raising and sporting activities.

An analysis of the TEN's applications indicates, 45 for existing premises licences, 54 for permitted community events and 15 from Private Members Clubs.

A summary of TEN's is reproduced for Members information as **Appendix 1A**.

**In accordance with the advice received in respect of data protection matters, the summaries of Personal Licences and Premises Licences issued under delegated authority are now reproduced for information as a Part II restricted item.**

### **4.3 Premises Inspection & Infringements**

The relevant Performance indicator for the Licensing Team is "*the premises licences found to be broadly compliant following inspection by Licensing Officers*". Officers will consider confidence in management, compliance with licence conditions and business competency when determining the risk rating of the premises when considering whether they are broadly compliant.

The current performance level for inspected premises which is at 90%.

### **4.4 Complaints, Advice, Guidance & Information**

#### Cynon

A pub in Mountain Ash recently came to the attention of the team due to the unnecessary behaviour of the owner towards an Environmental Health Officer while trying to conduct her duties. The male was described as obstructive and abusive and appeared to be drunk, as a result the Officer felt it necessary to leave the premises and return at a later date. Licensing Officers spoke to the DPS of the premises the following day and it was confirmed that she was retiring the following week however, the owner of the premises had been problematic. Both Local Authority and South Wales Police Licensing Officers have visited the premises and offered advice to the new DPS, particularly in line with the serving of alcohol to a person who is drunk.

Another premises in Mountain Ash was reported to the team in relation to a large amount of waste building materials being left outside by the owner of the premises causing a potential fire risk and blocking the commercial premises next door's fire exit. Following some joint working with South Wales Fire Service and the premises owner, the waste has been removed and is no longer a fire risk.

Allegations of drug use both inside and outside an off-licence premises in the Penywaun area were received in October which resulted in a visit from Licensing Officers from both South Wales Police and the Local Authority. No evidence of drug use was witnessed but the DPS was notably absent. The sale of alcohol was ceased following this visit and a week later a new application was received to Vary the DPS.

### Rhondda

The Licensing team received allegations of the PLH & DPS of a pub in Treherbert being aggressive to customers whilst intoxicated. There were also allegations about the general condition and maintenance of the building, which resulted in a visit from both Licensing and Environmental Health Officers in October, where full advice was given. A warning letter also followed this visit.

A pub in the Maerdy area was alleged to have constructed a beer garden to the rear of the premises resulting in noise and anti-social behaviour from the patrons being heard in gardens of neighbouring properties. Officers spoke with the owner of the pub and the situation was carefully monitored, there has been no further contact from the complainant.

A pub premises in the Tonyrefail area was alleged to be operating in the beer garden area to the front of the premises resulting in a number of noise complaints. Licensing Officers had previously worked with this premises and complaints were no longer being received. Following further investigation, the pub had changed hands and a new DPS had taken over without varying the Premises Licence or transferring the licence. Suitable advice and guidance were provided, and this matter is now in order.

A Rugby club in the Rhondda has been in touch for clarification on the legislation around children being on the premises and full guidance was given. It was particularly pleasing that this premises got in touch due in view of previous non-compliance over the past year or so. Partnership working between the licensing team and licensed premises is so important and it is always positive when this happens.

An Off Licence premises in the Porth area was subject to a complaint from another local business owner in respect of off sales and trading past authorised times. Licensing Officers conducted a full premises inspection during which the allegations could not be substantiated, however other non-compliance was identified. Advice was given to the premises licence holder and DPS who are working towards compliance and a further visit will be conducted in due course.

A noise complaint from a local resident was received in relation to bottle bins being emptied at 6.23 and 6.30am. Officers spoke to the premises licence holders who subsequently changed the collection times.

A pre application meeting has been held with a rugby club in the Rhondda area wishing to apply for a Premises Licence for their rugby field (not a Local Authority owned pitch), advice and guidance was given by the Responsible Authorities and an application is thought to be forthcoming.

Continued complaints have been received by a local resident regarding a pub in the Treorchy area. The complaints have ranged from customer noise in the beer garden, opening beyond permitted hours, light nuisance and anti-social behaviour. The PLH has been contacted on several occasions and a number of visits were made by officers, including a full inspection. The conditions of licence are now being adhered with, and any further allegations of noise nuisance and anti-social behaviour will be considered by Environmental Health and South Wales Police respectively.

A licensed premises in the Clydach area has been subject to several complaints, including underage sales and noise nuisance from an event held in September. The allegations were also that the management of the premises were rude on the day of the event when a local resident complained directly to them – this resulted in a complaint to the licensing team. Despite joint efforts from licensing officers, Environmental Health Officers and South Wales Police, the DPS of the premises has been unable to meet with officers to discuss this. The premises will continue to be contacted.

A Club premises in the Pentre area was subject to a noise complaint, following an advice letter being sent the complaints have ceased.

A pub in the Gelli area has been contacted by Officers in relation to a noise complaint, this complaint was strongly refuted by the Premises Licence Holder and complaints have ceased.

A Club premises in Ynyshir was contacted following a complaint in relation to their barrel delivery before 7am. The Club will endeavour to ensure this doesn't happen again.

### Taff

An Off Licence premises in Glyncoch was found to be trading with no DPS resulting in alcohol sales being ceased by Officers. The premises had been sold to a new owner, but no transfer application had been submitted. Suitable advice was provided, and the premises is now compliant.

An incident in the beer garden of a pub in Church Village is still under investigation, a female threw a glass at another female which resulted in her needing stitches to her face. Licensing Officers from South Wales Police and Local Authority visited the premises and spoke to the DPS who even though had just taken up the position, had worked at the premises for several years. Authorities were satisfied the pub had acted appropriately and there were no licensing issues to report.

A golf club in the Taff area received advice from licensing officers in respect of a fireworks event. This was to be the first fireworks event held at this premises and the advice was well received, a recent communication from the golf club was received thanking officers for their help and declaring the event a success.

Advice and guidance were requested from a general store in Llantrisant, who wish to apply for a Premises Licence. Full advice was given and a pre application meeting was recommended.

Pontypridd Library have been in touch with licensing officers for advice in relation to small music events in the library. Advice has been given regarding deregulation and the TEN process.

Much work has been undertaken at an established licensed premises in Pontyclun, this premises has been given a complete refit and has resulted in a new application being submitted due to the changes in the layout of the building and the management structure. The premises is hopefully reopening in December in time for Christmas after being closed for many years.

A Club premises in Pontypridd town centre has contacted the licensing team for advice in relation to extending their opening times, they currently operate until 23:00. Advice was given regarding TEN's and the Full Variation process.

A pre application meeting was conducted for an existing late night refreshment premises in Pontypridd town centre, officers from the Licensing Authority and South Wales Police attended. The licence holder initially asked for advice to stay open until 5am, this was met with concern from the Responsible Authorities, he is considering the advice given.

Licensing Officers met with a premises in the Hawthorn area who wish to put on a music event next summer in their large car park. The organisation so far has been positive, showing promotion of the licensing objectives. The Licensing Officer has requested a meeting with the Event Safety Advisory Group as soon as possible to enable to licence holder to plan ahead.
