Cafodd y rhain eu hehangu yn 2011 i gyflwyno parthau gwahardd er mwyn rheoli masnachu ar y stryd o fewn radiws o 500 metr i Ysgol Sirol Cymuned y Porth ac Ysgol Gyfun Treorci.

Cafodd y cynllun ei gyflwyno yn wreiddiol yn dilyn cwynion am fasnachwyr bwyd heb eu cofrestru, arferion hylendid bwyd gwael, sbwriel a phroblemau o ran aroglau ym Mhontypridd. Hefyd, penderfynwyd ehangu'r darpariaethau i ardaloedd o amgylch ysgolion yn dilyn pryderon a godwyd gan yr Heddlu ynghylch masnachwyr stryd yn rhwystro palmentydd ac yn achosi peryglon o ran y traffig a hefyd gan fod Penaethiaid wedi codi pryderon bod y gwerthwyr yn cynnig bwydydd braster uchel a oedd yn tanseilio ymdrechion yr Awdurdod i wella diet pobl ifainc.

Nodwyd bod Adran 3 o Ddeddf Llywodraeth Leol (Darpariaethau Amrywiol) 1982 yn caniatáu i'r Cyngor fabwysiadu Atodlen 4 o'r Ddeddf, sy'n datgan 'A district Council may by resolution designate any street in their district as a prohibited street, a licence street, or a consent street'.

Yn rhan o adroddiad i'r Pwyllgor Trwyddedu ar 5 Mehefin 2007, cafodd yr Aelodau wybod y cyfeiriwyd at gyfarfod a gynhaliwyd ar 12 Mawrth 2007 lle trafodwyd adroddiad oedd yn amlinellu'r opsiynau a bod yr holl opsiynau yn cael eu hystyried, a phenderfynwyd mai'r caniatâd mwyaf hyblyg ac addas oedd strydoedd caniatâd.

Yn ogystal â hyn, cynhaliwyd cyfarfod ar 12 Mawrth 2007 a phenderfynwyd er nad oes hawl i apelio yn erbyn penderfyniad i wrthod rhoi/adnewyddu neu ddirymu caniatâd o'r fath, ei bod yn arfer da ac yn cydymffurfio â'r Confensiwn Hawliau Dynol i gynnig darpariaeth o'r fath. Felly bydd ymgeiswyr tramgwyddedig yn cael cyfreithiadau i gyflwyno sylwadau i'r Pwyllgor Trwyddedu.

Cafodd Aelodau wybod y cynigir nad yw'r darpariaethau masnachu ar y stryd yn gyfyngedig i werthwyr bwyd yn unig; mae'n berthnasol i fathau eraill o weithgareddau masnachu ar y stryd. Mae rhestr o weithgareddau eithriedig, nad ydyn nhw'n cael eu hystyried yn weithgareddau Masnachu ar y Stryd wedi'i chynnwys yn yr adroddiad. Yn ogystal â hyn, mae 88 o fasnachwyr bwyd symudol wedi cofrestru gyda Chyngor RhCT (adeg ysgrifennu'r cofnodion yma), felly nid yw hyn o reidrwydd yn golygu bod pob un o'r 88 yn masnachu yn RhCT. Yn yr un modd, mae'n bosibl y bydd rhai masnachwyr bwyd symudol wedi cofrestru gydag awdurdodau lleol eraill ond yn masnachu yn RhCT. At hynny, mae yna ffi sy'n gysylltiedig â'r broses o roi caniatâd i fasnachu, ac mae hyn yn talu am y broses weinyddol. Hefyd, nid yw'r ffioedd yn statudol ac maen nhw'n amodol ar gynnydd blynnyddol yn unol â pholisi'r Cyngor mewn perthynas â ffioedd a thaliadau.

It was **RESOLVED** to approve the minutes of the 12<sup>th</sup> December 2023 as an accurate reflection of the meeting.

**50 TO CONSIDER THE LICENCES & REGISTRATIONS ISSUED UNDER  
THE PROVISION OF DELEGATED POWERS FOR THE PERIOD:  
27.11.2023 - 14.01.2024**

The Head of Service for Public Protection and Regulatory Services presented Members with details of licences and registrations issued during the period 27<sup>th</sup> November 2023 to 14<sup>th</sup> January 2024.

**51 TO CONSIDER THE EXTENSION OF STREET TRADING PROVISIONS**

The Head of Service for Public Protection and Regulatory Services outlined the report which is to gain in principal Members approval on the adoption of further provisions to facilitate the control of street trading.

Members were advised that in December 2009 the Council implemented street trading provisions in Pontypridd town centre, which was extended in 2011 to the introduction of prohibition zones for the control of street trading within a 500m radius of Porth County Community School and Treorchy Comprehensive School.

Furthermore, that the scheme was initially implemented following complaints of unregistered food traders, poor food hygiene practices, litter, and odour nuisances in Pontypridd. Moreover, that the extension of provisions to areas around schools were introduced following concerns raised by the Police regarding street traders obstructing pavements & causing traffic hazards, and also, that Headteachers raised concerns that the vendors were offering high fat, low nutritional value foods that undermined the Authority's efforts to improve the diets of young people.

It was reported that Section 3 of the Local Government (Miscellaneous Provisions) Act 1982 allows Council to adopt Schedule 4 of the Act, which states that, 'A district Council may by resolution designate any street in their district as a prohibited street, a licence street, or a consent street.

Members learned that in a report to Licensing Committee on June 5<sup>th</sup>, 2007, reference is made to a meeting held on 12<sup>th</sup> March 2007 where a report was discussed that outlined the options, Also, that all options were considered, and it was decided that the most flexible and appropriate permission was that of consent streets.

In addition, in the meeting held on the 12<sup>th</sup> March 2007 it was determined that although there was no right of appeal against a refusal to grant/renew or revoke such consent, it was deemed good practice and Human Rights compliant that a provision be available, and therefore, aggrieved applicants will be afforded an opportunity of representation by means of the Licensing Committee.

Members were advised that it is proposed that the street trading provisions are not limited only to food vendors; it applies to other types of street trading activities, and there is also a list of exempt activities that are not regarded as Street Trading and are listed within the report embedded to the rear of the document. In addition, at the time of writing RCT has 88 registered mobile food traders, this does not necessarily mean that all of the 88 trade within RCT. Likewise, there may be mobile food traders registered with other local authorities but trade in RCT. Furthermore, that the extension of the existing provisions may not apply to all these businesses due to them trading outside of the Borough or the frequency of trading, and also, that there are currently no businesses trading that require a consent to trade.

Furthermore, it is proposed that the existing provision is extended across all RCTCBC and that a review of the existing conditions will look to improve the standard of the existing food businesses. In addition, it is proposed that those businesses with a food hygiene rating of 3, (satisfactory or above), can apply for a consent to trade.

Moreover, that the extension of the existing provisions across the Borough will provide the local authority with a flexible system which will include those traders from outside the Borough and those who trade infrequently. Also, that the extension of the scheme does not affect the Street Furniture Scheme that exists in Aberdare and Pontypridd Town Centres

It was reported that the process of the consents to trade currently sits within the Licensing Team of Public Health and Protection and supported by officers in the Food and Health & Safety Team along with Highways/Street-care. Furthermore, that there is a fee linked to the process of the consent to trade that covers the administration process. Also, that the fees are not statutory and are subject to the annual increase as per the Council policy in relation to fees and charges.

The Head of Service for Public Protection and Regulatory Services reported that the recommendations are made following concerns regarding mobile food vendors trading in the Borough, and that the extension of the existing provisions will provide a level regulatory regime for all mobile traders and will assist local authority officers in compliance to improve overall standards, providing added confidence to the residents of RCTCBC.

Following consideration of the report, the Committee **RESOLVED**:

- (i) To accept the proposals of the draft report to extend existing street trading ‘consent’ provisions in Pontypridd Town Centre afforded by the Local Government (Miscellaneous Provisions) Act 1982, to all areas across RCT, but to retain the prohibited streets in Treorchy and Porth.

- (ii) Approve that notice of the draft resolution be published in accordance with statutory requirements, allowing for consultation with the trade.
- (iii) That the Director Public Health, Protection & Community Services, in consultation with the Director of Highways, Streetcare and Transportation Services, be authorised to prepare and publish the required draft resolution to extend 'consent' street trading provisions afforded by the Local Government (Miscellaneous Provisions) Act 1982, to all areas across RCTCBC.

## PURPOSE OF THE REPORT
