Mae dadansoddiad o'r ceisiadau am Hysbysiadau Achlysuron Dros Dro yn nodi bod 45 wedi'u rhoi i safleoedd sydd â thrwydded eisoes, 54 wedi'u rhoi ar gyfer achlysuron yn y gymuned a 15 wedi'u rhoi i glybiau preifat. Cafodd Aelodau eu hatgoffa bod lefel y ceisiadau am Hysbysiadau Achlysuron Dros Dro yn parhau i fod yn uchel ac mae hyn i'w ddisgwyl adeg yma o'r flwyddyn. Hefyd, wrth i fis Awst ddod i ben, newidiodd y gwyliau bwyd, a ddefnyddiodd y caniatâd dros dro i werthu alcohol, i bartïon Calan Gaeaf, achlysuron tân gwyllt, ffeiriau Nadolig a cheisiadau am ymestyn oriau agor safleoedd â thrwydded. Yn ogystal â hynny, mae canlyniad un adolygiad o ran y cyfnod wedi'i benderfynu gan Heddlu De Cymru ar gyfer No 12 Drinks Emporium, Pontypridd, lle penderfynodd yr Is-bwyllgor atal y drwydded am gyfnod o 6 wythnos o ganlyniad i achosion parhaus o beidio â chydymffurfio, diffyg hyder yn y rheolwyr a thanseilio'r amcan trwyddedu Trosedd ac Anhrefn. Hefyd, roedd Hen Swyddfa'r Post (Squares), Porth, wedi apelio a chynhaliwyd y gwrandawriad ar 9 a 10 Hydref 2023 ac roedd y Barnwr Rhanbarth o'r farn nad oedd y sŵn yn gyfystyr â niwsans cyhoeddus ac roedd o blaid yr apelydd, Gold Bar Two Ltd, sy'n golygu bod modd i'r safle barhau i fasnachu gyda'i amodau trwyddedu gwreiddiol.

Aeth Swyddogion Trwyddedu o Heddlu De Cymru a'r Awdurdod Lleol i'r safle a siaradon nhw â'r Goruchwyliwr Dynodedig Mangre a oedd newydd ddechrau yn y swydd ond roedd wedi gweithio yn y safle ers nifer o flynyddoedd. Roedd yr Awdurdodau'n fodlon bod y dafarn wedi ymddwyn yn briodol a doedd dim problemau trwyddedu i'w nodi.

Cafodd Aelodau wybod bod clwb golff yn ardal Taf-elái wedi derbyn cyngor gan Swyddogion Trwyddedu o ran achlysur tân gwyllt. 16 APOLOGIES FOR ABSENCE

An apology for absence was received from County Borough Councillors S. Bradwick and A O Rogers.

17 DECLARATION OF INTEREST

RESOLVED – In accordance with the Members Code of Conduct, the following declaration of personal interests in a matter pertaining to the agenda was declared: -

County Borough Councillor G. Holmes in respect of agenda item 4, “One of the businesses in the report is well known to me”.

18 HUMAN RIGHTS ACT 1998 AND CRIME AND DISORDER ACT

It was **RESOLVED** to note that when Members determine the licensing and registration matters before them, they have a duty not to act in a manner that is incompatible with the convention on Human Rights and the Crime and Disorder Act.

19 MINUTES

It was **RESOLVED** to approve the minutes of the 5th September 2023 as an accurate reflection of the meeting.

20 REVIEW OF THE LICENSING ACT 2003 & GAMBLING ACT 2005

The Head of Service for Public Protection and Regulatory Services provided the Committee with the report on relevant issues with regard to the Licensing Act 2003 and the Gambling Act 2005 for the 21st August 2023 to 26th November 2023, together with ancillary matters arising from the responsibilities charged to the Committee.

An analysis of the TEN's applications indicates, 45 for existing premises licenses, 54 for permitted community events and 15 from Private Members Clubs. Member were reminded that the TENs applications remain at a high level which can be expected at this time of the year. Also, as we ended August, the food festivals which utilised the temporary permissions for the sale of alcohol gave way to Halloween discos, firework events and currently, Christmas fayres and extension of hours on licensed premises. Furthermore, these seasonal events are in addition to the typical TENs we receive throughout the year for fund raising and sporting activities.

In addition, Members learned that it remains a busy time amongst the team with a rise in transfer, Vary DPS and Minor Variation applications some of which will have been the outcome of infringements picked up by the Officers during licensing inspections.

The Head of Service for Public Protection and Regulatory Services reported that since the last Committee report, there had been one contested application for a Grant of a Premises Licence which had been Refused as it would undermine the licensing objectives in respect of crime & disorder, public nuisance & the protection of children from harm. Furthermore, that one Review has been determined for the period by South Wales Police for No 12 Drinks Emporium, Pontypridd, whereby the Sub-Committee determined for the Licence to be suspended for a period of 6 weeks due to continued non-compliance, lack of confidence in the management and the undermining of the licensing objective Crime & Disorder, and also, an Appeal had been lodged by the Old Post Office (Squares), Porth whereby the Hearing took place on the 9th and 10th October 2023, and it was determined by the District Judge who was of the opinion that the noise did not amount to a public nuisance and accordingly found in favour of the appellant, Gold Bar Two Ltd. which allows the premises to continue to trade with their original licensing conditions.

Members were referred to section 4.3 of the report, where the premises inspections and infringements were outlined. It was reported that the current performance level for inspected premises which is at 90%.

Members were advised that a pub in Mountain Ash recently came to the attention of the team due to the unnecessary behaviour of the owner towards an Environmental Health Officer while trying to conduct her duties. Also, that the male was described as obstructive and abusive and appeared to be drunk, as a result the Officer felt it necessary to leave the premises and return at a later date. Furthermore, Licensing Officers spoke to the DPS of the premises the following day and it was confirmed that she was retiring the following week however, the owner of the premises had been problematic. Both Local Authority and South Wales Police Licensing Officers have visited the premises and offered advice to the new DPS, particularly in line with the serving of alcohol to a person who is drunk.

It was reported that allegations of drug use both inside and outside an off-licence premises in the Penywaun area were received in October which resulted in a visit from Licensing Officers from both South Wales Police and the Local Authority. Also, that no evidence of drug use was witnessed but the DPS was notably absent. In addition, the sale of alcohol was ceased following this visit and a week later a new application was received to Vary the DPS.

Members learned that the Licensing team received allegations of the PLH & DPS of a pub in Treherbert being aggressive to customers whilst intoxicated. Also, that there were also allegations about the general condition and maintenance of the building, which resulted in a visit from both Licensing and Environmental Health Officers in October, where full advice was given. Moreover, a warning letter also followed this visit.

The Head of Service for Public Protection and Regulatory Services advised that a Rugby club in the Rhondda has been in touch for clarification on the legislation around children being on the premises and full guidance was given. Also, that it was particularly pleasing that this premises got in touch due in view of previous non-compliance over the past year or so. Furthermore, that partnership working between the licensing team and licensed premises is so important and it is always positive when this happens.

Members learned that a licensed premises in the Clydach area has been subject to several complaints, including underage sales and noise nuisance from an event held in September. Moreover, that the allegations were also that the management of the premises were rude on the day of the event when a local resident complained directly to them – this resulted in a complaint to the licensing team. In addition, despite joint efforts from licensing officers, Environmental Health Officers and South Wales Police, the DPS of the premises has been unable to meet with officers to discuss this. The premises will continue to be contacted.

It was reported that an Off Licence premises in Glyncoch was found to be trading with no DPS resulting in alcohol sales being ceased by Officers, and also, that the premises had been sold to a new owner, but no transfer

application had been submitted. Moreover, suitable advice was provided, and the premises is now compliant.

Members were advised that an incident in the beer garden of a pub in Church Village is still under investigation, a female threw a glass at another female which resulted in her needing stitches to her face. In addition, that the Licensing Officers from South Wales Police and Local Authority visited the premises and spoke to the DPS who even though had just taken up the position, had worked at the premises for several years, and also, that the Authorities were satisfied the pub had acted appropriately and there were no licensing issues to report.

Members learned that a golf club in the Taff area received advice from licensing officers in respect of a fireworks event, and this was to be the first fireworks event held at this premises and the advice was well received, a recent communication from the golf club was received thanking officers for their help and declaring the event a success.

Furthermore, advice and guidance were requested from a general store in Llantrisant, who wish to apply for a Premises Licence and was given along with a pre application meeting was recommended.

Members were reminded that a pre application meeting was conducted for an existing late night refreshment premises in Pontypridd town centre, officers from the Licensing Authority and South Wales Police attended, and that the licence holder initially asked for advice to stay open until 5am, this was met with concern from the Responsible Authorities, he is considering the advice given.

In terms of the recovery of annual fees, Members were advised that several suspensions have been issued to premises for no-payment, which had the required affect with payments now received and suspensions were then lifted. Furthermore, that there is a large figure for outstanding invoices, this is normal for this time of year as new invoices have been issued and officers will chase these payments during the next reporting period.

The Head of Service for Public Protection and Regulatory Services referred Members to section 5.1 of the report and provided them with an update in terms of the Gambling Act 2005.

Furthermore, Members were provided a summary of existing permissions in relation to Trade profile Gambling.

1. PURPOSE OF THE REPORT

The purpose of the report is to update Members on relevant issues, with regard to

- **the Licensing Act 2003**
- **the Gambling Act 2005**

2. RECOMMENDATION

Members are requested to: -

- (i) note the contents of the report in respect of the **Licensing Act 2003** which has been provided for information.
- (ii) note the contents of the report in respect of the **Gambling Act 2005**, which has been provided for information.

3. BACKGROUND

Members will be aware that a quarterly meeting is convened to review and discuss the implementation and progress of the Licensing Act 2003, together with any ancillary matters arising from responsibilities with which this Committee is charged.

Such ancillary matters include the Gambling Act 2005. (There may also be ancillary matters arising from the impact of the Smoke-Free Premises Regulations, which have the potential to affect all licensed premises).

4. **LICENSING ACT 2003**

4.1 **Application Process**

Applications received since the last update (**27th November 2023 to 25th February 2024**) are as follows:-

Applications have remained high during this period with a steady number of personal licences and a high amount of transfer & Vary DPS applications, which are often the outcome of chasing annual fees for licensed premises and/or picked up during licensing inspections.

The Christmas period was a busy time as expected for the processing of TENs across licensed Clubs and Premises but also in the wider community. The retail sector often applies for extended hours and to trade on Christmas Day, Christmas fayres and sporting activities are abundant in the community while licensed premises apply to extend their hours for alcohol sales or for entertainment. More than one premises utilised the TENs process to hold licensable activities while they awaited their applications for Premises Licences. This is mutually beneficial as it allows the applicants to trade whilst allowing the Police and Environmental Health Departments an insight into how these applicants would run their premises in the future.

An analysis of the TEN's applications indicates, 44 for existing premises licences, 42 for permitted community events and 18 from Private Members Clubs.

A summary of TEN's is reproduced for Members information as **Appendix 1A**.

In accordance with the advice received in respect of data protection matters, the summaries of Personal Licences and Premises Licences issued under delegated authority are now reproduced for information as a Part II restricted item.

4.2 Contested Applications

No contested applications have been determined since the last report.

Reviews

No reviews have been determined during this period.

Appeals

No Appeals have been determined.

4.3 Premises Inspection & Infringements

The relevant Performance indicator for the Licensing Team is "*the premises licences found to be broadly compliant following inspection by Licensing Officers*". Officers will consider confidence in management, compliance with licence conditions and business competency when determining the risk rating of the premises when considering whether they are broadly compliant.

The current performance level for inspected premises which is 89.25%.

4.4 Complaints, Advice, Guidance & Information

Several requests for pre application advice have been actioned over the past few months including:

- An unused building in Pontypridd potentially being utilised for a wine bar with some outdoor seating. The applicant does not propose late hours and is planning some tapas style food.
- The organisers of the Rhondda Arts Festival have been in contact for some advice prior to the festival taking place this summer. This is a well-established event, and this year it is hoped that capacity will be increased to encourage more footfall through Treorchy.
- A licensed premises in the Hirwaun area has reopened under new ownership and they have enquired about an extension to the existing Premises Licence. An application has not been submitted as yet.
- A late-night refreshment business in the Llanharan area came to the Responsible Authorities for advice in applying to add the sale of alcohol as an off sale to their existing Premises Licence. After discussions relating to conditions, this application was submitted and granted.

A large, licensed premises in the Treforest area contacted licensing officers for advice in relation to a few events they have planned utilising outside areas. This premises is not currently trading as they have done historically and are thinking of new ways to utilise the space, they have to stay open. From speaking to them it seems that a change in socialising trends has forced them to change their business format.

A licensed premises in the Treorchy area is subject to ongoing complaints, primarily in relation to noise and anti-social behaviour. The relevant parties are aware of the allegations.

Terry Stephens from South Wales Police came to a number of our Pubwatch meetings across RCT in his position as Counter Terrorism Security Advisor. Terry gave an informative talk about Martyn's Law, a piece of legislation which will impact many of our spaces and premises and the way local authorities deal with events, planning security and running businesses.

Following a request from the police, Licensing Officers attended several premises in Pontypridd Town Centre to assist in relation to thefts from various off licensed premises. It was pleasing to note that all were happy to take advice and guidance from Officers.

A licensed premises in the Mountain Ash area, has submitted an application to change from a pub premises to a convenience store with off sales of alcohol. This premises has not operated for a number of years, and it is positive that this building will be part of the community again.

Following an incident at a funeral at a private members club in the Llanharan area, South Wales Police and Licensing Officers met with the Club Secretary to discuss action taken. The original report regarding non-members gaining access to the club and a fight involving 20 people taking place was not accurate, however full advice was given to the club in question.

A complaint was received via Crimestoppers in relation to a number of offences including underage drinking at a pub in the Llanharan area. A joint visit was conducted, and advice was given. It would appear that the complaint was as a result of a disgruntled customer and no further action was taken.

The Christmas period was not as busy as we have experienced in the past, and as such there are no substantial incidents to report.

The usual Pubwatch meetings have taken place across the Rhondda, Cynon, and Taff areas, and are a positive space for information sharing, advice, and guidance from Officers.

News of the Eisteddfod coming to Pontypridd this year has resulted in many smaller groups making initial enquiries for advice to hold small scale local events over Rhondda Cynon Taff. Queries are being logged and raised with the event Safety Advisory Group where necessary.

4.5 Recovery of Annual Fees

The payment of annual fees remains at an expected level for this time of the year. Licence holders typically delay payment until after Christmas period. Several suspensions issued to premises for non-payment, resulted in the payments being made and the suspensions subsequently lifted.
