# REPORT OF THE SERVICE DIRECTOR, DEMOCRATIC SERVICES & COMMUNICATIONS

#### 1. PURPOSE OF THE REPORT

- 1.1 The purpose of the report is to provide the Overview & Scrutiny Committee with the opportunity to scrutinise and challenge the attached report (Appendix 1) which provides an update on the progress of the Cardiff Capital Region ('CCR') Joint Cabinet (the 'Regional Cabinet' a joint committee), to oversee the Region's economic growth and to deliver the commitments set out in the CCR City Deal.
- 1.2 Committee requested the opportunity to consider this report in advance of Cabinet discussions, when scrutinising the Cabinet Work Programme.

- 3.2 It is anticipated that the Overview & Scrutiny Committee will use this report as the basis for its scrutiny and challenge in advance of it being presented to Cabinet on the 25<sup>th</sup> February 2021.

- 4.1 The Overview & Scrutiny Committee received both the Cabinet and Scrutiny forward work programmes to its meeting on the 18<sup>th</sup> January 2021, with a view to selecting any matters included in the Cabinet forward work programme for pre-scrutiny.
- 4.2 At the meeting Members identified the Cardiff Capital Region City Deal as an area they wished to consider in greater detail and requested that this matter be brought before the Overview & Scrutiny Committee before the end of the municipal year.
- 4.3 In response to its request, the Overview & Scrutiny Committee has been provided with the opportunity to scrutinise and challenge the content of the attached update report which sets out the progress made by the Cardiff Capital Region Joint Cabinet in respect of the agreed commitments established in the CCR City Deal.
- 4.4 The attached progress report will be presented to Cabinet at its meeting on the 25<sup>th</sup> February 2021, in view of the reporting timescales, it is advised that Members' comments and feedback be relayed to Cabinet by the Service Director, Democratic Services and Communications.
- 4.5 As Committee is aware, Rhondda Cynon Taff County Borough Council is currently the host Authority undertaking the Scrutiny arrangements of the Cardiff Capital Region City Deal Joint Overview and Scrutiny Committee (CCRCD JOSC). The authority currently undertakes the administrative arrangements and provides dedicated support and advises members of the JOSC.
