REPORT OF THE SERVICE DIRECTOR, DEMOCRATIC SERVICES AND COMMUNICATIONS

1. PURPOSE OF THE REPORT

1.1 To present to Members the Cwm Taf Joint Overview and Scrutiny Committee (JOSC) 2020-21 Interim Annual report, which details the work undertaken by them during the period between December 2020- April 2021.

4. BACKGROUND

4.1 The Joint Overview and Scrutiny Committee is made up of representatives from Rhondda Cynon Taf County Borough council and Merthyr Tydfil County Borough Council.

4.2 Within the JOSCs Terms of Reference the Committees core statutory functions are set out as follows:

- The JOSC are to review and scrutinise the decisions made or actions taken by the Board;
- To review the Boards Governance arrangements;
- To make reports or recommendations to the Board regarding its functions or governance arrangements;

- To consider matters relating to the Board as the Welsh Ministers may refer to it and report to the Welsh Ministers accordingly; and
- To carry out other functions in relation to the Board that are imposed on it by the Well-Being of Future Generations (Wales) Act 2015.

4.3 In addition to these functions the JOSC's Lines of Inquiry can include (but not be limited to), the following:

- The effectiveness of the Wellbeing Assessment;
- The effectiveness of the Wellbeing Plan;
- The effectiveness of performance measurement arrangements;
- The level of commitment from individual partners to the work of the Public Services Board;
- The effectiveness of the Public Services Board in communicating its work, objectives and outcomes to its stakeholders; and,
- The effectiveness of the Public Services Board in addressing the issue of pooled funding to tackle priorities

4.4 On the 23rd April 2021, Members agreed that an Interim Annual Report would be presented at the first meeting of the JOSC in the 2021-22 Municipal Year. Members of the JOSC acknowledged the pressures faced by both Councils during the pandemic as well as the pressures of response and recovery. With this in mind, the draft Cwm Taf Public Service Board Joint Overview and Scrutiny Committee Interim Annual Report sets out a limited number of scrutiny meetings during the 2020-21 Municipal Year, which allowed both Councils to respond effectively to emerging issues.

Function of the Cwm Taf Public Services Board Joint Overview and Scrutiny Committee

The aim of the JOSOC is to scrutinise the overall effectiveness of the Cwm Taf Public Services Board Joint Overview and Scrutiny Committee.

The core statutory functions of the JOSOC are:

- To review or scrutinise the decisions made or actions taken by Board;
- To review or scrutinise the Board's governance arrangements;
- To make reports or recommendations to the Board regarding its functions or governance arrangements;
- To consider matters relating to the Board as the Welsh Ministers may refer to it and report to the Welsh Ministers accordingly; and
- To carry out other functions in relation to the Board that are imposed on it by the Well-Being of Future Generations (Wales) Act 2015.

In addition to these functions, the JOSOC's Lines of Inquiry can also include:

- The effectiveness of the Wellbeing Assessment;
- The effectiveness of the Wellbeing Plan;
- The effectiveness of performance measurement arrangements;
- The level of commitment from individual partners to the work of the Public Services Board;
- The effectiveness of the Public Services Board in communicating its work, objectives and outcomes to its stakeholders; and,
- The effectiveness of the Public Services Board in addressing the issue of pooled funding to tackle priorities.



Wellbeing Objective: STRONG ECONOMY

To grow a strong local economy with sustainable transport that attracts people to live, work and play in Cwm Taf.



This year the Joint Overview and Scrutiny Committee agreed to scrutinise the development of one strand from the Cwm Taf Wellbeing Plan. The agreed objective for scrutiny was “Strong Economy”. Limiting the focus to only one objective gave Members the opportunity and time to conduct a thorough, detailed and informed review to produce a meaningful outcome at the end of the year.

Members of the JOSOC decided to pursue this strand of the **Cwm Taf Wellbeing Plan** due to its vital importance during the COVID-19 Pandemic. Its key issues in measuring progress of the objective are listed below:



Step 1:

Stimulate and boost the aspirations and skills of our people to meet public and private sector career opportunities;

Step 2:

Growth and promotion of tourism using the assets of our beautiful natural environment, heritage and culture for the health, prosperity and benefit of the whole community and alongside the development of the Valleys Landscape Park;

Step 3:

To make the most of the investment and return opportunities of the £1.229 billion City Deal locally within Cwm Taf;

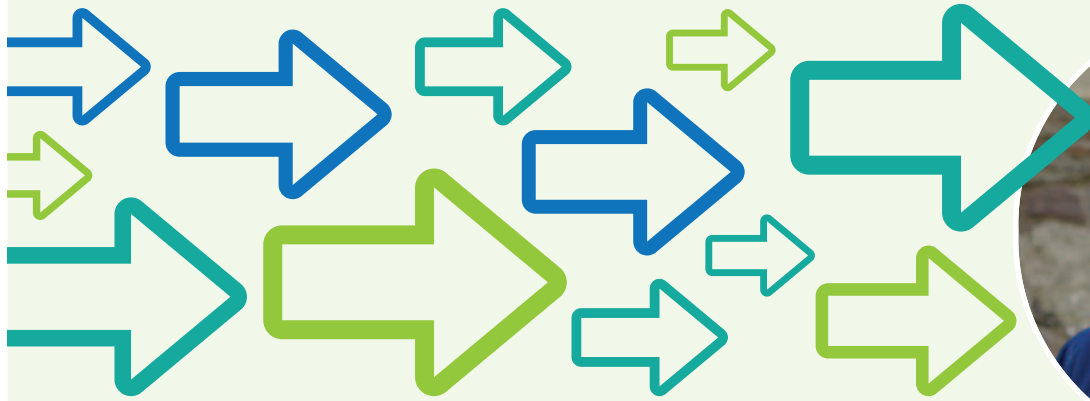
Step 4:

Further explore the opportunities for sustainable housing and renewable energy developments with associated community funds;

Step 5:

Encourage opportunities for development and regeneration as the City Deal delivers jobs and returns on its investments, including attracting hotels.

- Supporting the development of a clean economy.
- A sustainable, energetic and expanding economy with employment rates equalling the UK average.
- A vibrant tourist industry attracting people from near and far, enjoying our natural environment, history and culture.



On the **4th December 2020**, the Committee welcomed the Chair of the Community Impact Assessment Group and the Vice Chair of the Cwm Taf Public Service Board, Mr Mark Brace.

Mr Brace reminded Members of the planned delivery of the Well-being Objectives, ACEs and Live Lab development and broader work against the **Well-being of Future Generations Act**.

Members were advised that this work was obviously greatly impacted by the flooding following Storms Ciara and Dennis, and then the pandemic.

Mr Brace also emphasised that key questions remain relevant going forward:

- How are we making a positive difference in our communities; and,
- Are our mechanisms for delivery right, and are they working

Members scrutinised the information provided and Mr Brace advised Members that 58,000 employees across the partnership have been furloughed and acknowledged that there is a lot of uncertainty about the future. Members were advised that the Community Impact Assessment work shows the potential impact of the pandemic on economic depression and mental health, particularly for young people and disadvantaged learners. The PSB has the opportunity to harness partnership working and to be a real benefit to the community.

However, Mr Brace also acknowledged that the Board cannot do everything and the focus of the Board needs to be on work that can make a real impact in the community.

Members also raised concerns in respect of home working during the pandemic and its effect on the economy. Mr Brace acknowledged the difficulties of working from home and noted that working from home has added a new cohort to the work of the PSB in respect of loneliness and isolation. Mr Brace acknowledged that people who are working from home are often isolated from colleagues, friends and family. Mr Brace emphasised the importance of social interaction and its impact on health and wellbeing.



On the **23rd April 2021**, Members welcomed the Chair of the Cwm Taf Public Service Board, the Head of Procurement Delivery at RCTCBC and the the Service Director Community Services at RCTCBC.

Mr Mark Brace, the Chair of the Public Service Board, provided Members with a progress update in respect of response and recovery as well as the work of the Community Impact Assessment. Members were also advised that discussions are ongoing in respect of the Board's future work programme and joint working strategy. The relationship with the Regional Partnership Board was also emphasised and that the future plan will be to merge to create one central PSB. Members scrutinised the update and noted their concerns in respect of annual reports being retrospective and noted the need to have a report that outlines the Board's future work and its target outcomes. Members also emphasised their admiration for the work of the public service areas during the pandemic.

Members expressed a view that the positive partnership working visible across Cwm Taf Morganwng during the pandemic, came as a result of the respective organisations dedication to public services and not as a result of the work of the Public Service Board. Members commented that the role and purpose of the PSB should be reflected upon in light of the strong joint working taken forward during this period, which paid dividend in the support provided to communities, and the fact that this approach had been taken forward constructively outside of the formal Public Service Board structures.

Members also received an update from the Head of Procurement Delivery at RCTCBC on the expenditure on 'goods works and services' that takes place locally by Rhondda Cynon Taf County Borough Council and Merthyr Tydfil County Borough Council. The Service Director Community Services at RCTCBC also provided Members with a presentation and a short video overview in respect of employment and skills in the county. Members welcomed the scheme to get people back into work and noted the importance of providing feedback to applicants who were not successful in obtaining an employment role. Members also noted the importance of monitoring employment vacancies in both the private and public sector.



Moving Forward

This year has continued to present unique challenges and I am proud of the professionalism, dedication and hard work shown by our public service workers during this period. I am grateful to everyone who has helped contribute to the work and results outlined in this report and to the valuable outcomes that we continue to produce in order to support our local communities.

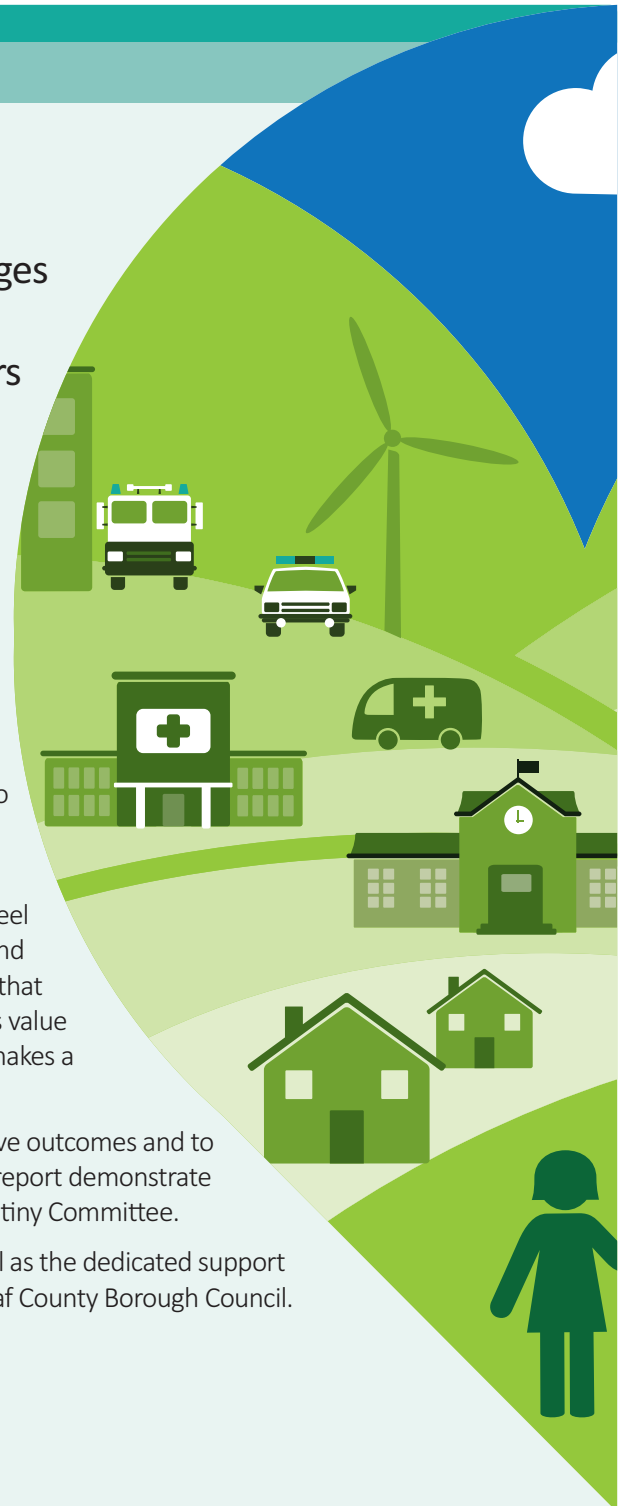

I would once again like to thank my Vice Chair, Councillor T. Skinner, as well as the dedicated support officers from both Merthyr Tydfil County Borough Council and Rhondda Taf County Borough Council. I look forward to the year ahead with pride and confidence.
