12/12/23	Email 5	<p>Member of the Senedd for Cynon Valley</p> <p>The aim of the Welsh Government's Free Breakfast in Primary Schools scheme is to provide children with a healthy breakfast before the start of the school day and I appreciate the wraparound childcare element of this provision is solely funded by local authorities. In light of austerity and the financial pressures local authorities across the UK</p>

		<p>are facing, I will offer my support to the proposed change in provision which will bring in a small fee for childcare. My support is offered on the basis the current policy of free wraparound care is reconsidered should a more generous local government financial settlement become available to the local authority in future.</p>
18/12/23	Email 6	<p>Executive Officer to Hirwaun & Penderyn Community Council</p> <p>Our Cllrs have asked me to respond to the consultation on the continuation of free breakfast club provision.</p> <p>Their opinion is that the provision of a free breakfast club is a proven benefit to children to increase their learning and should continue to be free.</p>
19/12/23	Email 7	<p>Clybiau Plant Cymru</p> <p>Do you agree with the proposal to introduce a charge for the additional childcare element of breakfast club?</p> <p>No, we feel that this scheme should be called an 'extended breakfast club' not a 'childcare element' of breakfast club. Using the term childcare will adversely affect parental perceptions of childcare and its cost. Care Inspectorate Wales (CIW) registered childcare provisions have a 1:8 adult: child ratio, qualifications in Playwork, are trained in Safeguarding, First Aid and other CPD and meet a whole range of National Minimum Standards. With these requirements in mind, current CIW registered provisions could not possibly offer services at a £1 or any reduced cost. The unintended consequences of using this terminology would be to undermine the parental perceptions of the cost of high quality, CIW registered childcare run by Childcare/Playwork qualified staff, meeting a whole range of standards against which they are inspected.</p> <p>How would the proposal impact upon you and / or your family?</p> <p>We think that if this is termed childcare for £1, then there are challenges with parental perception of the cost of CIW regulated childcare, which will impact the Childcare and Playwork sector in RCT. Without regulated childcare in the county, parents would not be able to work, train, progress careers and improve their families circumstances long term.</p> <p>Other comments</p> <ul style="list-style-type: none"> • Could Free Breakfast Initiative (FBI) funding or other initiatives to support disadvantaged children (e.g. SHEP funding) be invested in existing CIW registered Out of School Childcare provision (we believe there to be 13 CIW registered Before School Childcare Clubs in RCT),

		<p>that provide quality play and care for children, improving their outcomes and sustain a quality childcare sector in RCT. There are 5 school based Before School Childcare Club provisions currently registered with CIW and 8 non-school based Out of School Childcare Breakfast Club provisions registered with CIW in RCT.</p> <ul style="list-style-type: none"> • We have successfully tendered for funding for Playwork qualifications through the Welsh Government Training and Support Programme and would be delighted to be able deliver Playwork training to catering staff to enhance their skills and ensure quality childcare for children. • If individual schools are managing these breakfast clubs (FBIs) and 'childcare element' and also manage Afterschool Childcare Clubs, with combined hours exceeding 2 hours in any one day at the same location, they will need to register with CIW by law as they are exceeding the National Minimum Standards for providing Childcare unregistered with CIW. • Within RCT there are 26 Out of School Childcare Settings that have an After School Club but do not have a registered Out of School Childcare Breakfast club. Of these 26 settings, 20 of these are based within a school building, therefore there is potential for clubs to be developed and incorporate the FBI within a play provision.
15/12/23	Email 8	<p>I am saddened, disappointed and concerned to learn that the provision of a free breakfast for all Primary School children is now under threat of becoming a pay for access service. Not only at a time of economic hardship for family's, but also in an area with districts that rank highest for poverty in a recent survey (Wales on Line Article 2nd June 2019 "The Welsh Village Where Half The Kids Grow Up In Poverty")</p> <p>To take us back to the origins and goals of Primary Schools providing free breakfast for all. The free breakfast club initiative is aimed at providing primary school pupils with the opportunity of receiving a free, healthy breakfast at school each day.</p> <p>Free breakfast in primary schools is an integral part of our wider work to improve food and nutrition in schools and ensure all children are treated equally. That will not be the case if the poorest family's are no longer able to access this provision and life line</p> <p>Benefits of a pupil having a good breakfast in the morning:</p> <ul style="list-style-type: none"> • Increases pupil's concentration and behaviour in school • Offers supervised play and social time in the morning • Prepares pupils for the day ahead • Improves punctuality and attendance • Useful for parents who need to start work early.

		<p>In a recent survey it found that Children who usually skip breakfast achieve significantly lower GCSE grades than those who normally eat it, research shows. The UK study found that missing the first meal of the day was associated with academic performance around two grades lower than it would otherwise have been, when all exams were added together.</p> <p>The Telegraph 20 Nov 2019</p> <p>As no schools in Rhondda Cynon Taff currently rank in the top 10 for performance, (Top performing schools in Wales revealed in new survey</p> <p>03 Dec 2021) I find it concerning that some of the protest and most deprived children not only in RCT but in wales are at risk of being further deprived.</p> <p>Now to a personal note</p> <p>I Have Helped facilitate Breakfast Clubs in a variety of schools in RCT for the past 10 years. I have personally seen both the benefit and the necessity that a free breakfast provides. When a Child is hungry their behaviour, and concentration are significantly affected. It is heart-breaking to see some children eat a larger and more substantial breakfast than a fully grown man. Not out of gluttony but out of pure hunger.</p> <p>On a number of occasions through out the last decade both myself and i should imagine most of the breakfast club facilitators have had to report to that schools safe guarding officer over the concerning amount some children eat out of hunger.</p> <p>As recent as yesterday a report has come to light that Older primary school children are going hungry, because the school meals are too Small (Wales online 13th December 2023) and i feel with the introduction of a pay for breakfast club for our poorest and most vulnerable in society. This is only going to get worse.</p>
06/01/24	Email 9	<p>I oppose to you charging for breakfast club and I oppose to you saying its childcare. We are a breakfast club for the children to eat their breakfast so that they can concentrate in class. It does help working parents and we understand that however they must understand that we are to feed the children as well. I am not a childcare person, if I was I would have gone to college and be on a lot more money than what we are getting paid.</p> <p>Where do you get your times from I do not know. 3 of us are in at about 7.50am. I think you think that the kitchen getting wiped down and all the breakfast items are ready to serve. Tables being set up wiped down set up with board games, lego etc all done by 8am you're</p>

		<p>all off your trollies. We've give 30 minutes a day up to get things ready by 8.10 for the gates to be opened at 8.10. The gates shut at 8.30 for us to get the kitchen ready for 9 o clock for the cook to go into their job.</p> <p>You haven't even spoken to the catering department about these times. If you had they would have told you that these times are not possible. Start working with your employees instead of ***** them off.</p>
