Background to survey

Key points

- \succ The survey is usually taken every 2 years, but due to the pandemic, there has been 4 years since the last survey in 2018; the pandemic altered the mindsets and values of many people, including young people, thus these results are more important than ever in ensuring the Council is responsive to current needs

YOUR VOICE SURVEY 2022-2023 Almost 5,000 young people, aged 11–25 completed the survey in schools, colleges, youth clubs and other community settings across the county borough, representing the diversity of young people living, being educated or working in RCT. Young people were given the opportunity to complete a series of interactive questions on a range of thematic areas, which were decided following consultation with other Council services:









- □ From November 2023, YEPS' Transitional Support Workers (TSWs) will be piloting an earlier intervention programme for pre-16 learners (Year 10) who have been identified as at risk of becoming NEET
- The TSWs will be improving the promotion of available support for Year 11+ learners, including signposting to relevant partners
- □ YEPS' 16+ team are leading on a mapping exercise of all EET support and eligibility criteria available across RCT; this is being shared with the Youth Support Services sub-groups, which consists of both internal and external partners








HOW YOUNG PEOPLE FEEL ABOUT LIFE

- Liaise with partners to deliver and share suitable IAG for young people (sexual) health, Barod, Head Above the Waves)



AWARENESS OF RCT'S COUNTY YOUTH FORUM FOR PEOPLE AGED 11-25










YEPO's to deliver sessions for 16+ at school and youth clubs promoting the importance of voting, the process of voting and how to find out more about candidates using critical thinking skills





- \succ Each working group to convene on a quarterly basis; meetings will be chaired by the Youth Services Manager; all partners will be responsible for updating progress on the relevant actions via a shared action log
- \succ Feedback to young people via youth forums, school council's, County Youth Forum and social media platforms
